Now, thereof, if the said _____ shall pay any and all legal damages which may lawfully be claimed against it or on account of any damages to person or persons caused by, or arising from or growing out of, the wrongful, fraudulent, or illegal conduct of the said itinerant vendor, while conducting the sale or exhibit in the city of Houston, and shall comply with all ordinances of said City and the general laws of the State of Texas now in effect, or hereafter to become effective, insofar as the same may be applicable to it, and this bond shall remain in full force and effect for the entire duration of the license-permit as stated herein, and two (2) years thereafter, then this obligation shall be null and void, otherwise, it shall remain in full force and effect.

This bond, while make payable to the Mayor of the City of Houston and his successors in office, shall be considered to be for the use and benefit of any person or persons entitled thereto by reason of any damages sustained through the conduct of said business as hereinabove set forth, and may be sued upon by such person or persons, their legal representative directly, without joining in the City of Houston.

INSTRUCTIONS FOR ITINERANT VENDOR'S LICENSE

1. MUST BRING AN ORIGINAL SURETY BOND TO 611 WALKER 2ND FLOOR, BOND IN THE SUM OF \$2,000.00 (TWO-THOUSAND-DOLLARS) WITH THE MINIMUM TERM OF TWO YEARS AND FORTY DAYS
2. PERMIT FEE: FIFTY DOLLARS (\$50.00) **CASH ONLY**, PERMIT IS VALID FOR FORTY DAYS (40)
3. BRING A PHOTO ID OR DRIVER'S LICENSE CARD OR AN ID ISSUED BY A GOVERNMENT AGENCY

NOTE: IN GENERAL, THE FEE FOR THIS BOND IS NOT \$2,000.00 (TWO-THOUSAND-DOLLARS); HOWEVER, THE INSURANCE OR BOND AGENCY MAY CHARGE YOU UP TO 10% OF THE TWO THOUSAND DOLLAR VALUE OF THE BOND, (OR LESS THAN \$200.00).
