



## City of Houston Pet Registration Application

Registering your pet is the law. The City of Houston Municipal Code requires that anyone who owns, keeps, possesses, or has control of a dog or cat four months of age or older must have their pet registered, vaccinated against rabies every year, and a registered microchip. A City of Houston pet registration identifies and protects your pet in case it becomes lost. Even indoor pets can get out and become lost. You are required to renew your registration annually and update when you move and/or your pet is given away, lost, stolen, or is deceased.

To register your pet, please mail a completed application and check or money order to "City of Houston BARC" at 3200 Carr St, Houston, TX 77026 (please do not send cash). Remember to include a copy of your pet's rabies certificate, proof of registered microchip number, proof of spay/neuter, proof of age (if applying for altered senior registration). The City of Houston has gone tag-less due to mandatory microchipping; therefore, you will not receive a tag.
