City Council Chamber, City Hall, Tuesday, March 31, 2015

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, March 31, 2015 with Mayor Annise Parker presiding with Council Members Brenda Stardig, Jerry Davis, Ellen R. Cohen, Dwight Boykins, Dave Martin, Richard Nguyen, Oliver Pennington, Edward Gonzalez, Robert Gallegos, Mike Laster, Larry V. Green, Stephen C. Costello, David W. Robinson, Michael Kubosh, and C. O. "Brad" Bradford, Jack Christie D. C., Harlan Heilman, Division Chief, Claims & Subrogation Division; and Marta Crinejo, Agenda Director and Stella Ortega, Agenda Office, present.

At 1:50 p.m. Mayor Parker called the meeting to order and stated they would start with the presentation portion of the City Council meeting and recognized Council Member Stardig for a presentation. Council Members Davis, Cohen, Boykins, Martin, Pennington, Laster, Green and Robinson absent.

Council Member Stardig stated this time of the year, with regards to public safety and pools, which a lot of children out there that are exposed to pools and were not given pool safety instruction she wanted to recognize a number of people representing the Houston Apartment Association that are involved in communities outreach to make sure that in apartments and across the City that there was pool safety available for children because of drowning-related deaths in Houston and Harris County continues to be a concern every year, highlighting the necessity of water safety education and residents in communities were encouraged to take responsibility and precautions to prevent drowning accidents by advocating for safe water practices, implementing preventative measures and choosing to use Coast Guard approved personal floatation devices and therefore Mayor Parker proclaimed April as April's Pool Water Safety Awareness Month in Houston Texas. Council Members Davis, Boykins, Martin, Pennington, Laster and Green absent.

At 2:00 p.m. Mayor Parker recognized Council Member Nguyen for the invocation and the pledge of allegiance. Council Members Davis, Boykins and Martin absent.

At 2:02 p.m. the City Secretary called the roll. Council Members Boykins and Martin absent.

Council Member Gonzalez and Bradford moved that the minutes of the previous meeting be adopted, all voting aye, nays none. Council Members Boykins and Martin absent.

Mayor Parker stated due to a lot of speakers in the Chamber today, there was a long standing rule of Council that if the number of speakers who have signed up exceeds 150 minutes, that the speakers and the Member of Council are given one minute each to get through as many speakers in a timely manner.

The City Secretary began calling the list of speakers.

Ms. Carrie Pepi, 3668 Del Monte, 77019, (832)567-6527 appeared and stated she was present in favor of the Memorial Park Master Plan and was currently involved as a volunteer in a Native Plant Restoration Project in the park which improves the habitat for the wildlife and plants. Council Members Boykins, Martin, Gallegos and Green absent.

- Mr. Alan Atkinson, 6 Pinehill Ln, 77019, (832)428-1141 appeared and stated he was in favor of the Memorial Park Master Plan and stated that more people are going to move here because of the parks. Council Members Stardig, Boykins, Martin, Gallegos, Laster and Green absent.
- Ms. Helen Drummond, 440 Wilchester Blvd, 77079, (713)932-1639 appeared and stated she was an Executive Director for the Houston Arboretum, a 40 years resident Houstonian that visits Memorial Park and the Ecological Restoration element of the Master Plan were important to Houston and was present in favor of the Memorial Park Master Plan. Council Members Stardig, Boykins, Martin, Gallegos, Laster and Green absent.
- Ms. Kaye Tynan, 315 Glenwood Dr., 77007, (713)515-4077 appeared and stated she likes the idea of the Memorial Park Master Plan but had concerns about the traffic on the eastern side because of the school, residential area and believes a traffic study should be implemented into the plan. - Dr. Betty Edwards, 17070 Red Oak Dr. No. 400, 77090, (281)384-6064 appeared and stated was President-Elect Daughters of the Republic of Texas and represting Ellen McCalf and was present in favot of the Memorial Park Master Plan. - Ms. Claire Caudill, 518 Westminster Dr, 77024, (713)932-8933 appeared and stated that she serves on the Board of Directors of the Memorial Park Conservancy and was initially skeptical of the plan until she realized how badly the park was damaged and that just letting

Ms. Emily Manderson, 4501 Woodway Dr, 77024, (713)681-8433 appeared and stated she was Conservation Director with the Houston Arboretum and Nature Center and been encouraged to see the ecological thought that's been part of the Master Plan and would enhance and support the work at the Houston Arboretum and Nature Center and the Master Plan efforts. Council Members Stardig, Davis, Boykins, Martin, Gallegos, Laster, Green and Costello absent.

Mr. James Von Suskil, 6014 Blossom St, 77007, (713)807-7645 appeared and stated he followed the plan for the park with optimism but concern was for the public safety and neighborhoods; specifically there are no sidewalks during the first two of the first blocks and the streets tend to get narrow and suggested to use the existing east Memorial Loop drive for the baseline of the parking which was currently proposed along Crestwood. Council Members Stardig, Davis, Boykins, Martin, Gallegos, Laster, Green and Costello absent.

Mr. Robert Hoekman, 19 Crestwood Dr. No.9, 77007, (713)863-9525 appeared and stated he was a regular user of Memorial Park and strongly supported the Memorial Park Master Plan especially increasing the walk ways and more runner user safety. Council Members Stardig, Davis, Boykins, Martin, Pennington, Laster and Green absent.

Ms. Nisha Desai, 1201 Fannin, 77002, (713)906-4105 appeared and stated was present in support of the Memorial Park Master Plan and to express her personal experiences with the Memorial Park. Council Members Stardig, Davis, Boykins, Martin, Pennington, Laster and Green absent.

Mr. Jim Dougherty, 6515 Durford Dr, 77007, (713)864-9649 appeared and stated was on the Memorial Park Conservancy Board and already spoke to some of Council at the Quality of Life Committee and was in support of the Master Plan and only the only thing negative he had heard was the parking. Council Members Stardig, Davis, Boykins, Martin, Pennington, Laster and Green absent.

Mayor Parker stated wanted to admonish the audience that they have a very strong policy here that no one disrupts the speakers and would be asked to leave.

Mr. Dexter Handy, 5213 Feagan St. No. C, 77007, (832)724-8753 appeared and presented information and picture to Members of Council and stated he was a big user of Memorial Park and in support of the Master Plan but had recommendations for the plan which included more bike slots, increased parking spots, sidewalks, bike lanes into and out of the park, more bus stops, healthy vending machine and more restrooms. Council Members Stardig, Davis, Boykins, Martin, Pennington, Laster and Green absent.

Ms. Ardon Armstrong, 274 Pine Hollow Ln, 77056, (713)553-9471 appeared and stated that the City Council had been more than fair with hearings schedules throughout the city for the Master Plan of Memorial Park and hired the most innovative earth sensitive landscape designer and this was a plan to save it, restore it and respect what Houston has. Council Member Robinson move that the rules be suspended for the purpose of moving the following speakers out of order Matthew Berstein, Alex Mohan, Kevin Wambold, Alexander Rodriguez and to add Stray Hunt to the speakers list and seconded by Council Member Green, all voting aye, nays none. Mr. Steve Jenkins, 3107 Del Monte, (713)252-4194 appeared and stated he was a lifetime user of Memorial Park and the drought of 2011 left the park devastated and joined the Memorial Park Conservancy Board and was part of the committee that chose the architect for the Master Plan and he believes the plan was well researched and thoughtfully designed. Council Members Stardig, Davis, Boykins, Martin and Pennington absent.

Ms. Shelley Kennedy, 706 Sue Barnett Dr, 77018, (713)822-7688 appeared and stated she wanted to thank the Members of Council for voting last week for keeping her has a commissioner and was present to speak about the Master Plan for Memorial Park and that she had been part of the planning from the beginning and was excited that cyclist would have a place to train. Council Members Stardig, Davis, Boykins, Martin and Pennington absent.

Ms. Jan Cobler, 12953 Trail Hollow Dr, 77079, (713)468-1626 appeared and stated Members of Council know that they believe that a part of their quality of life was in preserving historical environment; well there was a remarkable pure and beautiful strip of forest along Buffalo Bayou between Shepherd and the Archery Range and it's a part of Memorial Park and there was in place the aforementioned proposed plan to destroy the trees along this stretch as they are doing their job has a filter. Council Members Stardig, Davis, Cohen, Boykins, Martin and Pennington absent.

Mayor Parker stated that since Ms. Cobler have her remarks in writing that the remarks will be passed along to Members of Council.

Mr. Adam Newar, 1980 Post Oak Blvd. No2280, 77056, (713)807-1760 appeared and stated he was a Board Member of Memorial Park Conservancy and a user of the park and was present in support of the Memorial Park Master Plan and that Memorial Park was the Park for all of Houston just as Central Park was a park for New York City. . Mr. Joseph Carey, 6628 Rodrigo, 77007, no phone number given appeared and stated he was the President of the Houston Area Road Runner Association; they are an all-volunteer nonprofit that supports running thoughout the region and Memorial Park was the most widely used for runners and the Master Plan proposes a safer and more extensive network of pedestrian pathways and the Road Runners Association supports the plan. Council Members Stardig, Davis, Boykins, Martin and Pennington absent.

Mr. Chuck Carleberg, 2407 Pelham Dr, 77019, (713)824-0742 appeared and stated was a Memorial Park Conservancy Board Member and completely in support of the Master Plan. Council Members Stardig, Davis, Boykins, Martin and Pennington absent.

Mayor Parker stated that she had a map of a study where they just looked at the license plate and used a license plate reader and there was not a neighborhood in Houston where people don't use Memorial Park.

Mr. Brandt Mannchen, 5431 Carew, 77096, (713)664-5962 appeared and stated was present to request that the City Council delay the Master Plan for two weeks because there are issues that need to be resolved; the first was the total cost estimate and he believes of a need for a public involvement process afterwards because all the detail have not been worked out and published for the public to view. Council Members Stardig, Davis and Pennington absent.

Ms. Marilyn Van Way, 9947 Camp Forest Dr, 77080, (713)462-5262 appeared and stated was present to speak why she was on the advisory Board of the Memorial Park Conservancy and that's because she representing the Daughters of the Republic of Texas and was in favor of the Master Plan. Council Members Stardig, Davis and Pennington absent.

Ms. Shellye Arnold, 859 Azalea, 77018, (713)299-0237 appeared and stated she was Executive Director of the Memorial Park Conservancy and wanted to thanked the Members of Council for the support of this historical project for Houston. Council Members Stardig, Davis, Boykins, and Green absent.

Cowan, 77007, (713)398-3314 appeared and stated he was present to request Council not to vote for the Memorial Park Master Plan because he feels that his neighborhood was never included in the input of the Master Plan. Cowan, 77007, (713)398-2334 appeared and stated she was a resident of Crestwood and requested that Council delay this item until someone can address and discuss with them the impact of traffic. Ms. Brenda Nemzin, 6035 Blossom St, 77007, (713)906-0123 appeared and stated she had written remarks but will forgo those remarks because she wanted to address some of the issues that have been brought up through this meeting and she believes that this plan was not right and needs a better study and she has concerns especially for safety and traffic issues. Council Members Stardig, Davis, Boykins, Martin, Gonzalez, Laster and Green absent.

Ms.Cara Barer, 5535 Memorial Dr. No.F650, 77007, (713)825-7455 appeared and stated she lives in the Crestwood area and first she was not opposed of the Master Plan to Memorial Park but concerns of the location of parking lots; there would be more traffic, noises and security issues that would be added next to her neighborhood. Council Members Stardig, Davis, Martin, Gonzalez, Laster and Green absent.

Ms. Carol Limperos, 6317 Pickens St, 77007, (713)426-0988 appeared and stated was a Camp Logan resident and wanted to thank the people who develop the plan but would bring the possibility of Council postponing the vote because a better traffic study needs to be done and include the schools that are in the area. Council Members Stardig, Davis, Martin, Gonzalez and Laster absent.

Council Member Cohen moved that the rules be suspended for the purpose of hearing from Sarah Newbery to answer question relating to Item 1 on the Agenda and seconded by Council Member Gonzalez; Council Members Bradford and Christie voting no, balance voting aye. Council Members Stardigm Davis, Boykins, Martin and Pennington absent. **MOTION 2015-0211 ADOPTED**

Mr. George Figueroa, 10327 Piping Rock, 77042, (713)974-3090 appeared and stated he was present to voice his opinion on the Memorial Parker Master Plan to move the baseball fields. Council Members Stardig, Davis, Boykins, Martin and Pennington absent.

Council Member Gonzalez stated that they presented their statement in full in writing to Members of Council and their concerns center around the ball field and the movement of the fields and brought it to Ms. Arnold's attention before the meeting to try to get some feedback on Mr. Figueroa concerns. Council Members Stardig, Davis, Boykins, Martin and Pennington absent.

Ms. Sarah Newbery was invited to the podium and was question lengthy by Council about Memorial Park Master Plan and the traffic study. Council Members Stardig, Davis, Boykins, Martin and Gonzalez absent.

Mr. Rob Goyen, 6018 Gracy's Landing Ln, Katy, 77494, (832)472-4453 appeared and stated was President of the Houston Area Trail Runners and was in support of the Memorial Park Master Plan as a suitable way to allow trail runners to run the trail safely. Council Members Stardig, Davis, Boykins, Martin, Laster, Costello, Kubosh and Christie absent.

Council Member Laster stated since there was a quorum in the chamber he would like to bring back Ms. Sarah Newbery back to the podium.

Mayor Parker stated since the Mr. Vandusen was already called; that Council Member Laster could make a motion after he speaks.

Mr. Mike Vandusen, 6022 Rose, 77007, (713)864-0221 appeared and stated he lives on Crestwood and President of the Crestwood Civic Club; the plan was begun without benefit of a traffic impact analysis study and they have been told there have been changes made in the traffic study but haven't been shown that study. Council Members Council Members Stardig, Davis, Boykins, Martin and Christie absent.

Mayor Parker stated that Council Member Laster wanted to do a procedural motion which was legal but the administration's strongly prefers that he do the motion in tomorrow's meeting. Council Members Council Members Stardig, Davis, Boykins, Martin and Christie absent.

Council Member Laster stated that he thought there were other Council Members in the cue to ask question but if the other Council Member wish to delay their question until tomorrow he would not make the motion. Council Members Council Members Stardig, Davis, Boykins, Martin and Christie absent.

Mr. Jaime Gonzalez, 3015 Richmond Ave, 77098, (281)660-6683 appeared and stated was speaking on behalf of the Prairie Conservation and was a biologist and educator which he had opportunity to serve on the scientific panel that was critical to this Master Plan and was in

support of the Memorial Park Master Plan. Council Members Stardig, Davis, Boykins, Martin, Pennington, Gonzalez and Christie absent.

- Ms. Ofelia Mayo, 6022 Rose St, 77007, (713)864-0221 appeared and stated she lives in the Crestwood and Glencove neighborhoods and believes that the design team has done a thoughtful job on the Master Plan however the design team has not done an admirable job of being mindful of the traffic and safety issues related to the changes and the impact on citizen of the neighborhoods. Council Members Stardig, Boykins, Martin and Pennington absent.
- Mr. Richard Ruggiero, 6634 Wanita Place, 77007, (281)989-9037 appeared and stated was a resident of Camp Logan and was in favor of the Memorial Park Master Plan; there are going to be traffic issues and yes their streets are narrow but he was disgusted by his neighborhoods comments about their distain about people walking, jogging or cycling through their neighborhood to get to Memorial Park. Council Member Stardig, Davis, Boykins, Martin and Pennington absent.
