City Council Chamber, City Hall, Wednesday, June 1, 2016

At 8:32 a.m. Ms. Anna Russell, City Secretary, read the description or captions of the items on the Agenda.

The Houston City Council convened at 9:00 a.m., Wednesday, June 1, 2016, Mayor Sylvester Turner presiding, with Council Members Brenda Stardig, Jerry Davis, Ellen Cohen, Dwight Boykins, Dave Martin, Steve Le, Greg Travis, Karla Cisneros, Mike Laster, Robert Gallegos, Larry Green, Mike Knox, Michael Kubosh, Amanda Edwards and Jack Christie D.C.; Mr. Ronald C. Lewis, City Attorney and Ms. Marta Crinejo, Agenda Director and Stella Ortega Agenda Office present. Council Member David Robinson absent on personal business.

At 9:13 a.m. Mayor Turner called the meeting order. Council Members Martin and Cisneros absent.

Mayor Turner recognized Council Member Green for the invocation and the pledge of alliance. Council Members Martin and Cisneros absent.

At 9:14 a.m. the roll was called. Council Member Robinson absent on personal business.

Council Member Kubosh moved to delay the previous minutes for one week and seconded by Council Member Knox, all voting aye, nays none. **MOTION ADOPTED** 

At 9:15 Mayor Turner stated he would move to the Mayor's Report.

#### **MAYOR'S REPORT**

Mayor Turner stated due to the recent flooding along the San Jacinto River and the condition on Lake Houston maybe Hazardous for boating as the result, it was recommended that boaters, jet skiers, water skiers and tubers use extreme caution if they decided to enter into the lake with the higher water level coming up and in addition property owners were also concerned the wakes from the boaters would create additional erosion along their properties, with school getting out he was concerned about the safety of the kids that would be getting out on the lake, the lake was dropping but until it turns into normal level they want to make sure that they were doing all they can for public safety, the City was continuing to monitor the situation on the lake and should public safety worsen they may recommend that there would be no additional boating and he also wanted to say that they were expecting additional rain and the areas around the City of Houston was impacted and communities in the Kingwood area and his heart goes out to Council Member Martins District that continues to be affect every time there was a rain fall and he thinks they have to be commented to come up with something that would limit the risk, it seems that Montgomery, Fort Bend County, Waller County had been extremely impacted and he wanted to reach out to all the Mayors in the area and all the elected Officials in the area to offer any help that he can.

Mayor Turner further stated that donations to the Greater Houston Storm Relief Fund were now approaching \$1.8 million dollars and he wanted to thank everyone that had contributed to the fund, Non-profit Organizations, Public Agencies and Governmental Bodies were providing direct support for the immediate and short term need for the flood victims that would be eligible for the fund, Grant request would be considered in the following counties, Brazoria, Chambers, Fort Bend, Galveston, Harris and Montgomery, there had been out pouring support for neighbors that were hurt in the after math of the flooding, he wanted to thank individual corporations that had made donations, Houstonians never hesitate to step up and help; the largest donation that came in was \$500,000.00 from the Houston Rockets, another half million dollars came from Aramco services, Gringos and the

McNair Foundation which gave \$100,000.00 and the rest of the money came from smaller contribution and again he want to thank everyone that contributed; the United Way and Catholic Charities were working to identify the needs and other Non-Profits were eligible to apply for the Grants and the most critical needs seems to be for furniture because a high majority of the flooded victims lost every piece of furniture and bedding that they had and Grants must be approved by the Chairman from the Greater Houston Storm Relief Fund, Advisory Board, the City's Chief Development Officer and the Greater Houston Community Foundation and lastly once the Grant had been approve the funds would be distributed to the Grantee no later than one week after approval of the Grant and no Grants would be awarded for any needs that had already been met and any funds that remain at the end of the April 18th flooding or it aftermaths would be available to any future response that was necessary; he wanted to thank Channel 13 for the two hours air time to do the concert, wanted to thank Clay Walker for taking the lead on his effects and wanted to thank Lake Wood Church for their support and lastly there was any Item on the Agenda that was dealing with the fire hydrants that ask them to appropriate some additional dollars to the contractors to deal with repairing fire hydrants which they would be doing about 700 fire hydrants repair a year and again he thanks everyone in regards to the budget.

At 9:37 a.m. Mayor Turner requested the City Secretary to call the List of Speakers.

Mr. Paul Blackwelder, 4135 L St., 77072, (713)876-4191 appeared and stated that hopefully everyone would understand what he was getting at because this was becoming a very serious problem and he requested this Council to take step a forward to do something about it and he believes they can; the thing that he was speaking of was talking on the cell phone, the technology exist to shut off phones but have 911 service available, it was selective in turning off by the companies that own the phones or one that people subscribe to, it can be done and this would eliminate the problems they had couple weeks ago people that ran into the truck head on because they were playing with a cell phone and he was requesting that the Council would do something like passing a law that was a step forward in doing this, do not wait for everyone else to make a decision for them because they have the power right now to do the thing that was necessary to make this stop, people were dying because of this inadequacy to initiate a law that says cell phone companies have to turn off or place it on a standby situation, they could be notified if they have a call but they would have to do something to answer that call and hopefully Member of Council can do something about this and he would be available to anyone that would like to discuss this; the other thing that he would like to bring up, they have a massive amount of people staying on corners harassing drivers and pushing signs in their faces and he went to Austin a couple weeks ago and he did not see any of that anywhere there, were they going to get on the same plain as Austin and clean this place up, to stop these people from standing on corners, it was becoming a very serious problem and it was luck that no one's had been run over and killed and he would like Council to do something about that, have the police remove them to the County line and to do anything it takes to get them off the streets. Council Members Davis, Boykins and Martin absent.

Members of Council questioned Mr. Blackwelder.

Mr. Benjamin Calhoun, 8510 North Main, 77022, (713)694-6899 had reserved time to speak but was not present when his name was called. Council Members Davis, Boykins and Martin absent.

Mr. Willis Wiley, 3502 Blodgett St. Apt. No. 5405, 77004, (832)756-1800 had reserved time to speak but was not present when his name was called. Council Members Davis, Boykins and Martin absent.

Mr. Jerry Gamez, 2502 Fannin, 77002, no phone, appeared and stated that he had a problem that had been going on years and he had a book on the Constitutional Rights that stated "I will support and defend the Constitution of all enemies, foreign or domestic, so help me God", that means their Civil Rights, he had been here for about 10 years and he does not know who they were but they been tapping into his TVs and most of the people he knows that does this was the Police Officers that were undercover Cops, they were doing it at his mother's house, he had been homeless for four to five years, they finally got him an apartment and they were doing the same things all over again, he had gone to the District Attorney, to Attorney Steve Leroy Junior and he told him to go to Internal Affairs and Internal Affairs told him that he was crazy, he was not crazy, he was very upset, they were defaming his character, slandering his name, he was dying of Cancer and he was 62 years old, what was he supposed to do about this, who does this; he had gone to the Law Library and he found various laws and he does not know what to do about it and he wanted Members of Council to assist him, he was not crazy, he has people stalking him. Mayor Turner, Council Members Davis, Boykins, Martin, Gallegos and Knox absent. Mayor Pro Tem Cohen presiding.

Mayor Pro Tem Cohen advised him to speak with Sergeant Anthony that was in the back.

Mr. Steve Barnaba, 9350 Country Creek, Apt.No.24, 77036, (832)718-9596 appeared and stated he was present because of Police harassment, he wanted Members of Council to be the judge of it, the issue he was having was a traffic violation around February 10<sup>th</sup> by HPD who was standing outside of his car when he pulled up by a stop sign, he did not commit any crime and he asked him for his license and insurance which he told the Officer that he does not have it because he had no reason to do this that was why he said it, so the Officer told him to step out of the car and he showed him, his Military ID, he took it to his car, he ran his license plate and he came back and asked him if he could search his car and he told the Officer that he had nothing to hide which he proceeded to search his car anyways, there were four other Police Officers there and he found 50.00 dollars' worth of marijuana and told him that he was going to jail, he just looked at the Officer and the Officer asked why does this smell funny and he told him would he really like to know, all of them gather around and he said because he happen to roll them with watermelon cigars and he would dump the tobacco from the cigar which it camouflage the smell and they would not know that he was smoking but anyway; he thinks it gave the Officer the idea instead of taking him to jail, he could take his weed which he did, put on the ticket that search his vehicle, which he did, consent, yes, he thinks when he said that he had nothing to hide, he thinks was not a consent, he got the ticket dismissed and he had selfmedicated for 40 years on marijuana medically, never been arrested, never been convicted of a crime or never been to prison and he was trying to get the bottom of this why the Police Officers not in court or where was his medical marijuana and why did they not test it. Mayor Turner, Council Members Martin, Gallegos and Knox absent. Mayor Pro Tem Cohen presiding.

Mayor Pro Tem Cohen advised Mr. Barnaba that if he had an issued that he needed to file with the IAD Department and to speak with Mayor's Citizen Assistant which that was the direction he needed to go.

Mr. Frank Burns, 2811 Almeda Plaza Dr., 77045, (832)628-2256 had reserved time to speak but was not present when his name was called. Mayor Turner, Council Members Martin, Gallegos and Knox absent. Mayor Pro Tem Cohen presiding.

Mr. Reginald Moore, 8619 Barronwood Circle East, 77083, (281)495-1869 appeared and stated that it seems like it was an unavoidable when dealing with certain issues in dealing with

the Black community and there was an issue that was in the newspaper in this past week displayed it was dealing with the Third Ward fighting to match gentrification, he had a gentlemen that was affiliated with the Mayor with a development group who hoard proprieties that should be going for communities redevelopment and they were using for development, they have agencies that were formed, they have the Midtown Development Authority; for about 15 years they had misappropriated funds and he came here to give them some information for fraud and abuse, there was no accountability in the first year they had to pay back PUD dollars, these dollars with these lots and with this organization that was dealing with this gentlemen that was hoarding lots with the City and private funds, that should had been going for people that need affordable homes, church groups and organizations and had collaborative that led to this gentrification and he wanted to know the Mayors association and to some of the Council Members if they were with this group; there had been a lot of fraudulent things and he gave information to the Controller and these groups where the reason why they have this article that was done by MIT who said this was a travesty and disgrace and he wanted to know the Mayors affiliation, he wanted the transiency, this was a terrible article, this was Black on Black crime, stealing, Mr. Green, Mr. Davis, what was their affiliation and this was going on in Mr. Boykins area what do they know about this, this was hoarding, this was gentrification, the University Trans Development Place was going through, that this line did not go through, this was a disgrace and making off the poor, let's use the PUD money properly and revitalized the community and MIT has them on the scope.

Mr. James Partsch- Galvan, 2705 Terry St., 77009, (713)528-2607 had reserved time to speak but was not present when his name was called. Mayor Turner, Council Members Martin and Gallegos absent. Mayor Pro Tem Cohen presiding.

Ms. Madine Lewis, 914 Skyline Vista, 77019, (832)723-2914 appeared and stated she lives in the historical Allen-Parkway Village and she has two problems, the tenant that works with HUD, she has all of her evidence from 2013 to now, they called Precinct Six out, they do not do anything about it, she was constantly putting stuff on her porch, she had gone to Housing Department, written letters but she feels intimated, she feels like her rights have been taken, this past Friday, Precinct Six was out there and put her in handcuffs, they said that she had a gun and she pulled it out on a kid, she did not have a gun but she has a play gun that she keeps on her porch and the Officer did not even want to hear anything she had to say, she requested to speak with the Police Officer Supervisor and she does not think she can give names at this Council, that Members of Council needs to do something about Precinct Six Officer, she asked if she was allowed to call his name, well she said his name was Dennis she said his name because Members of Council did not say no; the problem with him was that he did not allow her to say anything, he jerked her hat off her head and two more years she will be 80 years old, she does not feel like she should be treated like a criminal, to be handcuffed or to be put in a Police car, to sit in the rain, she got a cold from it, she was embarrassed, she was handicapped, she did not do anything and the lady that she was having problems with said that she was going to get her evicted out of here because she works with the Housing Authority and she contacted Housing Authority who did not do anything, she needs help, she was a praying person, that people can get provoked and she tries to act like a Christian but these people push her to her limit, she has no weapon and that was the reason she came to Council for some help, what can Members of Council can do with Precinct Officer embarrassing people, she keeps having problems with these men please someone help her, who does she turn to. Mayor Turner, Council Member Stardig absent. Mayor Pro Tem Cohen presiding.

Mayor Pro Tem Cohen advised Ms. Lewis to speak with the Mayor's Citizen Assistance Department.

Council Member Cisneros moved to suspend the rules to add Mr. Davis Heck to the speakers list and seconded by Council Member Kubosh, all voting aye, nays none. Mayor Turner, Council Member Stardig absent. Mayor Pro Tem Cohen. **MOTION 2016-0271 ADOPTED** 

Mr. Davis Heck, no address, no phone number, appeared and presented a picture to Members of Council and stated that he was a Houston resident of 25 years and wanted to propose a question to every single person that was present in City Hall; "how many times did you change your vote because you saw a political poster on the side of the road" probably never, modern day voters were not easily persuaded by street-corner advertising and the problem was in low income areas of the City were being taken advantage by many political candidates, as party volunteers break the law by posting ads on derelict properties but many of these abandon properties do have owners and those property owners were not giving permission to have political advertising that were littering the landscape, the law was being openly broken to the detriment of neighborhoods and residents, candidates do not post illegal signs in River Oaks or the Galleria so why was it alright to subject low income areas to this out dated political strategy, candidates posters do not increase voter turn outs, blanketing the neighborhoods with political propaganda affect property value, no one wants to buy in an area with cheap advertising and most importantly, many of these ads do not fit the guidelines set forth by Texas Ethics Commission, Department of Transportation or the City of Houston Public Works Sign Administration, this practice was completely unacceptable and there was no accountability for these unlawful activities and many of these posters were abandon after the election and most candidates do not even know where their political posters were located, voters of Harris County deserve better and he has a solution of this plague in the communities; please require political ads that were over three feet to be tagged with a link to legal documentation showing that the owners have a written permission to be provided which was required by law and these tags would have an expiration date and voters deserve to know who was running and what was their platform, he believe a fact based web page would encourage citizens to vote. Houston candidates web page could cite an example for America and also reducing tons of political waste that were filling up the landfills each year, the greatest thing they can do for this City to regulate these large signs and to show legal proof of placement. Council Member Green absent.
