

City Council Chamber, City Hall, Tuesday, October 10, 2017

A regular meeting of the Houston City Council was held at 1:30 p.m., Tuesday, October 10, 2017; Mayor Sylvester Turner presiding, with Council Members Brenda Stardig, Jerry Davis, Dwight Boykins, Dave Martin, Steve Le, Greg Travis, Karla Cisneros, Robert Gallegos, Mike Laster, David Robinson, Michael Kubosh, Amanda Edwards and Jack Christie D.C.; Randy Zamora, Legal Department, Marta Crinejo, Agenda Director and Stella Ortega Agenda Office present. Council Members Ellen Cohen and Larry Green absent on personal business. Council Member Mike Knox absent due to be ill.

At 1:37 p.m. Mayor Turner called the meeting to order and stated they would start the presentations. Council Members, Stardig, Martin, Gallegos, Laster and Kubosh absent.

Mayor Turner stated that they were recognizing the Houston Municipal Pension Fund as it was Retirement Security Week and that recent data from the Employee Benefit Research Institute indicates that in the U.S., only 56 percent of workers or their spouses are currently saving for retirement and that the actual amount of retirement savings of workers lags far behind the amount needed to adequately fund their retirement and Americans are living longer and the cost of retirement is increasing, the financial literacy is an important factor in U.S. workers' understanding of the need to save for retirement and saving for retirement is a key component to overall financial health and security during retirement years and the importance of financial literacy in planning for retirement must be advocated, Retirement Security Week will be observed October 15-21, 2017, by supporting the Financial Retirement Employees Educational (F.R.E.E.) Summit event. The City of Houston salutes and commends the organizers and participants of Retirement Security Week and extends best wishes for a successful and rewarding observance and therefore, I hereby proclaimed October 15-21, 2017, as Retirement Security Week in Houston, Texas. Council Members Stardig, Martin, Le, Travis and Gallegos absent.

Mayor Turner stated that since 2010, Dr. Richard Ludwick has served as president of the Independent Colleges of Indiana, serving 31 institutions and 100,000 students. In that role, he led strategies that increased student funding, heightened policy and public support, promoted innovation and increased revenue and Dr. Ludwick's experience and success in higher education includes positions at St. Gregory University, Albany Law School, University of Florida College of Law and University of Oregon School of Law, earlier in his career, he co-founded a law firm in Indiana, Ludwick & LaRue, P.C., which focused on corporate, sports and higher education law and active in parish and civic life, Dr. Ludwick is a member of the Knights of Columbus, serves on the Fellowship Commission of his parish home, St. John the Evangelist, and has taught Confraternity of Christian Doctrine (CCD) and he has enjoyed a variety of roles in service to his community, including as a youth basketball coach, congressional campaign worker and public library board member and earlier this year, Dr. Ludwick became the ninth president of the University of St. Thomas. Today, we honor him for his outstanding achievements and work in higher education. The City of Houston commends Dr. Richard Ludwick on his accomplishments and extends best wishes on all future endeavors at the University of St. Thomas and therefore, I hereby proclaimed October 10, 2017, as Dr. Richard Ludwick Day in Houston, Texas. Council Members Stardig, Boykins, Martin, Travis and Edwards absent.

Council Member Davis stated that before they move on to the next proclamation, he would like to take a point of personal privilege, today they have volunteers from Student transportation of America/Canada and they work with the Mayor's Citizens Assistance Office and Solid Waste Department to clean up Harvey Storm debris in the Kashmere area, they have Jay Kirkman that is Human Resources Director for US Region which covers Texas and he has stated " as party of

our core mission as HR professionals we wanted to do a community project to help assist the citizens still suffering from the damage Hurricane Harvey left behind” and Council Member Davis introduced each individuals and where they were from.

Council Member Robinson stated that Ramonia McCarty has been serving Houstonians as a METROLift driver for the past five years and has consistently received METROLift’s monthly performance standard bonus and she is known for her positive attitude and her exemplary performance when picking up her paratransit customers and Ramonia McCarty was stranded with a METROLift paratransit client on board the night of August 26, 2017, as Hurricane Harvey hit Houston, she drove the cab to high ground, staying in the cab with her passenger for a total of 18 hours, and then safely delivered her passenger home through flooded streets the next morning, without flooding the inside of the cab and on September 26, 2017, the International Association of Transportation Regulators Board of Directors named Ramonia McCarty the 2017 International Driver of the Year due to her incredible efforts during Hurricane Harvey and this recognition is issued by government transportation professionals to a driver who has provided excellent service to passengers and has likewise performed in an extraordinary manner that exemplifies the highest level of the profession and on October 10, 2017, Ramonia McCarty will be recognized for her heroic, life-saving effort and the City of Houston commends and appreciates Ramonia McCarty for her selfless act of courage, her professionalism and her dedication to serving Houstonians in need and therefore, Mayor Turner hereby proclaimed October 10, 2017, as Ramonia McCarty Day in Houston, Texas. Council Members Stardig and Green absent.

Mayor Turner stated for those who forgot his birthday, that he is still celebrating, it is a late notice and he continues to celebrate it 30 days after that for those who forgot.

At 2:10 p.m. Mayor Turner recognized Council Member Davis for the invocation and the Pledge of Allegiance. Council Member Stardig absent.

The Roll was called. Council Members Ellen Cohen and Larry Green absent on personal business. Council Member Mike Knox absent due to be ill. Council Member Stardig absent.

Council Member Kubosh moved to adopt the minutes of the September 6, 2017 and delay adoption of the balance of the minutes and seconded by Council Member Robinson, all voting aye, nays none. Council Member Davis absent. **MOTION ADOPTED**

Mayor Turner recognized Council Member Boykins for a procedural motion; Council Member Boykins moved that the rules be suspended for the purpose of hearing Ms. Barbara Anderson out of order and seconded by Council Member Kubosh, all voting aye, nays none. Council Member Davis absent. **MOTION 2017-0617 ADOPTED**

At 2:13 p.m. Mayor Turner requested the City Secretary to call the List of Speakers.

Dr. Abdul Haleem Muhammad, 4443 Old Spanish Trail, 77021, (832)236-9956 appeared and stated that he came before them for the purpose like last time to ask approval of the Banner District in the Greater Southeast Management District and to accept the Director of Public Works recommendation and he will also take this occasion to thank the Mayor and City Council, the City Workers and everyone on how we all pulled together during Hurricane Harvey and the last time he was present they we debating about the Statues and we were torn apart but we all came together and so that being said let continue with that spirit and we do have pockets of despair that is still in the City and he will do his part and he will asked them for them to do their part that we can bring all of our citizens back to a sense of wholeness and completeness and also go Astros. Council Member Davis absent.

Ms. Malahat Kizilbash, 200 Beaver Creek Ct., South Lake, TX, 76092, (214)418-418-7667 appeared and stated that they had drove over from Dallas this morning, nine mom's because they care about Houston and from their T-Shirt and arm bans they represent HUSSEIN that was started in London and it was taken over by people all over the world and the aim is to spread positivity and HUSSEIN Texas is a small organization from all different walks and all different Religions, they did so many drives like blood drives, book donations, can food donation and in hope to lift up others but this was for Texas, their volunteers donated, they spent hours to work with Trusted World and sent donations to Texas and they had been training with Red Cross and the reason why they were here is because they started a GoMeFund me page with a goal of \$10,000.00 and they met it and they are here to present the Mayor with the check in person and just wanted to get together for Houston.

Mayor Turner thanked them and came to the podium to take a picture with the group and to receive the check.

Members of Council thanked them for the check and volunteering their time.

Mr. Thanh Lee, 16511 Obsidian St., 77095, (281)888-8426 appeared and stated today he comes in front of them to advise Members of Council about Hurricane Harvey and something that they did and when the Hurricane hit, he and a lot of his friends went out and saved a lot of people and the reason why they are here is that he has a student that is here from Australia and after Hurricane Harvey, he raised money from school and the teachers there, they put money together and they are here to present it to them, along with 3,000 letters from the school to the Hurricane Harvey victims and he was on a mid-term break and flew out here to deliver it.

Council Member Stardig moved that the rules be suspended for the purpose of allowing more than one person at the podium and seconded by Council Member Laster, all voting aye, nays none. **MOTION 2017-0618 ADOPTED**

Members of Council thanked them for what they donate and the 3,000 letters and the Mayor took a picture with them and accepted the donations.

Dr. Alkebu Motapa, 5022 Cosby, 77021, (713)741-5150 had reserved time to speak but was not present when his name was called.

Mr. Patrick McIlvain, 1618 Webber St., 77007, (713)705-7058 appeared and stated that today is the 25th Anniversary of World's Mental Health Day and the theme this year is Mental health in the Workplace and he wanted to present some facts in dealing with Mental Health in the Workplace and he thinks that these statistics are pretty important, Globally 300 million people are challenged with depression, 260 million people are challenged with Social Anxiety and many of us that face these difficulty face them both everyday WHO the World Health Organization conducted a study of the Economic Impact Globally of Mental Health in the Workplace and it causes one trillion in productivity loss and in America almost 44 million Americans experience a mental illness in a given year, 10 million adults that live in America live with a serious Mental Illness and almost 3 million Americans with Schizophrenia and 16 million Americans are challenged with depression and 90% of the deaths that are suicide are people who have a underline mental health condition and he thinks it is very important that the employees in the workplace have safe place to have a conversation and he would like to ask the Council to send a letter next year to the building in the Downtown area and surrounding areas that have LEDs lighting. Council Member Travis absent.

Members of Council questioned Mr. McIlvain.

Ms. Gladys House-EI, 1605 Andrews St., 77019, (832)781-9724 appeared and presented information and stated that she is here to find how much of that \$50 million of the FEMA money will come to Freedmen's Town, although they did not get flooding but they did get a lot of damage in the rain fall, from the roofs, the foundations have been slightly shifting and also FEMA has denied their claims, why is SBA is not giving any loans for them and they are really left with nothing to work with and they request that some of the \$50 million from FEMA to be directed to the Nonprofit Organizations in Freedmen Town and on the hand out that is going around there are still some outstanding concerns and one is when will their Historic Bricks be returned because it has been a year now and they have not been able to confirm the funding from Housing and Community Development on the Contraction of the Youth Center and the Administration is awaiting to hear something from him constantly, they are constantly promised a lot of things but nothing in written form, no time tables. Council Members Travis and Laster absent.

Members of Council questioned Ms. House-EI.

Mayor Turner questioned Ms. House-EI and stated that he needed to check on that because he thought that the contractor was finished on that street.

Ms. Barbara Anderson, no address, no phone, appeared and presented information and stated that those papers in front of them are emails and audits from the Houston First and Office of Business Opportunities and City Officials, she had reported this to everyone, this is her 4th visit, it shows that in the year 2007 to 2012 the Prime Contractor reported paying her company \$387,000.00 and she actually only received \$49,000.00, she reported this and fast forward to the present the last sheet audit date in 2015 that her company was paid with additional \$689,000.00 and then concerning 2 more years, Super Bowl, so sir the Prime owes her about \$1.5 million for services rendered on a City Minority Contract, are the people really the City and what is the City going to do, stay silence in this fraud or help. Council Members Le and Travis absent.

Council Member Boykins questioned Ms. Anderson and Mayor Turner stated that this is Houston First and not the City and in her situation she needs to get a lawyer.

Mr. David Tidmore, 8600 South Course, 77099, no phone, appeared and stated that he would like to make a personal observation about that courageous woman that worked with Yellow Cab that got the Proclamation, it was not even framed and he understands that the money is tight in the City but he is willing to pitch in and give her a frame and the reason he is speaking today is about communities and their communities have been devastated from Japan to the Mideast, we have had fires in California, fires in the Panhandle, we have had Hurricanes on every part of the Gulf Coast and we need to step back and reflect on this and what he is asking is that when we as Americans celebrate Thanksgiving, we do it one day on a Thursday in November and he is requesting a Proclamation to make the month of November Thanksgiving month so we can reflect on the First Responders and Private Responders that came to everyones aid, Civilians, the ones that lost their lives, the volunteers and City workers, Corporate Workers that helped tirelessly and he just wanted to make that comment. Council Members Le and Travis absent.

Mr. Bobby Taylor, Post Office Box 202021, 77220, (832)870-7673 had reserved time to speak but was not present when his name was called. Council Members Le and Travis absent.

Mr. Eli Sasson, no address, (281)250-2953 appeared and stated that he is here to talk on behalf of thousands of people that for 3 years in a row they have lost their home, the City is doing a great job on trying to help and he wanted to say something that they would consider to do some corrections, on August 1st the City sent a letter to the people who wanted to register to elevate their homes and after many suffering and by the time the letter came when it printed out it took 5-

7 days and many people after school took many of their kids, left for vacation and went out and they closed the list on August 25, 2017 and then they get Hurricane Harvey and now they have thousands and thousands of people that are asking for help and he understands that most likely all of City Council to try to get these funds to elevate and he trust that they are doing everything that they can and the one thing that they can do that is in their hands is to open back the list, give the people the opportunity to enroll, just consider and they would have a better judgement how the people are quantified and then they can make the arrangements and that is all he asking and he brought a copy of the letter. Council Member Travis absent.

Mayor Turner stated that Gary Norman from Public Works and Engineering is here to speak with him.

Mr. Jesse Rodriguez, 7546 Magnolia St., 77023, (832)289-8311 appeared and stated that he is running for School Board District 3 and that is not the reason he is here, on the end of this Hispanic heritage month, they are here not to complain or to vent but to honor Mayor Turner, he was born and raised here in Houston and is living in District I and he is here with 2 other passionate vocal community Activist who will be coming up here shortly and they are here to compliment and praise for all the good work that has been done in the Hispanic Community, they thank them for standing by with DACA and Dreamers, thanked them for the appointments of Chief Art Acevedo and Chief Samuel Pena and recognizing Houston Leaders in the Hispanic Heritage month like Johnny Mata and others, they thank them for their Cultural Arts Funding and thank them to coming to their events. Council Members Travis, Laster and Kubosh absent.

Members of Council questioned Mr. Rodriguez.

Mr. Javier Perez, 7627 Hirsch Rd., 77016, (713)628-2454 appeared and stated that he is the Executive Director Talento Bilingue Houston and he wanted to thank Council for their leadership that they portray in the most trying times they had during the Hurricane, he also wanted to thank the Mayor and Council for protecting the most valuable the young people, the Seniors and the immigrants and they saw firsthand the immigrants were coming were so afraid to ask for help because they did not want to put their name on a list where they would become targets, during the worst of times, we witness the best in people, the First Responders never faltered nor waited to be asked and they would be in forever in their debit and also wanted to recognized the organization that stepped up without being asked and helped and as soon as the roads cleared TBH suspended their schedule and open up as a relief shelter, they severed thousands of hot meals, gave out 200 articles of relief supplies and they had their volunteers help clear out homes and they housed over 200 volunteers from places like Arkansas, Atlanta, Ohio and more and now they come to the end of Hispanic Heritage Month and it is great to do this and they really wanted to thank the Mayor and the Council for being the first Municipality to recognized Tejano History Month. Council Members Boykins and Travis absent.

Council Member Robinson moved that the rules be suspended for the purpose of adding Mr. Marlan Sneed to the list of speakers and seconded by Council Member Kubosh, all voting aye, nays none. Council Members Boykins, Travis and Laster absent. **MOTION 2017-0619 ADOPTED**

Mr. Rashaad Price, 740 ½ W. Rittenhouse Rd., 77091, (713)427-9392 appeared and stated that he is a Stephen F Austin graduate and he has a Bachelor Degree in Health Science and he also been diagnosed with a mental illness and he wanted to shed some light on the Houston Jail System and he is currently going through a legal situation and he wanted to shed some light on Big Baker because it is egregious and when they put them in lock up when they get down there, they put them in a small room that is actually looks like it used to be a visitors booth and there are almost 20 people in there, there is no air conditioning in there and with so many people in there it is so hot and he knows that it's not supposed to be a playful place or an easy place to stay in but from the outside perspective and people that have not been locked up down there, they do not know the extent on how bad it is in there and also the case he is going through is actually in Angelonia County and the jail system is a lot better, its clearer and the food is great and they cater to people that have mental illness and he wanted to see if there was any way that Council can remedy that situation to where people are more educated or have had experience with mental illness before and come up with a solution. Council Members Boykins, Martin and Travis absent.

Mayor Turner stated that he agrees with Mr. Price and they need to get the proper treatment to individuals prior too, them even having to enter into the criminal justice system and making that detection on the front end and to help divert them into the place they really need for help.

Members of Council questioned Mr. Price.

Mayor Turner further stated that while he understood that Congresswoman Sheila Jackson Lee was supposed to be next and she is not here but she did provide a resolution that Congress officially started that the first week in October as Mental Illness Awareness Week and stated that Tanya from Congresswoman Sheila Jackson Lee Office is here and would like to have a conversation with him on behalf of the Congresswoman and he also going to have someone from his staff to go down there and hand him the Resolution and he can present it for the Congresswoman.

Congresswoman Sheila Jackson Lee, no address, (202)225-3816 had reserved time to speak but was not present when her name was called. Council Members Boykins, Travis and Laster absent.

Mr. Marion Scott, 1600 Louisiana St., 77002, (713)783-9292 had reserved time to speak but was not present when his name was called. Council Members Boykins, Travis and Laster absent.

and honored to say that he wrote a book and in November it will be up for adoption at the Texas State Board of Education. Council Members Boykins, Travis and Laster absent.

Mr. Marlan Sneed, no address, no phone, appeared and stated that he came up here to show them something, he came up with an acronym for Houston and he knows how much everyone loves Houston but some hate it, he is not here to ask for any kind of money, he just wanted the City to get behind this and he wants to unite the City and nothing unites likes sport and all he wanted to do is to show it and he held up his shirts and it said "Hatted On Us, So Tough Over Nothing" which he only had a couple of the shirts printed out, he had one representing the Rockets and one representing Astros since they are in the playoffs and hopefully the City will get behind it and push for it. Council Members Stardig, Boykins, Martin, Travis, Gallegos and Kubosh absent.

Mayor Turner stated that he appreciates what he did and wish him success

The City Secretary advised that a couple of Speakers that were called earlier are now present.

Ms. Anita Hernandez, 1508 Caze St., 77020, (281)738-0836 appeared and stated that she is employed Midwest Janitorial Service and she cleans and take care of the George R. Brown Convention Center and today she wanted to share with all of you how much GRB janitors and all Houston First workers are committed to their City, during and after Hurricane Harvey, Houston First Janitors like herself went beyond their regular duties to care for their community and she worked 7 days in a row and when she was not cleaning the restrooms or taking out the trash, in and on her off time she was changing diapers for elderly, took them to the bathroom, clean them , got their food and fed them, she sent photos and vidoes to her love ones in Mexico and across the U.S. to let them know that she was safe and she is still in touch with them today and as they know Houston First janitors are now in negotiations with their employer, Midwest and their employer has told them they would agree to much needed pay raises but that iut is up to Houston First for approval and she is here today to tell this City Council to tell Houston First that janitors, Union and Non-Union should have a pathway in their contract to \$12 per hour over the next 3 years. Council Members Stardig, Boykins, Martin, Le and Travis absent.

Members of Council questioned Ms. Hernandez at length.

Mayor Turner stated that he excepts Houston First to be very sensitive to the employees and not just to the General Contractor employees and employees to the Sub Contractors as well.

Council Member Kubosh stated that a Bill Brady that was present and he would like to make a motion to add him on the speakers list and Mayor Turner advised that there were not enough to make his motion.

Ms. Lauren Jean, 1305 W. 11th, 77008, (713)430-6397 appeared and stated that she is lifelong Houstonian and she would like to say when they were all locked in watching their televisions before the water rose, she never has been prouder of this City in the Leadership that Mayor Turner and Judge Emmett showed, she is a retired Hospice nurse and her mother is a long time 8 year resident at 2100 Memorial, she has congestive heart failure and she is aging in place and for our Seniors that can and would not or cannot afford assisted living and that is the case with a lot of them do not qualified for a nursing home and that is the case with a lot of the residents at 2100 Memorial, she gives her meds 4 times a day, she knows her neighbors in the building well, there has been a grave misunderstanding after the forced eviction that was forced by HHA and about the remaining residents, no one whats them there if it is not safe and there are people there that are concerned for their safety, they are not there by choice and they do not have anywhere to go. Council Members Stardig, Boykins, Martin, Travis and Le absent.

Mayor Turner stated that they are encouraging the Houston Housing Authority to work with all of the tenants, it has its own Board.

Council Members Ellen Cohen and Larry Green absent on personal business. Council Member Mike Knox absent due to be ill. Council Members Stardig, Martin and Le absent.

At 6:04 p.m. Mayor Turner called Public Hearing in connection with the bond election and called on Ms. Tantri Emo Acting Director of the Finance Department and Ms. Melissa Diebowsky for a power point presentation.

The Houston City Council reconvened at 9:00 a.m., Wednesday, October 11, 2017 Mayor Sylvester Turner presiding, with Council Members Brenda Stardig, Jerry Davis, Ellen Cohen, Dwight Boykins, Dave Martin, Steve Le, Greg Travis, Karla Cisneros, Robert Gallegos, Mike Laster, Larry Green, Mike Knox, David Robinson, Amanda Edwards and Jack Christie D.C.; Ronald Lewis, City Attorney, Marta Crinejo, Agenda Director and Stella Ortega Agenda Office present. Council Member Michael Kubosh absent on personal business.

At 9:08 a.m. Mayor Turner called the meeting to order and stated they would move to the Mayor's Report. Council Members Davis, Boykins, Le, Cisneros and Gallegos absent.

MAYOR'S REPORT

Mayor Turner stated he wanted to start a fairly brief report and as we talked about before, they have had number of people that raised concerns about their water bills, PWE has set up a hotline number and that number is (832)394-2455 for people who believe that their water bills have jumped dramatically, especially in the month of September and PWE will be staffing that number and will be handling their situations to a make determinations on a case by case basis what the situation is and how they can corrected.

Mayor Turner further stated that he has a brief report on the debris removal and that it is moving forward of schedule and he would ask Members of Council if they know areas in their own particular areas where they have not come through at least on the first pass and let Solid Waste know and in most areas they have made the first pass where they have picked up the heavy debris but there maybe certain pockets in their District where they may have not gone through on the first time and he wants to commend Director Hayes and his team, they have aggressively moved forward where people thought it would be at least a couple months before making that first pass; they have gotten approval from FEMA to remove debris on private streets and in gated communities and they are acting on that now and the first week in November with start back up on recycling and to remind everyone not to put the green bins out at this time because they want to focus on the heavy debris removal and they are moving ahead of schedule and he is very pleased with that.

Members of Council questioned Mayor Turner.

Mayor Turner stated that the next thing he wanted to speak about is that the World's Largest Bank which is ICBC and that a China Bank has opened up Office in the City of Houston and that occasion was last night and Houston will be the first location in the South West and they have about \$17 billion dollars' worth of investments in the United States and \$2 billion that is in the City of Houston and he also wants to congratulate Tillman Fertitta for finalizing the transaction between him and the NBA and now he is the new owner of the Houston Rockets and Go Rockets on that end and then he wanted to congratulate the Houston Astros for winning the Division and the game on Monday was a classic and their next game will be on Friday and it will be either in Houston or Cleveland and Go Astros.
