# MAYOR'S REPORT

Mayor Turner stated that Houston Health Department is doubling its daily COVID-19 testing compacity and the second drive-thru site has been stood up. Where they were doing 250 test per day and now it will go up 500 per day. As they work to provide additional support from their Federal Partners in terms of getting PPE and test kits, the hope is that they can do even more. He is also encouraging private testers like Legacy and others to go into the neighborhoods or different sectors in the City of Houston to do more testing. The more testing that they do, the more they can have a better idea of the community spread that is taking place within the City of Houston. These sites are for people that have symptoms of the virus, regardless of their age,

they can call the Houston Health Department and go through their process and they give them an authorization code, then they can process to get the testing. The number is (832)393-4220 and they can call from 9 a.m. to 7 p.m.

Mayor Turner stated as of yesterday, in the terms of confirmed cases in the City of Houston and that number is 377 confirmed cases. They fully anticipate that number to rise, the good news is the more that they test, and people are identified, they can engage in the connect tracing and isolate people has much as they can. He wanted to make this note, "if you are being tested and you have been tested and you are waiting on the results, to please return home and quarantine yourself and if you are tested and don't know the results don't go back for example like to work as you wait for the test results." Again, if you are not feeling well, just stay at home and think about your family members and friend's health. If we work here collectively, the sooner they can get out of this situation. He was on a conference call on yesterday with Dr. Peter Hotez which he is a leading epidemiologist at Baylor and what he indicated is that he felt that the peek for the state of Texas in his view which come around May 2<sup>nd</sup>. That's assuming that everyone participates and engage in social distances.

Mayor Turner stated in the terms of the First Responders as of this morning which the numbers are subject to change, there are 8 Firefighters that have tested positive and 12 Police Officers have tested positively, and 18 City of Houston Municipal people have tested positive.

As they know that the Stay Home, Stay Safe Order was extended through April the 30<sup>th</sup> and this lines up with the President's Social Distancing and the Governor's Social Distancing Order. He wants to thank the Faith Based Institutes for working with them and he is going to continue working with them, by doing their services online. He wanted to let everybody know that this is working. Look at the numbers where we are today and compare it to others, that shows that these steps are working.

This is April 1<sup>st</sup> and there is a lot of people that their rent, mortgages and business need to make payments, they are going to ask the Financial Institutions, Landlord's and others to work with each other.
