Council Chamber, City Hall, Tuesday, November 15, 2022

A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, November 15, 2022, with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Tiffany Thomas, Mary Nan Huffman, Karla Cisneros, Robert Gallegos, Martha Castex-Tatum, Mike Knox, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department and Marta Crinejo, Agenda Director, present. Council Member Edward Pollard absent. Council Members Dave Martin and David W. Robinson out of the City on City business.

At 1:33 p.m., Mayor Turner called the meeting to order and recognized Council Member Alcorn for the first presentation.

Council Member Alcorn presented a proclamation for the Charity Guild of Catholic Women celebrating their 100th anniversary. Accepting the proclamation were Elizabeth Jordan, President of the Charity Guild of Catholic Women, and members of the Board.
