MAYOR'S REPORT

Mayor Turner stated since Tuesday of last week, it's been very busy in the City of Houston with a lot of things having taken place. Last Tuesday, we had the Ronald McDonald games with the high school players, for both women and men. That was very well attended, people were very pleased with that. Then of course the NCCA Men's Final Four, both on Saturday and Monday were well attended, over 70,000 people there. The concerts, in front of Discovery Green and New Addition at the Toyota Center, the Astros playing, the Rockets playing, the HBCU All Star College game and just a lot of things. The IFTAR dinner on Sunday night was the largest in the country, over 2300. Just a lot of events that took place in the city and he wants to give credit to all of the first responders, Fire Department, Police Department, EMS workers, Municipal workers, Houston Public Works and the thousands of volunteers who really were the ambassadors for our City. A lot of praise and credit to all of them, but it was an excellent showing on behalf of the City of Houston from all indications people thoroughly enjoyed themselves from those who visited as well as those who live in the region and literally for everybody.
