At 9:05 a.m., Mayor Turner called the meeting of the Houston City Council to order and moved to the Mayor's Report.

MAYOR'S REPORT

Mayor Turner stated that the Department of Justice opened up an investigation on the City of Houston as it relates to illegal dumping about a year ago. There has been a lot of conversations and sharing of information over the past several months. On yesterday, there was an announcement with the U.S. Assistant Attorney General for Civil Rights, Christian Clark, who came to Houston regarding the voluntary resolution of this particular matter. Quite frankly, it is an institutionalized One Clean Houston that's already in place which is producing some positive results. They will continue to move forward in addressing illegal dumping throughout the City of Houston. One Clean Houston is working, which is what the agreement is. It is adopting what they already have done. He wanted to say thank you to Arturo Michel and his legal team because they did an outstanding job. Also, thank you to Director Mark Wilfalk from Solid Waste and community leaders.

Today at 3:00 p.m., they will join the Federal Railroad Administrator, Amit Bose to talk about the city's Railroad Crossing Elimination Grant award of \$36.9M. It's the largest Railroad Crossing Elimination Grant awarded in the State. The location of this announcement is at 2197 Franklin Street. He wants to give credit to Council Member Gallegos for his advocacy. He has been a strong advocate for the City of Houston and his push has led to this taking place and it will be a benefit for businesses, residents and people living on the East End when it comes to railroad crossings.

The Gun Buyback Program is this Saturday, June 10th, in partnership with Harris County Precinct 1 and the Houston Police Department from 8:00 a.m. to 12:00 p.m. at NRG Stadium. He is hopeful that people will come out and make this event successful. He wants to thank Chief Finner, HPD and Harris County for their partnership.

He is very excited about the Hire Houston Youth Program. The focus is 16 years old to 24 years old. Eight (8) years ago, the City of Houston was offering about 450 intern jobs and they were all city intern jobs. Now that we're working with the private sector, they're working with about 500 businesses. They are about 3,000 shy of 20,000 summer paid jobs for this year. It will be the largest number in our 8 years. The City of Houston is providing 450 of those jobs but the remaining 17,000 is coming from the private sector. He wants to give a shout out to Olivera Jankoski and Jane Cheeks and her team. A shout out to Council Member Cisneros because she started that drive 8 years ago dealing with our youth and working with our educational institutions.

The Mayor's Office of Veterans and Military Affairs is hosting a Texas Women Veteran's Day Celebration honoring the 75th Anniversary of the Women's Armed Services Integration Act that enabled women to serve as permanent regular members of the Armed Forces. The event wil take place on Monday, June 12th at 1:00 p.m., in the City Hall Legacy Room.

Mayor Turner stated this month is Pride Month. There are a lot of activities planned in the month of June. June 24th is the Pride parade. He wants to encourage people to come out.
