

City Council Chamber, City Hall, Tuesday, July 26, 2005

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, July 26, 2005, Mayor Bill White presiding and with Council Members Toni Lawrence, Carol M. Galloway, Mark Goldberg, Ada Edwards, Addie Wiseman, M. J. Khan, Pam Holm, Adrian Garcia, Carol Alvarado, Mark Ellis, Gordon Quan, Shelley Sekula-Gibbs, M.D., Ronald C. Green and Michael Berry; Ms. Jo Wiginton, Division Chief, Contract Division, Legal Department; Mr. Richard Cantu, Director Mayor's Citizens Assistance Office; Ms. Marty Stein, Agenda Director Mr. Jose Soto, Assistant Agenda Director present.

At 1:53 p.m. Mayor Pro Tem Alvarado stated that Council Member Sekula-Gibbs would begin the presentations; and Council Member Sekula-Gibbs stated that it was her pleasure to present a Proclamation to a notable genius and invited Mr. Kayvan Mashayekl and members of the crew and cast to the podium. Council Member Sekula-Gibbs stated that he was writer, director and producer of a movie called "The Keeper" which was a film telling a story of a financial immigrant from Houston who learned he was of direct descent to a eleventh century Persian scientist and poet and Houston was one of five locations for filming; and presented Mr. Mashayekl with a Proclamation for his film which had generated \$90,000.00 benefiting the Texas Children's Hospital; reminding all they were "Keepers of stories, traditions and beliefs" and proclaimed July 26, 2005 as "The Keeper Day" in Houston, Texas. Mr. Mashayekl stated that it was an honor to be present; and thanked all who shaped the City of Houston which brought him to make his film; and thanked and acknowledged all who worked on and took part in the film. Mayor White, Council Members Edwards, Holm, Garcia and Berry absent. Mayor Pro Tem Alvarado presiding.

Council Member Goldberg invited Mr. Greg Marshal, the Director of Community and Government Relations, to the podium and stated that a couple of months ago in District C they broke the Guiness World Records in Nano Technology and invited Mr. Richard Smalley and Mr. Mafio Pasquallie along with the Director of the Center for Nano Science and Technology Mr. Wade Adams to the podium. Council Member Goldberg stated that what they were displaying was a small segment of the model which broke the world record, it was 360 meters long, taller than the tallest building in Houston; and presented them a Proclamation for carbon nanotubes being members of the family of carbon molecules, a unique form of carbon first discovered in Houston in 1985 at Rice University; that they weighed one-sixth as much as steel but 100 times stronger and they had potential to revolutionize energy production, storage and transportation with NASA being one who hoped to revolutionize rockets with it; and proclaimed April 22, 2005, as "Carbon Nanotube Day" in the City of Houston. Mr. Smalley stated that he was a Houstonian for almost 30 years now and this was a new polymer which conducted electricity and it would have a tremendous impact as it was developed for Houston and the State of Texas for new energy technologies and super strong materials and batteries; and presented certified pieces of the nanotube model for Council Member Goldberg and Mayor White. Mayor White, Council Members Edwards, Garcia, Green and Berry absent. Mayor Pro Tem Alvarado presiding.

Council Member Sekula-Gibbs complimented all of them for their work on behalf of the City of Houston and the world in reducing future energy needs. Mayor White, Council Members Edwards, Garcia, Green and Berry absent. Mayor Pro Tem Alvarado presiding.

Council Member Khan invited Ms. Bapsy Sidhwa to the podium and stated that she was a distinguished international writer who had published four novels American Brat, Cracking India, The Bride and The Crow Eaters; that Cracking India was made into a film and she had received many awards; and presented her a Proclamation congratulating and commending her and proclaimed July 26, 2005 as "Bapsy Sidhwa Day" in Houston, Texas. Council Member Khan acknowledged all those present honoring Ms. Sidhwa and asked them to stand to be recognized; and Ms. Sidhwa stated that she was grateful to Mayor White, the City of Houston and the Houston City Council for honoring her so greatly and was humble to be in such good company today; and with all cities she had been in loved Houston. Mayor White, Council Members Goldberg Garcia and Green absent. Mayor Pro Tem Alvarado presiding.

Council Member Quan congratulated Ms. Sidhwa and stated that she had been a great treasure to the Houston community and he wished her the very best. Mayor White, Council Members Goldberg Garcia and Green absent. Mayor Pro Tem Alvarado presiding.

At 2:18 p.m. Mayor Pro Tem Alvarado called the meeting to order and called on Father Kevin A. Collins of the Immaculate Heart of Mary which was within the Magnolia Park community to lead all in the prayer and Mayor Pro Tem Alvarado led all in the pledge. Mayor White and Council Member Garcia absent. Mayor Pro Tem Alvarado presiding.

At 2:19 p.m. the City Secretary called the roll. Mayor White and Council Member Garcia absent. Mayor Pro Tem Alvarado presiding.

Council Members Khan and Quan moved that the minutes of the preceding meeting be adopted. All voting aye. Nays none. Mayor White and Council Member Garcia absent. Mayor Pro Tem Alvarado presiding. MOTION ADOPTED.

Council Member Galloway moved to hear Ms. Ivy Spivey, Ms. Gwen Wolfe and Mr. Gary Bauch out of order, seconded by Council Member Ellis. All voting aye. Nays none. Mayor White and Council Member Garcia absent. Mayor Pro Tem Alvarado presiding. MOTION 2005-0687 ADOPTED.

Council Member Wiseman stated that as a point of personal privilege she wanted to recognize the children in the Summer Page Program and introduced Amaya Valley, Charli Worrel, Jessika Cantu and Ashlee Cantu and asked them to stand to be recognized. Mayor White and Council Member Garcia absent. Mayor Pro Tem Alvarado presiding.

Ms. Ivy Spivey, 12410 San Lucia River Drive, Houston, Texas 77050 (281-590-8677) appeared and stated that today she was present with an Oak tree which was sold to her by Mr. Willie Hunter for \$25.00, but she had no idea it was the City's tree; that she called in and reported Mr. Hunter and he said she took it off her truck, but that was not true and he needed investigating; that he called Officer Hobb and said she took the tree. Mayor White and Council Member Garcia absent. Mayor Pro Tem Alvarado presiding.

Upon questions by Council Member Galloway, Ms. Ivy said it was a City tree; that it was sold to her off Homestead and Lee Road, but when she started noticing the trees down the street she realized it was a City tree; that Officer Hobb stated that they investigated and the gentleman working with Mr. Hunter admitted he did give her the tree but it was just a \$12.00 tree; and Ms. Ivy stated that it was the principal; that it was the City's tree; and she was told nothing could be done as no one saw anything; and Council Member Galloway stated that she would like a thorough investigation and report; and Mayor White stated that was fair and he appreciated her bringing it to their attention. Council Members Khan, Garcia, Ellis and Berry absent.

Upon questions by Council Member Quan, Ms. Spivey stated that she received a phone call from Officer Hobb and Mr. Hunter accused her of taking the tree; that the DA's Office said it was only \$12.00; that she made the complaint with Mr. Mayo; and Council Member Quan stated that if they were stealing from the City then they should be prosecuted; and Mayor White stated that a representative with HPD was present and it would be followed up on; and Ms. Spivey stated that she brought the tree back but she could not get her money; and Mayor White stated that he would bet Mr. Cantu could solve the problem; and thanked Ms. Spivey for the tree. Council Members Lawrence, Khan, Garcia, Alvarado, Ellis and Berry absent.

Ms. Gwen Wolfe, 1301 McKinney, Houston, Texas 77010 (713-545-2917) appeared, presented information to Council Members and stated that she was a reverse mortgage consultant with Wells Fargo Home Mortgage and was present as a result of Council Member

Green; that a reverse mortgage was a home loan for seniors over the age of 62 who owned their own home and lived in it as their primary residence; that the government allowed them to borrow a portion of the equity from the home and it could be used however they choose; that it was insured by FHA and governed by HUD; and Wells Fargo was the primary lender for that loan in Texas. Council Members Lawrence, Galloway, Khan, Holm, Garcia, Alvarado and Ellis absent.

Council Member Quan thanked Ms. Wolfe for coming and stated that he knew the department was looking at reverse mortgages and a representative from Hibernia Bank was present last week from New Orleans; and upon questions, Ms. Wolfe stated that they also gave a presentation to the Department of Housing last week. Council Members Lawrence, Khan, Holm, Garcia, Alvarado and Ellis absent.

Council Member Green stated that he did mention a meeting in the Sunnyside area on reverse mortgages and he wanted people to know what they were getting into, but he hoped she was not present because of him; and he wanted them to educate the people as well on reverse mortgage so they would know all ramifications. Council Members Khan, Ellis and Quan absent.

Mr. Gary Bauch, 13911 Murifield Village Drive, Houston, Texas 77069 (281-416-3922) appeared, presented information and stated that his purpose today was he was the regional manager for reverse mortgage for Wells Fargo for Houston and South Texas and as of August 1st he would be representing the State of Texas with Wells Fargo on reverse mortgages; that he understood there were unscrupulous lenders in the Sunnyside area and under the guise of reverse mortgage were making home equity loans, but on reverse mortgage there was no mortgage payment and until the senior either sold the home or until they passed away the home and equity was theirs and the equity actually went to the heirs or the estate. Council Members Wiseman, Khan, Ellis and Quan absent.

Council Member Green thanked Mr. Bauch for coming and stated that he wanted to make sure the homeowners who took advantage of this understood it; and he thanked him for them educating homeowners. Council Members Khan, Ellis, Quan and Berry absent.

Council Member Sekula-Gibbs stated that she appreciated them coming and clearing up some things on reverse mortgage such as they must be 62 or over and that they hold ownership; and upon questions, Mr. Bauch stated that there were no monthly payments and it was an adjusted rate and the interest rate was deferred until they sold the home, etc., the equity remaining when the heirs received it went to them or the estate whatever was established by the will. Council Members Khan, Ellis, Quan and Berry absent.

Mr. Vance Lane, 4406 Pineville, Houston, Texas 77388 (281-353-2055) appeared and spoke in opposition to Agenda Item 31 and stated that he owned a limousine company in Houston and was a part of the board of directors of the Limousine Association; that the Mayor stated they needed more targeted recruitment of likely corporate relocations and better coordination of economic development activities in the region and they agreed with that but a rate hike of 40% would not help that goal. Council Members Khan, Garcia, Ellis, Quan and Berry absent.

Mr. Michael Arrieta, 5411 Aspen, Houston, Texas 77081 (713-953-0022) appeared and spoke in opposition to Agenda Item 31 and stated that if it was Council's contention the taxi and limo industries were competitors when would a limousine booth be established at airports or downtown areas as taxis. Council Members Khan, Garcia, Ellis, Quan, Sekula-Gibbs and Berry absent.

Mr. Patrick Smith, 3505 Sage Road, Houston, Texas 77056 (713-553-1718) appeared and spoke against Agenda Item 31 and stated that he was a limo owner and driver in Houston and

was also against the rate hike and he wondered if the rate increase was discussed with members of the Greater Houston Convention and Visitors Bureau and if so were they in favor of it. Council Members Khan, Holm, Ellis, Quan, Sekula-Gibbs and Berry absent.

Mayor White thanked Mr. Smith for coming and stated that they wanted to have the capacity within the community to service as many customers as they could at the peak and they did survey regulations in other cities; that taxis, limos and mass transit were all part of the picture and he knew there were different views, but appreciated his thoughts. Council Members Khan, Holm, Ellis, Quan, Sekula-Gibbs and Berry absent.

Council Member Alvarado moved to hear Ms. Lucy Salazar, Elvira Casarares and Mr. Moses Villalpando after Mr. Michael Holt, seconded by Council Member Khan. All voting aye. Nays none. Council Members Wiseman, Holm, Ellis, Quan, Sekula-Gibbs and Berry absent. MOTION 2005-0688 ADOPTED.

Mr. Josef Khanoyan, 9910 Mossy Tree Lane, Houston, Texas 77064 (no phone) appeared and spoke against Agenda Item 31 and stated that he was with Corporate Car Service in Houston and if you could get a taxi from the airport for \$22.00 their charge of \$70.00 would be almost double and that was excessive, over the edge and would drastically affect their business. Council Members Wiseman, Holm, Ellis, Quan, Sekula-Gibbs and Berry absent.

Mr. Kevin Claypool, 4618 Park, Bellaire, Texas 77401 (713-218-7433) appeared and spoke against Agenda Item 31 and stated that he was representing some small three car operators; that when he first started he tried charging \$70.00 and his car stayed parked and now charging \$55.00 to \$60.00 it made a difference; and he understood with a contract in place you could grandfather in your cost, but he did not have those so he could not compete in that way either and he would basically be taken out of business. Council Members Wiseman, Holm, Quan, Sekula-Gibbs and Berry absent.

Mr. Jerry Brady, 827 East Rogers, Houston, Texas 77291 (713-696-0177) appeared and spoke in favor of Agenda Item 31 and stated that he was president of Liberty Cab Company and he supported the Director of F & A's recommendation 100% and complimented her and others on the wonderful job they did on meeting with everyone and coming up with this proposal to correct ground transportation problems. Council Members Wiseman, Quan, Sekula-Gibbs and Berry absent.

Upon questions by Council Member Khan, Mayor White stated that the last limousine rate increase he believed was in 1989; and Mr. Brady stated that it was four years on the taxi rate; and Council Member Khan stated that it was 15 years to revise limo rates and most fuel cost was in the last four years and that needed to be taken in perspective. Council Members Quan, Sekula-Gibbs and Berry absent.

Mr. Rudy Bruhns, 1406 Hays, Houston, Texas 77009 (713-224-4445) appeared, presented information and spoke in favor of Agenda Item 31 and stated that Yellow Cab supported the F & A's recommendations and complimented the department on their work; that it had been four years since the last increase and gasoline prices had increased 46.4% since then; that increasing the limousine rate would distinguish differences between luxury limousine services and taxicab services; and urged passage of the ordinance. Council Members Quan, Sekula-Gibbs and Berry absent.

Council Member Galloway moved to hear Mr. Trent Winters out of order, seconded by Council Member Green. All voting aye. Nays none. Council Members Quan, Sekula-Gibbs and Berry absent. MOTION 2005-0689 ADOPTED.

Mr. Trent Winters, 7967 W. Airport, Houston, Texas 77071 (713-729-1153) appeared, presented information and stated that he was present again regarding the elderly housing

program; that what he presented to Council was from the City regarding the Tier Programs and the money they gave in 2004 only had a quarter of it spent so something was wrong; that the city could help fix problems and were not doing it. Council Members Edwards, Alvarado, Sekula-Gibbs and Berry absent.

Council Member Quan stated that he appreciated him coming and holding Council responsible; that recently a job contract was approved so they could move faster; and he would make this an item for the next Housing Committee Meeting and they would ask the department to give a full report on repairs; and invited Mr. Winters to the meeting. Council Members Edwards, Sekula-Gibbs and Berry absent.

Mayor White stated that on problems with HUD he could not control the federal government and one issue had been them wanting the City to spend money on re-inspections of all done over the last five years or they would not get credit for money spent; that people were working long hours in Housing and now they had a more reasonable proposition, but he agreed nothing should be misrepresented. Council Members Galloway, Edwards and Berry absent.

Ms. Emily Hayes, 201 S. Heights Blvd., Houston, Texas 77007 (713-863-8012) had reserved time to speak but was not present when her name was called. Council Members Galloway, Edwards and Berry absent.

Mr. Joe Jordan, 2615 Waugh Drive, Houston, Texas 77006 (713-680-3181) appeared, presented information and spoke in opposition to Agenda Item 31 and stated that he was president of the Limousine Association in Houston and asked all members present to stand to be recognized. Mr. Jordan further stated that they were 100% opposed to the rate hike, it had not been raised since 1989 because there was no reason for it and why have a one day raise of 40%; that it would hurt them and the City of Houston and it was their position to file a federal lawsuit against the City of Houston if the 40% vote was approved as they felt they were in violation of the HOBB Act, etc., and it was excessive restraint of commerce and only 9% of cities in America regulated limousines in any way; and encouraged a no vote. Mayor White, Council Members Galloway, Goldberg, Garcia and Berry absent. Mayor Pro Tem Alvarado presiding.

Upon questions by Council Member Khan, Mr. Jordan stated that they felt they could live with a 10% increase but corporations were already complaining about the rate of \$50.00 from the airport when a cab was \$20.00, they felt to be fair there should be a price margin but not 40% in one day. Mayor White, Council Members Galloway, Goldberg, Wiseman, Garcia, Green and Berry absent. Mayor Pro Tem Alvarado presiding.

Council Member Quan stated that he found it interesting they did not want a pay increase, most people said they wanted more and they were asking to not be forced to charge more; and upon questions, Mr. Jordan stated that there were 300 limousine companies in the City of Houston and about 70 belonged to their association and not one single limousine company has come before Council asking for a rate hike; that under the current program they could work with incoming conventions, but under the proposed ordinance it prohibits them from negotiating. Council Member Quan stated that he was in New York and a limo was \$30.00 and he was always knew a competitive market such as that worked so well that way; and Mr. Jordan stated that was how it should be here. Mayor White, Council Members Galloway, Wiseman, Garcia, Green and Berry absent. Mayor Pro Tem Alvarado presiding.

Mr. Michael Rindenow, 5479 W. Sam Houston Parkway, Houston, Texas 77041 (713-464-3344) appeared and spoke in opposition to Agenda Item 31 and stated that he was owner of Hallmark Limousine and Towncar Service and the proposed fee would impair their ability to provide services they now provided; that letting the market determine the price was the way it should be; that they were a predetermined service and not competition to taxis, they had no booth at the airport or lines at hotels, etc.; and urged a withdrawal on rates. Mayor White,

Council Members Galloway, Holm, Garcia, Green and Berry absent. Mayor Pro Tem Alvarado presiding.

Council Member Goldberg stated that one problem with the ordinance was if a big corporation called and wanted a contract for so many rides it would still be \$70.00 a ride no matter how many rides the corporation wanted to contract for; and upon questions, Mr. Rindenow stated he was correct and F & A proposed to add on that if there was already a contract before the date of effectiveness they would allow those rates; and Council Member Goldberg stated that it seemed there should be a leeway within the ordinance for multiple contracts or multiple use, he did not see how that would hurt the cab industry; that he did want to correct something as they would not have to pay the \$70.00 plus tip the total price had to be \$70.00 so if they wanted to include gratuity, tolls, etc., in the price their ride could be less than the \$70.00; and Mr. Rindenow stated that he thought that would be a good idea but it was not spelled out in the ordinance, if it was then it would be clear that would be a way to go. Mayor White, Council Members Galloway, Holm, Garcia, Green and Berry absent. Mayor Pro Tem Alvarado presiding.

Ms. Cheri Muenchausen, 22 South White Pebble Court, Spring, Texas 77380 (713-553-5755) appeared and spoke in opposition to Agenda Item 31 and stated that she owned a Towncar service in Houston and they did not advertise, they had a base of clients they used all the time and their clients were not happy with the proposed ordinance; that the \$70.00, two hour minimum was a problem and an example was they had a ride which was five minutes and under the proposed ordinance it would be \$70.00. Mayor White, Council Members Galloway, Holm, Garcia, Ellis, Green and Berry absent. Mayor Pro Tem Alvarado presiding.

Upon questions by Council Member Quan, Ms. Muenchausen stated that they had been charging a surcharge for fuel as it appeared necessary and at this time it was a \$2.00 per trip charge, depending on length of trip; and tipping was at the discretion of the customer. Mayor White, Council Members Galloway, Garcia, Ellis and Berry absent. Mayor Pro Tem Alvarado presiding.

Upon questions by Council Member Edwards, Ms. Muenchausen stated that they had no meter and they had no minimum rate; that they had an agreed amount with major corporations they did business with, it was a flat set rate and if they kept the car there were additional charges; and Council Member Edwards stated that if something went wrong they would come to the City; and Ms. Muenchausen stated that the City did permit them but they thought the market should dictate the rate. Mayor White, Council Members Galloway, Garcia, Ellis, Green and Berry absent. Mayor Pro Tem Alvarado presiding.

Council Member Goldberg stated that the City did regulate limousines and price was just one thing, but the \$70.00 could include the surcharge; and Ms. Muenchausen stated that they now charged \$50.00 because that was the minimum charge and the proposal was a significant increase. Mayor White, Council Members Lawrence, Galloway, Garcia, Ellis and Berry absent. Mayor Pro Tem Alvarado presiding.

Mr. J. W. Masseh, P. O. Box 742713, Houston, Texas 77274 (713-545-4777) appeared in favor of Agenda Item 31 and stated that he was president for independent cab drivers and initially they opposed the rate increase on the ground some protested the super shuttle, but they were now supporting the increase 100% under the condition it was the actual increase for them and not a zone rate; that they also wanted to pass their airport fee to the consumer and with gas going up they were asking for an additional \$2.00 per rider and that would compensate. Council Members Galloway, Goldberg, Garcia, Alvarado, Ellis, Sekula-Gibbs and Berry absent.

Council Member Khan stated that people taking cabs complained that the driver charged more than the zone rate and that also needed to be addressed; that taxi drivers he dealt with were honest and hardworking people proud of what they were doing and making guests to

Houston welcome and they should make the policy so they did not get a bad rep. Council Members Galloway, Goldberg, Garcia, Alvarado, Ellis, Sekula-Gibbs and Berry absent.

Mayor White stated that he thanked him for coming and as he would recall their first conversation about adjusting fares to take into the price increase; that he would ask they take into account the issues of structure of rates; that he knew many taxis had to wait a long time at airports and limos did not and they wanted to create a situation where people had options and where people performing the service were fairly compensated. Council Members Galloway, Goldberg, Garcia, Alvarado, Ellis, Sekula-Gibbs and Berry absent.

Mr. Richard Cowan, 8155 Hartford, Houston, Texas 77017-2230 (713-649-1112) appeared, presented information and appeared in favor of Agenda Item 31 and stated that he was owner of City Cab and City Towncar and was going along with F & A's recommendation; that he did want to reassure Council how important it was to change the limousine rate, he was appalled to hear the limo industry say they were not competing with taxicabs and yet two speakers said they wanted to take someone around the corner, etc., and that was for taxicabs; that they were supposed to charge per hour, not per trip and why were they advertising in phone books under taxicabs. Council Members Lawrence, Galloway, Goldberg, Garcia, Alvarado, Ellis, Sekula-Gibbs and Berry absent. ((NO QUORUM PRESENT)

Ms. Linda Pomerleau, 5218 Lacreek, Spring, Texas 77379 (281-320-0005) appeared and spoke in opposition to Agenda Item 31 and stated that she was owner of Gulf Coast Limousine Services in Houston and she had Towncars, limos and antiques and was totally opposed to the rate increase; that Council Member Goldberg mentioned if the rate went to \$70.00 then it would be a rolled in amount including gratuity, surcharge, etc., and most of her Towncar trips were between \$65.00 and \$70.00 and that was about what they normally charged, but to make her charge \$70.00 without a stipulation in the ordinance was wrong, they could not arbitrarily say they were interpreting the ordinance to include all Council Member Goldberg mentioned and felt that part of the ordinance should go back and be checked and if it was to be included it should be spelled out; that they also wanted provision for future convention work so they could be competitive and charge less than the \$70.00. Council Members Lawrence, Galloway, Ellis, Sekula-Gibbs and Berry absent.

Mr. Michael Holt, 1790 East Hardy, Houston, Texas 77073 (281-821-8989) appeared in favor of Agenda Item 31 and stated that the taxicab drivers did not have to be considered criminals with zone rates they could just honor the zone rate, the airport customer was a unique customer; that they were only asking for a separation of the market segment and if limo trips were supposed to be two hours then it should be two hours and if he had a good customer who did have a small trip they could comp it and make it up later; that larger companies did seem to abide by the rules but no one was watching the little companies and maybe next time the cab rate went up so should the limos, maybe there should be a parity difference of 40% between them. Council Members Lawrence, Galloway, Garcia, Ellis, Sekula-Gibbs and Berry absent.

Ms. Lucy Salazar, 1416 Munger, Houston, Texas 77023 (832-466-4307) appeared and stated that she was present a year ago with concerns of the sidewalk in the 1400 block of Munger; that some have fallen because they were so broken and Mr. Cardova said they would be getting new sidewalks in her block on both sides along with wheelchair ramps, but today she received a call from Mr. Gary Norman saying there would be no new sidewalks only the ramps at the corner and that would do no good because the sidewalks were not walkable; and she was told it was their problem, they needed to fix their own sidewalks, but if one could afford to fix it and the next could not then a person in a wheelchair could still not use the sidewalk and many could not afford to fix them. Council Members Galloway, Sekula-Gibbs and Berry absent.

Council Member Alvarado stated that their office was familiar with this and Ms. Salazar did bring up a good point as there were two schools in the area and there was the transit center; that Munger was a major artery street and she knew they had talked about the sidewalk

ordinance but she did not agree with it as if some could fix it and others could not there was inconsistency and she hoped to take up the issue; and with her being told they would get the sidewalk and then told no they would not she did not know where the breakdown was but she hoped it could be resolved and also hoped she would get the sidewalk. Council Members Galloway, Sekula-Gibbs and Berry absent.

Upon questions by Council Member Edwards, Ms. Salazar stated that she was given a name to call, Ms. Murray and she called her about the handicap issue but never received a return call and if they were going to not give them sidewalks then they should not put the ramps and save the money; that another person who never returned her call was Maria Rocha, the Mayor's community liaison. Council Members Galloway, Ellis, Sekula-Gibbs and Berry absent.

Upon questions by Mayor White, Ms. Salazar stated that she called Ms. Rocha after she left a year ago and called again a couple of months later and never received return calls; that Mr. Mike Cordova and Mr. Gary Norman had called her; and Mayor White stated that he would say to Mr. Norman that on sidewalk repair they needed criteria and he shared the concern that there were circumstances in which it was the public interest to do it and one circumstances would be pedestrian access review standard; and would like this case used as a laboratory case to come up with criteria such as proximity to a public facility such as METRO, a school, etc., and presence of handicapped residents and age of the sidewalk as some people were overdo for repairs in their neighborhoods, but Mr. Norman could look at that and then report back to him. Council Members Galloway, Wiseman, Ellis, Sekula-Gibbs and Berry absent.

Ms. Elvira Casarares, 1047 Zoe, Houston, Texas 77020 (713-673-6858) appeared and stated that three months ago the transformer light in her neighborhood burned down and now they were repairing, but when she bought her house years ago there were pipes in the alley for all utilities and now they were digging ditches, but she needed the pipe back; that Council Member Alvarado's assistant said the ditches and alley belonged to her and it did not it belonged to the city and they were responsible for the pipe; and the sidewalk from her house to the church had the pipes removed to and they also needed the pipe to cross over to the church. Council Members Galloway, Wiseman, Holm, Ellis, Sekula-Gibbs and Berry absent.

Council Member Alvarado stated that she and Ms. Casarares spoke with Mr. Gary Norman and there was question that Center Point may have right of way there with the culverts, but she was convinced it was not so she asked Mr. Norman to send someone out and reevaluate. Council Members Galloway, Wiseman, Holm, Ellis, Sekula-Gibbs and Berry absent.

Council Member Garcia stated that in regard to the comments the Heights had a lot of alleys and this brought to mind a discussion he was having with Mr. Norman on culverts and he felt it needed additional discussion; that he had someone with a cratering culvert and the policy was it was his responsibility to repair but he did not have the money for repairs on the drainage system so he would probably fill it with dirt or sand and that would impede the drainage and then they would have flooding. Council Members Galloway, Wiseman, Ellis, Sekula-Gibbs and Berry absent.

Mr. Moses Villalpando, 314 Lindale, Houston, Texas 77002 (713-699-4475) appeared and stated that Council Member Ellis's remarks to use HPD to attack the legal status of immigrants was in poor taste; that it was a political move for him, but consequences he started were troubling; that they should go after the coyotes instead of the immigrants, should every Hispanic looking person be questioned on residency, this was a Civil Rights violation; and urged Council Members to not use local services for something which was a federal issue. Council Members Galloway, Wiseman, Ellis, Quan, Sekula-Gibbs and Berry absent.

Council Member Edwards stated that when she first heard of this she thought of apartheid South Africa where everyone would have to carry a pass to show they were citizens of this country and then what happened if you did not have you pass; that it was a slippery slope and

she could not agree with him more; that if someone committed a crime and they were arrested then their immigrant status would be verified during that process; and would this be for immigrants from Britain, Ireland, Scotland and Canada or just Mexico; that if this was done police would be put into a dangerous situation and her issue on this was that if there was an immigration problem then there was an Immigration Service which needed to speak to the issue and not HPD. Council Members Galloway, Wiseman, Holm, Ellis, Quan, Sekula-Gibbs and Berry absent.

Council Member Alvarado stated that she could not agree with him more, the City's job was not immigration and she would say Houston police officers had enough to do and she would rather see them fighting crime; that the whole issue of Minute Men was not welcome here in Houston; and as Council Member Edwards stated if people wanted immigration reform then they needed to call their members of Congress; that here at this table they had been very cautious about resolutions, what was passed and what they did intervene in and this was a federal issue and best left to Congress to deal with. Council Members Galloway, Wiseman, Holm, Ellis, Quan, Sekula-Gibbs and Berry absent.

Council Member Garcia stated that having been on the streets and having understood issues confronting law enforcement officers over the years and racial profiling being the most recent they had advanced so much in law enforcement; and the vision he had was officers could randomly walk in the room or mount buses and start looking for documents and it would be a different country; that people thought crime would stop but it would not, crime was here before and it would still be here; that they should focus on local law enforcement and let federal agencies do their job. Council Members Galloway, Wiseman, Holm, Ellis, Quan, Sekula-Gibbs and Berry absent.

Council Member Khan stated that society was better off because of people like him and he thanked him and asked him to keep it up; and he thanked Mayor White for his response; that it was very easy to go onto the slippery slope of dividing the community and they would not expect immigration officers to come and do police work. Council Members Galloway, Wiseman, Holm, Ellis, Quan, Sekula-Gibbs and Berry absent.

Upon questions by Council Member Edwards, Mayor White stated that maybe they should consider an ordinance where a whole part of the city could petition to remove the police force and they would have them do something else, but he did not think there would be many takers; and part of his remarks which had not gotten lost was their hands were full running the city and he could not run the state, country, etc., it was a federal issue; and as one human being to another he hoped if someone found more money to demote to immigration issues they would first go after some of the ruthless coyotes and others, he could not forget what happened in Victoria; and people were stripped of all their worldly goods by people who prayed on people and if there were more recourses he hoped they would be targeted and not the victims. Council Members Lawrence, Galloway, Wiseman, Holm, Ellis, Quan, Sekula-Gibbs and Berry absent. (NO QUORUM PRESENT)

Ms. Kefflyne Harrington, 6419 Dellfern Drive, Houston, Texas 77035 (713-723-6021) appeared, presented information and stated that she was present regarding Agenda Item 19, funds allocated for playgrounds; that she was CEO and president of the Playa's Institute, a non profit organization which administered to needs of the inner-city community; that the notion of playground equipment within the district was an excellent suggestion they would like to respectfully offer an alternative solution which they thought would better reflect the diversity in the district and in lieu of equipment build a new community center park which provided basketball, soccer and walking trail; that she would like to offer classes and promote the joy of learning by teaching fundamental life skills and focus on academic classes. Council Members Galloway, Wiseman, Holm, Garcia, Ellis, Quan, Sekula-Gibbs and Berry absent. (NO QUORUM PRESENT)

Mayor White thanked Ms. Harrington for coming and sharing her information. Council Members Galloway, Wiseman, Holm, Garcia, Ellis, Quan, Sekula-Gibbs and Berry absent. (NO QUORUM PRESENT)

Ms. Mamie Ndawah-Massauoi, 7261 Chasewood Drive, Missouri City, Texas 77489 (281-835-0554) appeared and stated that she was present representing the Second Chance Youth Center, a new organization of which she was the founder, and the purpose was to cater to ex-offenders; that they were dedicated to change ex-offenders and at-risk youth into productive citizens offering GED training, etc., and hoped the City of Houston would be able to help, there were many vacant houses and they needed a facility. Council Members Galloway, Wiseman, Holm, Garcia, Ellis, Quan, Sekula-Gibbs and Berry absent. (NO QUORUM PRESENT)

Upon questions by Council Member Edwards, Ms. Ndawah-Massauoi stated that the program was for parolees and people on probation along with people who had not yet gone into the system; and Council Member Edwards stated that you could not mix those populations so was she looking at separate facilities; and Ms. Ndawah-Massauoi stated that she was correct you could not have a residential facility for parolees in a residential area, she was referring to buildings; and Council Member Edwards stated that Over the Hill worked with ex-offenders and she believed it was in Council Member Alvarado's district, but it had been in the Third Ward for at least 30 years and they did such programs and may be beneficial in helping her, but she would like to speak with her about the program she was trying to run, it was very competitive and they were now more stringent on requirements for people running such type groups; and Ms. Ndawah-Massauoi stated that would be appreciated. Council Members Galloway, Goldberg, Wiseman, Holm, Garcia, Ellis, Quan, Sekula-Gibbs and Berry absent. (NO QUORUM PRESENT)

Mr. E. J. Agbonayinma, 8303 Southwest Freeway #202, Houston, Texas 77074 (832-746-3389) appeared, presented information and stated that he was present in support of Houston Media Source; that he had interviewed the Mayor and some Council Members and had the opportunity to educate the community; and urged a vote in their favor. Mayor White, Council Members Galloway, Goldberg, Wiseman, Holm, Garcia, Ellis, Quan, Sekula-Gibbs and Berry absent. Mayor Pro Tem Alvarado presiding. (NO QUORUM PRESENT)

not consider that and he asked that they look at realities, where there was a high school there or not if people were being hit by cars they needed to consider that as a place where they might need to put a speed zone, and Mayor White stated that he knew Council Member Khan had expressed concern about Lee High School, as well as other people, that there may be places where they should have crosswalks, that they had to be thinking about the full range of options they had to make things safer, that there were going to be more and more places in the City where they wanted to be both pedestrian friendly and have mobility where they would be needing to look for crosswalks and what the cost of that was and where they fit into the overall CIP Program.

Council Member Ellis absent.

Mayor White stated that they had seen this come up at least three or four times in the last four or five weeks and there ought to be a way that they would have contract language that said if it came in over a million, depending on the amount, then people would know what rules applied.

MATTERS TO BE PRESENTED BY COUNCIL MEMBERS

Council Member Goldberg stated that last week Lakewood Church dedicated the Compaq Center and it became a church and it was a great opening and ceremony attended by the Governor of Texas and Ms. Nancy Pelosi, a Member of Congress, that it was going to be called the Central Campus and was a beautiful facility and one that he thought would attract a lot of people to the City of Houston, that he congratulated Joel and Victoria Olsteen. Council Members Lawrence, Khan, Ellis, Green and Berry absent.

Council Member Goldberg stated that Council Member Galloway brought up an issue that he thought bared looking into, that they had a situation similar where TXDOT was working on Shepherd, they reconstructed the street and also did the sidewalk, that the City was responsible for sidewalks and the City paid TXDOT to do the sidewalks yet they did not do it, they claimed that the City's design did not meet ADA qualifications and were not sure they did, yet the City paid them and there needed to be a reconciling of money because they owed the City \$800,000 and had not paid the money back for not doing the sidewalks, and in addition to that there was a punch list that was an argument between Public Works and TXDOT whether or not they finished the punch list, that he had asked the administration and F&A to look into the accounting, \$800,000 was a lot of money, and if they were due that money they were supposed to get it back. Council Members Lawrence, Khan, Ellis and Green absent.

Council Member Goldberg stated that they had formed Planning Commission committees and he did not have a very good understanding of the new committees and asked if the meetings were to be held in public, were they to find out what their agenda was because he was told of meetings they had on issues in their district and he had no notice of it, that they claimed it was on their website and that was their notice and he did not think that was enough and thought that at least they should notify Council Members of what their agendas were going to be and it should be open to the public, that they were making a lot of policy decisions that the Council Members did not have input and did not even know about, that he hoped they would give them better notice. Council Members Lawrence, Khan, Ellis and Green absent.

Council Member Goldberg stated that he wanted to congratulate one of the constituents in District C, Mr. Allen Wagharter went above and beyond the duty of a normal constituent and it had to do with bandit signs, that the signs were being put up in the esplanade so he took pictures of the guy who did it and got the prosecutors to prosecute the case and showed up in court and presented the judge the pictures and testified and was able to get a conviction, that he did it all on his own time. Council Members Lawrence, Khan, Ellis and Green absent.

Council Member Goldberg stated that he wanted to remind them all that the Telecom Bill was still up in the Legislature and they really had to keep track of it, that he thought it would really hurt the City if it passed and hurt their franchise revenue, that it was now called House Bill 1379. Council Members Lawrence, Khan, Ellis and Green absent.

Mayor White stated that both houses did pass the special session and during the session one company hired 120 lobbyists, over the opposition of municipalities, they wanted to use public streets for free, but then the final issue they were able to reconcile. Council Members Lawrence, Khan, Ellis and Green absent.

Council Member Goldberg stated that he was glad to see Mayor White's response to an investigative report on Channel 2 regarding the scanners, that they talked about the fact that the

City could get scanners for free to scan pets in BARC for microchips, that he thought statewide 5,000 pets were identified with chips and rescued and returned to their owners. Council Members Lawrence, Khan, Ellis and Green absent.

Council Member Goldberg stated that he wanted to congratulate the West University Place Little League Challenger Division, that they were invited by the President to come to the White House and play tee ball, that it was a great opportunity for them and the trip was free for the players and their families and they got to attend a Houston Astros game against the new Washington Nationals and got an autographed baseball from the President and had their picture taken with him, and there were some Hall of Fame All Stars there, that he wanted to congratulate the team players and their team manager, Bobby Lapin. Council Members Lawrence, Khan and Green absent.

Council Member Wiseman stated that with respect to TXDOT and their ability or inability to work with the City, they had a situation in Kingwood along Highway 59, that they were hearing from constituents complaining about the situation, they could not get onto the freeway from Kingwood right now, they either had to go up to Porter or down to Humble, the traffic jams were becoming a nightmare, there was a section of the feeder road that was down to one lane, that she would like to see if they could work together to attempt to reason with TXDOT with what they were doing, that she feared the worse with respect to emergency response if the emergency response units could not get through that traffic, that she thought a very easy temporary on ramp could be done, and Mayor White asked Mr. Norman, Public Works, if somebody could report back to him, that he needed somebody to look at the specifics on that. Council Members Lawrence and Green absent.

Council Member Wiseman stated that yesterday the United States returned to space, that she could not have been more proud and everything went off very well, that she wanted to thank her colleagues on Council who were present to join them in the moral support and celebration of the wonderful staff at Johnson Space Center, Council Members Garcia and Holm. Council Members Lawrence and Green absent.

Council Member Galloway stated that she had some concerns as it related to some constituents in her area as well as some organizations that she belonged to, that a group of people toured the Harris County Jail and they found out during the tour that it was noted about the over crowding and her question was if the fire inspectors inspected all buildings including the County buildings and jails for fire hazards as it related to occupancy, and Mayor White stated that he knew there were some public facilities which they did not, but he would find that out for her. Council Members Lawrence and Green absent.

Council Member Galloway stated that she had an outcry in her community, especially in the older neighborhoods, about the market rates for their properties at the appraisal district, that it seemed some of it was not fair and the market rate was really going up, that many places were tripled and there was no selling or buying in the various communities, that she had some great concerns about that and did not know what they as a City could do, that they were thinking about putting in a jurisdiction protest because it was in the older neighborhoods. Council Members Lawrence and Green absent.

Council Member Edwards stated that she wanted to congratulate her grandson, Nosacaray, who was 13 years of age, that he had the opportunity to join the Houston City Slickers Soccer Team and in the first game he scored two goals, that she was proud of him. Mayor White and Council Members Lawrence and Green absent. Mayor Pro Tem Alvarado presiding.

Council Member Edwards stated that she wanted to salute the North Montrose Community, especially the civic association, who celebrated their 25th anniversary last night. Mayor White and Council Members Lawrence, Goldberg, Khan and Green absent. Mayor Pro

Tem Alvarado presiding.

Council Member Edwards stated that she was handing out some cards, that Mr. Gene Moore Jr. at Saint Agnes Church, in District D, had been producing the celebration for 5 years, that his average attendance was about 5,000 to 6,000 young people, that it was a two day function, that it was entertainment and seminars where they gave them information about voting registration and health awareness and a lot of things that their young people did not get access to and this year they were looking to have 10,000 young people at Saint Agnes Church, that she wanted to congratulate Mr. Moore and the young ministers that he worked with across the State, that the Power of Life Celebration would be Friday and Saturday, July 29 and 30, 2005 at Saint Agnes Church located at 3730 South Acres Drive. Mayor White and Council Members Lawrence, Galloway, Goldberg and Green absent. Mayor Pro Tem Alvarado presiding.

Council Member Edwards stated that the second Montrose Task Force meeting regarding the homeless and conditions in the Montrose area would convene tomorrow night, Thursday, at 6:30 p.m. at the West Gray Multi Service Center, 1475 West Gray, that they were encouraged and really impressed with the work that this community task force was doing to bring solutions to the problems and challenges they were facing in the Montrose area. Mayor White and Council Members Lawrence, Galloway, Goldberg and Green absent. Mayor Pro Tem Alvarado presiding.

Council Member Edwards stated that one concern she had was that there were a lot of streets in District D that were occupied by long term renters, that people had rented properties for 30, 40 and 50 years and also large apartments in District D, that they had a lot of apartment dwellers, and they did not have the right to participate in getting their streets repaired because they were not the property owners, that she would like to work with someone to look at how they could amend that ordinance, so that long term renters could have the opportunity to speak to the condition of their streets and be part of the solution of getting the streets fixed. Council Members Lawrence, Galloway, Goldberg, Ellis and Green absent.

Council Member Edwards stated that the furor that was started by the Supreme Court with their ruling on the eminent domain situation and the subsequent bill that was passed in their Legislature regarding that, she was told by a State Representative that the eminent domain bill they passed exempted the State of Texas and the Texas Medical Center and she would like for someone to find out if that was the case and why would they be exempt. Council Members Lawrence, Galloway, Goldberg, Ellis and Green absent.

Council Member Garcia stated that he wanted to share his comments, prayers and excitement with the astronauts, that it was a special moment for him, that he was with his daughter and as they were watching the launch it occurred to him that she was watching some great American history, that during the launch the room fell silent and everybody was very emotional, that he wanted to congratulate those brave men and women on Discovery. Council Members Lawrence, Galloway, Goldberg, Ellis and Green absent.

Council Member Garcia stated that while the Astros were in Washington, D. C. playing the Nationals they took time out of their busy schedule to visit the recently wounded veterans. Council Members Lawrence, Galloway, Goldberg, Ellis and Green absent.

Council Member Garcia stated that he was saddened by the fact that there was a young life lost to a drowning but was particularly impressed and motivated by the Public Works employees who tried to save that life, the Public Works employees were Raymond Johnson, William Young, Gerald Lamar, Clifton Jones and Gregory Tuft , that it was Clifton Jones and Raymond Johnson were the two who worked to administer CPR and first aid to the child, that he wanted to thank them for doing the right thing and jumping at the opportunity to try to save a life. Council Members Lawrence, Galloway, Goldberg, Ellis and Green absent.

Council Member Holm stated that for the last several months there had been a street parking issue in District G that the Planning Department and her office had tried to address, that she thought several years ago there was an ordinance passed to protect residential communities from a surrounding commercial areas or a school area and they created the Residential Parking Ordinance and right now that was the only tool they had, that she wanted to recommend that they look at expansion and reevaluating those parking ordinances, that she had talked a little bit to the new director and she was also willing to embrace it. Council Members Lawrence, Galloway, Ellis and Green absent.

Mayor White stated that the Mayor Pro Tem had been working with a variety of stakeholders and Ms. Rambo to create a new institutional structure that would allow them to address the issue and as a result he knew there was an ordinance that had been or would be drafted which he thought was due to go to Chairman Berry's committee on August 11, 2005. Council Members Lawrence, Galloway, Ellis and Green absent.

Council Member Holm stated that last week at the TPC meeting one of the things that they mentioned was the I-45 plan and expansion of that, that over and over again she thought that one of the things that they saw it was not necessarily the plan sometimes but the process, that Council Member Garcia who also served as an alternate on the TPC was present and offered to be of assistance and she thought it was a real key opportunity for the City to be the facilitator as the elected person to represent the people as they moved forward, that she hoped the Mayor would really encourage with TXDOT that the City play more of a role; that she also wanted to say that with Metro, Mr. Frank Wilson was in the meeting two night ago with Afton Oaks and he had openly embraced the fact that sometimes it was not the plan but the process. Council Members Lawrence, Galloway, Garcia, Ellis and Green absent.

Council Member Holm stated that she wanted to thank Mayor White for embracing and taking the leadership on a new designation in their Historical Preservation Ordinance, that they had gone through a process to designate what was going to be called a protected landmark which gave a property owner the choice of permanently protecting their property so that it could be sustained if it met certain criteria, that it went through the Quality of Life committee for discussion and last week it went before the Houston Archeological and Historical Commission and was unanimously supported and tomorrow it would go before the Planning Commission and shortly thereafter it would come back before Council for approval. Council Members Lawrence, Galloway, Garcia, Ellis and Green absent.

Council Member Holm stated that yesterday she did share in mission control with her colleagues, Council Members Wiseman and Garcia, and it was a powerful experience, that they wished God speed to the crew and on their journey, and at the same time they had in the Medical Center in the last two weeks Texas Childrens Hospital was named the fourth out of the top ten facilities for it's work with children and it's leadership, medical staff and community and M.D. Anderson was again rated in the top two for the work it did. Council Members Lawrence, Galloway, Garcia, Ellis and Green absent.

Council Member Alvarado stated that as to the parking issue Council Member Berry agreed to hold the ordinance, they did have a final draft of the ordinance and they were trying to schedule meetings with Council Members prior to that meeting on August 11, 2005 their prompt response would be greatly appreciated. Council Members Lawrence, Galloway, Garcia, Ellis and Green absent.

Council Member Alvarado stated that she wanted to welcome the Texas Association of Mexican American Chambers of Commerce, known as TAMAC, they were holding their annual convention in Houston and they would have for the first time a Houston Hispanic female who would be sworn in as the Chair for the organization so they would salute Ms. Paula Mendoza and she invited all of them to attend some of the festivities that would be taking place, that they could contact her office or Council Member Garcia's office for that. Council Members Lawrence,

Galloway, Garcia, Ellis and Green absent.

Council Member Alvarado stated that she wanted to congratulate the Dixie Little League and the Magnolia Little League in her neighborhood, they were formed to put together a 15 year old and 16 year old league and they were playing in Tyler, Texas today to compete in the State sectionals and they wished them luck, they were coached by HPD Officer Chris De Alejandro. Council Members Lawrence, Galloway, Garcia, Ellis and Green absent.

Council Member Alvarado stated that she was saddened to hear of the passing of Mr. Rafael Fleagal, the former concert master of the Houston Symphony for the past 25 years and also served as a member of the Music Faculty at the University of Houston, Houston Baptist University and Rice University, that her condolences went out to the family. Council Members Lawrence, Galloway, Garcia, Ellis and Green absent.

Council Member Sekula-Gibbs stated that the 15th Annual Houston International Jazz Festival would be co-chaired by herself and Council Member Berry and Congresswoman Shiela Jackson Lee, that there would be some excellent music played by junior high and high school students who were delightful and very talented, that it would be on Sunday, August 7, 2005, from 11:00 a.m. to 1:00 p.m. at the Wortham, that if they were interested they could contact Willie Fontenot at 713-520-5920, that it was masterminded by Mr. George Thomas, General Manager of The Choice, KTSU, 90.9 Radio. Council Members Lawrence, Galloway, Goldberg, Holm, Garcia, Ellis and Green absent.

Council Member Sekula-Gibbs stated that on Saturday, July 30, 2005, they would have the Alief Health Fair and Resources Fair for the civic community at 7720 Boone Road at Notre Dame Catholic Church from 9:00 a.m. to 2:00 p.m., for more information they could contact her office. Council Members Lawrence, Galloway, Goldberg, Holm, Garcia, Ellis and Green absent.

Council Member Sekula-Gibbs stated that Houston would be honored to be hosting Dr. Elizabeth Duke who was the administrator for HERSA, Health Resources and Services Administration, that it was a very important opportunity for Houston to showcase the need that they had in terms of health requirements, that she would be at the Hyatt Regency at 7:30 a.m. for a breakfast and then they would have a news conference with her at the Houston Community Health Center, the Denver Harbor Clinic, in the La Roca Church area on Halo at 10:00 a.m. and they could contact her office for further information. Council Members Lawrence, Galloway, Goldberg, Ellis and Green absent.

Council Member Khan stated that he wanted to thank the Parks Department and Director Joe Turner, they were holding a community meeting tonight for Boone Road Park development at Notre Dame Church at 7720 Boone Road at 7:00 p.m. Council Members Lawrence, Galloway, Goldberg, Ellis and Green absent.

Council Member Khan stated that they would have the Alief Health Fair would be on Saturday, that he wanted to acknowledge the effort of the Alief Super Neighborhood Council who had been working very hard, that they could go to www.AliefSuperNeighborhood.org to get more information. Council Members Lawrence, Galloway, Goldberg, Wiseman, Ellis and Green absent.

Council Member Khan stated that there was a story in the Chronicle today, that it was a marketing effort by Alief ISD, that they enrolled about 46,000 students in Southwest Houston and was the most diverse school district in the City, that the marketing theme was "Alief, a Great Place to Learn", that he wanted to thank Alief ISD Superintendent, Mr. Louis Stoner and all the people who were involved in the marketing campaign to boost the image of Alief. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Khan stated that a construction company who was doing a lot of projects

around the City, CTI, had filed for bankruptcy and one of the projects they were working on was the Dunlap project and those neighbors were very frustrated because all the work was started and left in the middle, that there were safety and flooding concerns, that he wanted to thank Director Marcotte who would be joining him to hold a public meeting on August 4, 2005 to address the concerns of the neighborhood, that they would also be addressing what were the efforts for completing the project and what was the timeline for the completion, that it would be at Bayland Community Center, located at 6001 Bissonnet at Bayland Park. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Khan stated that a lot of people were trying to improve the image of the Gulfton area, that Neighborhood Centers started a newsletter promoting the Gulfton area and the first addition had a story on Dr. Azave who had a clinic on Hillcroft in the Gulfton area and they were doing a lot of good things and that was where the new multi service center was going up also, that it would really improve the image of Gulfton. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Khan stated that their C3 cleanup was scheduled for August 30, 2005. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Khan stated that Police Chief Hurtt had agreed to do another townhall meeting on crime, that it would be on September 19, 2005 at Nortre Dame Church. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Quan stated that yesterday at their Neighborhood Housing and Redevelopment committee meeting one of the things that passed through the committee was the action by the Houston Airport System, that Mr. Cherry, Cherry Demolition, had come before Council previously and talked about the fact that they had a number of homes on property that the airport was acquiring that were being demolished and that those homes could in fact be used to address affordable housing issues, the Houston Airport System had worked closely with them and had now made the homes available to community development corporations for a cost of \$1 each, they had a meeting scheduled for interested CDCs to go over the potential homes to see about moving them to property and lots where they could really help the community, that he wanted to commend HAS for their efforts. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Quan stated that community leader Mr. Lupe Fraga had recently been appointed to the Board of Texas A&M University and a reception was being held for Lupe this evening, that he had been a great contributor to the community. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Quan stated that on Friday night his second daughter, Chrissy Quan, would get to throw out the first pitch at the Astros game. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Quan stated that on August 2, 2005, would be the National Night Out and hoped that many neighborhoods around the City would participate in that. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Quan stated that he wanted to mention the passing of a real sweet community woman, Ms. Vera Kline, that she was very active in Southwest Houston, Southwest 2000 and was a docent for the Holocaust Museum, that she and her husband Ike served the community for many years. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Berry stated that Item Numbers 20 and 21 were requested to be untaggable, that he would hope that the word would go forth and thought it had to come from

Mayor White, that whether it was Purchasing or one of the individual departments, that they took it seriously, that typically they had been working on those things for six months, that it forced them to cram for the exam. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Berry stated that Thursday, July 28, 2005 was the TIA committee meeting and it would be on the Airport Duty Free Concession at George Bush Intercontinental Airport. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Berry stated that there was a nice story in the Houston Chronicle about Council Member Garcia and thought it was a model for all of them about the cleanup work that he was doing in his district as part of the 3C effort, that he had created community alliance for responsibility, empowerment and safety, that he used campaign funds to buy a tractor, shovels, safety glasses and other essentials and used Harris County Probation community service volunteers and offered homeless clients at the Open Door Mission on Harrisburg a letter of recommendation for perspective employers in exchange for their help. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Berry stated that Chief Lumpkin was doing a great job in a new department and was doing it on the backs of really good people in his department, that they called Inspector Michael La Chapelle about a house that was in bad shape and he managed, using probationers, to get the grass cut, that they appreciated it. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Berry stated that they were working on some eminent domain language that they hoped to work with the Legal Department and get their opinion. Council Members Lawrence, Galloway, Goldberg, Ellis, Sekula-Gibbs and Green absent.

Council Member Edwards stated that the Office of the Mexican Consulate General was in her district and they traditionally had a lot of long lines in the area outside, and there was a homeowner in the area that was charging people two dollars to use their bathroom and charging them to make a phone call, that she knew people had the option as to whether or not they wanted to do that, and they had a copy machine that they used and charged exorbitant rates on and her question was when they started charging did it make them a business and did it affect their impact fees as far as water, that it looked bad for the City for a resident to be charging people who were trying to get their lives together, that she needed help in how to handle it, that Ms. Gafrick was working with her on it, that she felt very uncomfortable with that type of activity going on. Council Members Lawrence, Galloway, Goldberg, Wiseman, Garcia, Ellis, Sekula-Gibbs and Green absent. (NO QUORUM PRESENT)

There being no further business before Council, the City Council adjourned at 12:16 p.m. Council Members Lawrence, Galloway, Goldberg, Wiseman, Garcia, Ellis, Sekula-Gibbs and Green absent. (NO QUORUM PRESENT)
