#### City Council Chamber, City Hall, Tuesday, August 20, 2013

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, August 20, 2013, Mayor Annise Parker presiding and with Council Members Helena Brown, Jerry Davis, Ellen R. Cohen, Wanda Adams, Al Hoang, Edward Gonzalez, James G. Rodriguez, Mike Laster, Larry V. Green, Stephen C. Costello, Andrew C. Burks, Jr., C. O. "Brad" Bradford and Jack Christie, D. C.; Mr. Harlan Heilman, Legal Department, Division Chief, Claims & Subrogation Division; Ms. Marta Crinejo, Agenda Director, and Ms. Stella Ortega, Agenda Office, present. Council Members Dave Martin, Oliver Pennington and Melissa Noriega absent on personal business.

At 1:47 p.m. Mayor Parker called the meeting to order and recognized Council Member Gonzalez for the first presentation. Council Members Brown, Davis, Cohen, Adams, Hoang, Rodriguez, Green, Burks and Bradford absent. NO QUORUM PRESENT

Council Member Gonzalez invited Ms. Yumi Kanke and the other guests from the Japan America Society of Houston to the podium and stated that the students were present as part of an annual exchange program between Johnston Middle School and Chiba Middle School, that the City of Houston and Chiba had a Sister City relationship in place since 1972, that while in Houston the students learned about American culture, stayed with local host families and attended classes at Pin Oak and Johnston Middle Schools, that they were joined by Ms. Patsy Brown, Executive Director of JASH. Council Members Brown, Davis, Cohen, Adams, Hoang, Rodriguez, Green, Burks and Bradford absent. NO QUORUM PRESENT

Ms. Brown stated that they were pleased that they had been able to continue the exchange relationship for over 31 years, out of the 40 years that they had been Sister Cities with Chiba, that the international exchange programs based on grassroots activities provided a very unique opportunity for those involved to share their cultures and learn about different cultures, the educational value and enrichment the experience brought was invaluable and had lasting positive influence and sighting interest in international relations, particularly US and Japan relations. Council Members Brown, Davis, Adams, Hoang, Rodriguez, Green, Burks and Bradford absent. NO QUORUM PRESENT

Council Member Gonzalez stated that he had the privilege and honor of visit Chiba in March and it was an amazing City and Country and he really enjoyed the hospitality. Council Members Brown, Davis, Adams, Hoang, Rodriguez, Green, Burks and Bradford absent. NO QUORUM PRESENT

Mayor Parker thanked Council Member Gonzalez for helping present the certificates and stated that they had a very robust relationship with their Sister City of Chiba, but one of the things that had sustained the relationship had been the student exchanges over the years, that when she was in high school and college her family was a host family for Japanese exchange students, she found it a tremendously enriching experience, that she did not get to experience Japan, but certainly appreciated having Japan represented at their dining table and the opportunity to share information about their cultures, and offered greetings on behalf of the City of Houston, and therefore, she, Annise D. Parker, hereby proclaimed today as Chiba Sister City Exchange Program Day in Houston, Texas. Council Members Brown, Davis, Adams, Hoang, Rodriguez, Green, Burks and Bradford absent. NO QUORUM PRESENT

Ms. Yumi presented Mayor Parker with a gift from Mayor Toshihito Kumagai, Chiba City, Japan. Council Members Brown, Davis, Adams, Hoang, Rodriguez, Green, Burks and Bradford absent. NO QUORUM PRESENT

Council Member Gonzalez presented a certificate to Ms. Yumi Kanke, Teacher Chaperone,

for the exchange students from Japan, Ms. Chinami Hirano, Ms. Rina Tamaki, Mr. Takashi Komatsubara, Mr. Daisuke Tarusawa and Hiroki Sakamoto, a Rotary exchange student from Chiba. Council Members Brown, Davis, Adams, Hoang, Rodriguez, Green, Burks and Bradford absent. NO QUORUM PRESENT

Council Member Christi stated that he had been in Tokyo when he was on the State Board of Education and visited the middle school and hoped that they gave to the American students the passion for learning and hard work. Council Members Brown, Davis, Hoang, Rodriguez, Green and Bradford absent. NO QUORUM PRESENT

Mayor Parker invited the Wolves Against Hunger of Saint Francis Episcopal Day School to the podium for the next presentation, Ms. Debbie Harris, Science Department Chair and some of her students, and stated that she found out about the program at the Saint Francis Episcopal Day School a couple of months ago and wanted the opportunity to publicly acknowledge the work that they did, that the Wolves Against Hunger, Saint Francis Episcopal Day School, won the National Lead2Feed Contest, sponsored by USA Today, Young Brands and Lift a Life Foundation, with it's effort to fight global hunger and creating leadership skills for the future, that Wolves Against Hunger of Saint Francis Episcopal Day School were awarded \$25,000 and they presented the money to Kids Meals, a local Houston Charity, which provides 1,700 lunches each day to impoverished young Houstonians, that Wolves Against Hunger, Saint Francis Episcopal Day School, partnered with KLI School of Meerut, India, to work collaboratively on global hunger by collecting canned food, making lunches for impoverished children, creating gardens to give fresh produce to local food banks and sharing research and videos made by the students, and therefore, she, Annise D. Parker, Mayor of the City of Houston, hereby proclaimed August 20, 2013 as Wolves Against Hunger, Program of the Saint Francis Episcopal Day School Day in Houston, Texas. Council Members Davis and Rodriguez absent.

Ms. Harris thanked Mayor Parker and the City Council and stated that the entire student body took on the project of researching hunger, that they were sad to find out that one in six children in Houston went hungry every day, they partnered with Kids Meals, the only meals on wheels that fed children, they did can food drives and established a garden because the food banks of Houston lacked fresh produce, they partnered a school in India and everything that they did they asked the students in India to do, they exchanged data, and at the very end they created an unbelievable video that brought tears to everyone, they entered a contest that was sponsored by USA Today and Yum! Brands Foods, that 1,500 schools around the Nation entered the contest, and this was a group of middle school students and they won first place, the prize was \$25,000, at the end of May they presented a check to Ms. Ruth Zomalt-Burrell and Kids Meals, that was 20,000 meals that children of Houston would now have, and introduced Ms. Holly Plost, Technology Instructor who was their coach and had helped them create the product, and students Mr. Taylor Bowers, Mr. Charles Moreton, Ms. Miranda Slaton and Ms. McKenna Dishongh. Council Members Davis and Rodriguez absent.

Mayor Pro Tem Gonzalez, Council Members Christi and Burks congratulated the Ms. Harris and the students and thanked them for all they were doing. Council Member Rodriguez absent.

Mayor Pro Tem Gonzalez recognized Mayor Parker for the next presentation. Council Member Rodriguez absent.

Mayor Parker stated that thanks to the great support of their corporate sponsors, the procuring and stuffing of multiple backpacks, they had been able to support not just her back to school fest, but also the work of Council Members in the community, that she wanted to thank the corporate sponsors for the 2013 Back to School Fest, that they had done it for the past three years and started at the George R. Brown Convention Center and last year it was at Reliant and this year they were at the University of Houston and hoped they had found a new permanent

home because the partnership with the University showed that they were not just preparing children for one school year, they were working to prepare them for a lifetime of education, that they could not do it without hundreds of volunteers or the dollars from their corporate underwriters who helped secure the backpacks and the supplies, that they had dozens of organizations presented to the back to school fest and did everything from immunizations to vision screenings, dental health, uniform vouchers, and on and on, but all designed to make sure that every child in Houston started that first day of school well prepared, and thanked The University of Houston and Dr. Renu Khator, Ms. Glenda Regenbaum, Executive Vice President, First Service Residential Texas, who had helped underwrite the program each year and could not be present today, Director Katy Tipton, Department of Neighborhoods, Mr. Nelson Espitia, Division Manager, Department of Neighborhoods, Mayor's Office of Special Events, Ms. Susan Christian, Kroger, and Shell Oil and Motiva Enterprises, partners in the effort.

At 2:10 p.m. Mayor Parker recognized Council Member Gonzalez for the invocation and pledge of allegiance. Council Member Davis absent.

Council Member Gonzalez invited Dr. Terry Leon Preston, II, Pastor, Yale Street Baptist Church, for the invocation and Council Member Gonzalez led all in the pledge. Council Member Davis absent.

At 2:12 p.m. the City Secretary called the roll. Council Members Martin, Pennington and Noriega absent on personal business.

Council Members Gonzalez and Burks moved that the minutes of the preceding meeting be adopted. All voting aye. Nays none. Council Members Martin, Pennington and Noriega absent on personal business. MOTION ADOPTED.

Mayor Parker recognized Council Member Burks for a procedural motion.

Council Member Burks moved that the rules be suspended for the purpose of hearing from Ms. Tomaro Bell at the top of the three minute non agenda speakers list, seconded by Council Member Costello. All voting aye. Nays none. Council Members Martin, Pennington and Noriega absent on personal business. MOTION 2013-0570 ADOPTED.

Council Member Gonzalez moved that the rules be suspended for the purpose of adding Mr. Carlos Doroteo to the three minute non agenda speakers list following Ms. Tomaro Bell, seconded by Council Member Hoang. All voting aye. Nays none. Council Members Martin, Pennington and Noriega absent on personal business. MOTION 2013-0571 ADOPTED.

Council Member Rodriguez stated that he wanted to recognize former Council Member Brenda Stardig, who had been present in the audience, but thought that she had left and wanted to say hello to his former colleague.

Dr. Alkebu Motapa, 5022 Crosby, Houston, Texas 77021 (713-741-5150) had reserved time to speak, but was not present when his name was called.

Mr. Shannon Foshee, 13110 Indianapolis, Houston, Texas 77015 (832-907-6426) had reserved time to speak, but was not present when his name was called.

Ms. Tomaro Bell, 3248 Charleston, Houston, Texas 77021 (713-825-8449) appeared and stated that she was present on Chapter 9, that yesterday Council Member Costello came to a super neighborhood meeting and let them know where they were on Chapter 9, that he brought up some changes they were looking at, a fee in lieu of detention, that they had a deep concern about a paragraph in Chapter 9 which said if a developer came in and built a property on an

adjacent property, next to a residence or other structure, that they could not elevate their property and cause flooding on the other side, there was nothing about enforcement, about sanctions if they did that, that it was happening in Montrose, Heights, Fourth Ward and Third Ward, there needed to be some kind of ordinance to go along with this and say what the sanctions were going to be if they violated, that someone from PWE called to see what she was going to talk about on Chapter 9, because he said that if PWE noted it and they build it they could make them tear it down, they needed to see some teeth, not just words put in an ordinance, they did not have enough staff to go around and look at everybody and make sure they did what they were supposed to do or make sure when it was finished that they did, that she was extremely disappointed and concerned about Little Audrey's Place on Southmore, that it needed to be dealt with, that she wanted to make sure that she noted that the place had federal monies waiting for it, that it was needed.

Mayor Parker stated that the Little Audrey's issue, there was federal money that was waiting, but they had to do certain things, which they had not done and did not appear capable of doing and she had shared that with the Congresswoman for the area and they were working with them, but they had not met the standards and they had to figure out what they did going forward, they recognize the need, but were not going to put money in a place that could not handle the federal requirements.

Upon discussion and questions by Council Members Brown, Green and Costello, Council Member Green stated that he was hearing that there was a meeting whereby changes to Chapter 9 were discussed with the community and he asked if Council had an opportunity to look at it and Mayor Parker stated that it was gong to Council Member Noriega committee at the appropriate time, and Council Member Costello stated that they would have a committee meeting long before it came before Council for adoption, that they did not get to adopt the criteria, it was a design manual, but they would have ample time for comments during the committee meeting, and Council Member Green asked if he could send it out concurrently to Council Members so when they started getting phone calls from the super neighborhoods with regard to what was gong on and the recommendations so they would have an opportunity to respond other then waiting for the actual hearing, that this was the first he was hearing of this, and Council Member Costello stated that the only issue that was outstanding was the fee in lieu of for individual lots, that he would be happy to provide it to Council Member Green.

Mayor Parker stated that they did have the public hearing process, the document was publicly available, this was a request for an amendment, which the administration had not adopted, they were trying to be as transparent as they could, that they posted the document on the City's website for all to see, and Council Member Costello stated that this process had been going on for about 18 months, and the last draft was on Public Works website, they had not presented it formally to the committee and Council because there were one or two other issues they wanted to do to the draft to make sure that what they all saw was the draft.

Council Member Bradford moved that the rules be suspended for the purpose of extending time for questions of Ms. Tomaro Bell, seconded by Council Member Costello. All voting aye. Nays none. Council Members Martin, Pennington and Noriega absent on personal business. MOTION 2013-0572 ADOPTED.

Mayor Parker stated that nothing had changed, that was the document as it was, this was a new issue that had come up, it had been discussed with the Super Neighborhoods and they were trying to start from the neighborhoods and bring it up rather than from the top down, that it would go to Council Member Noriega's committee, that they did not have a date, and Council Member Costello stated that they were still waiting on some responses from the neighborhood group and hoped to have something where they would give everyone about a thirty day review period before they had the committee meeting. After further discussion by Council Members Adams and Costello, Council Member Costello moved that the rules be suspended for the purpose of extending time for questions of Ms. Tomaro Bell, seconded by Council Member Laster. All voting aye. Nays none. Council Members Martin, Pennington and Noriega absent on personal business. Council Members Gonzalez and Burks absent. MOTION 2013-0573 ADOPTED.

After further discussion by Council Members Costello and Green, Council Member Green asked if he was hearing that the manual for the most part took care of what they needed, they just did not have the resources or the manpower to actually implement or to monitor, and Council Member Costello stated that was the concern of the community, that they did a lot of development in the City of Houston and on occasions they did have those problems. Council Member Gonzalez absent.

Mayor Parker stated that as long as Council Members understood these were meetings between a Council Member and members of the Super Neighborhood Council, just as any Council Member could have meetings, that the official City position had not changed, it was on the website, but because of neighborhood interest there were still a lot of conversations going on and if there was a concrete proposal they would share it immediately with all Council Members. Council Member Davis absent.

After further discussion by Council Member Bradford, Mayor Parker stated that she misspoke, it was a public comment period, there was a formal public comment period afterward and there was testimony given. Council Member Davis absent.

Council Member Bradford moved that the rules be suspended for the purpose of extending time for questions of Ms. Tomaro Bell, seconded by Council Member Gonzalez. All voting aye. Nays none. Council Members Martin, Pennington and Noriega absent on personal business. Council Member Davis absent. MOTION 2013-0574 ADOPTED.

After further discussion by Council Members Bradford and Burks, Council Member Brown moved that the rules be suspended for the purpose of adding Ms. Christina Walsh to the three minute non agenda speakers list following Mr. Carlos Doroteo, seconded by Council Member Bradford. All voting aye. Nays none. Council Members Martin, Pennington and Noriega absent on personal business. Council Member Adams absent. MOTION 2013-0575 ADOPTED.

Mr. Carlos Doroteo appeared, passed out a handout and stated that he used to work for City Council and had worked at the State Legislature and was present to bring to their attention an organization that he had started, along with other citizens of Houston called "Citizens Empowered", that it was about trying to empower people and trying to perfect this thing called "democracy", that about a year ago they thought about ways they could do so they came to them today with ten policy proposals that tried to achieve that, try to maximize citizens participation and reviewed a document titled "Declaration to Perfect Our Democracy", a copy of which is on file in the City Secretary's office for review. Council Members Adams and Burks absent.

Ms. Christina Walsh appeared and stated that at this particular time the presentations regarding Chapter 9 had been in one direction, the public had submitted comments but they had not received feedback on the comments, that they were hoping that at some time there would be an exchange, that she would tell them two top concerns, one, if they were going to build a street and put detention, while they were in there it was more economical to go ahead and put in five year service instead of two year service, second, regarding grandfathering, there was an understanding that grandfathering was gong away. Council Members Adams and Burks absent.

Council Member Brown moved that the rules be suspended for the purpose of extending time for questions of Ms. Christina Walsh, seconded by Council Member Bradford. All voting aye. Nays none. Council Members Martin, Pennington and Noriega absent on personal business. Council Members Adams and Burks absent. MOTION 2013-0576 ADOPTED.

After discussion and questions by Council Members Green, Bradford and Costello, Mayor Parker stated that to clarify there was no public hearing requirement, they had a public comment period, and it was something that would be adopted by Public Works and she would sign off on, they were keeping the process open because there was still a fairly robust dialog, they were not trying to surprise anybody, it would come to a full Council committee for a vetting of the issues. Council Members Adams and Burks absent.

Mr. John Cieslewicz, 1250 DuBarry Ln, Houston, Texas 77018 (713-906-1725) appeared and reviewed a handout which he had passed out to the Council Members regarding existing storm water drainage in the subdivision and swales behind the properties, that both the Mayor and Public Works had acknowledged these drainage swales, that the only drainage ditches were the swales, that the City was using a 1970 building code to illegally acquire uniform storm water drainage in it's older neighborhoods. Council Members Hoang, Rodriguez, Burks and Christi absent.

Council Member Laster stated that Mr. Cieslewicz had come to City Council many times and asked Mayor Parker if the City was meeting with him on this particular issue and what was the City's approach to this ongoing question about the drainage in his neighborhood, there appeared to be significant differences of opinion, and in talking with some other folks believed that there may be something to the claim. Council Members Davis, Adams, Hoang, Rodriguez, Burks and Christi absent. NO QUORUM PRESENT

Mr. Harlan Heilman, Legal Department, stated that they had responded to Mr. Cieslewicz on a number of occasions, laid out their position, and they disagreed with him, that the swale he was referring to was not a drainage easement, it was back to front drainage, curb and gutter, they had a disagreement and staff members had visited with him and communicated in writing, that he did not know what else they could do, that they felt very good about their position and disagreed with his statement that this was a drainage easement, the documents referred to a communal waste, that would seem to imply that was a sanitary issue, and Council Member Laster asked if it was possible that even though the official documentation on the swale could have actually had a drainage use possible, and Mr. Heilman stated that anything was possible, and Council Member Laster asked if the neighborhood relied on that drainage use purpose over a number of years, without it being a specific dedication, and Mr. Heilman stated that he did not know, and Council Member Laster asked if those things were possible if they changed the nature and use of the swale they might be changing the nature and use of the drainage purposes of which the neighborhood relied, was that possible, and he asked the question because this gentleman came to Council month after month and it seemed to him that there seemed to be something more than just a legal question, there seemed to be some issues in the neighborhood about drainage, and asked Mr. Cieslewicz if the City had met with him in relationship to the drainage issues from a neighborhood perspective or was it just himself. Council Members Davis, Adams, Hoang, Rodriguez, Burks and Christi absent. NO QUORUM PRESENT

Mr. Cieslewicz stated that it happened three years ago, he talked to a City inspector over the phone, and he said that all over the City this was happening, they were required to have back to front drainage, which the City could not prove, that he had applied for open records, if the City had proof that Oak Forest Section One was built with back to front drainage, they had no records, and Council Member Laster asked if his property was flooding now, and Mr. Cieslewicz stated no, they had not had a good rain in over three years, and the last big flood they had was the day after Ike, and Council Member Laster asked Mr. Cieslewicz ultimately what would he like to have the City do, and Mr. Cieslewicz stated that he would like to have storm water drainage, but they could basically run an underground pipe, and Council Member Laster asked if his neighborhood was flooding because of some change that the City had made, and Mr. Cieslewicz stated that it flooded six weeks ago and he gave a flood map to everybody, and Council Member Laster asked if there were other neighbors in the neighborhood who had issues with this, and Mr. Cieslewicz stated that most of his neighbors did. Council Members Davis, Adams, Hoang, Rodriguez, Burks and Christi absent. NO QUORUM PRESENT

Mayor Parker stated that the first time Mr. Cieslewicz came to Council she asked for an individual briefing by Public Works with the engineers, they had sent multiple teams of staff out there, that Council Member Laster was probably correct, it may have been used for drainage at one time, whether it was developed as drainage was different, that she had not nor was she aware of any other communications from anybody else in that neighborhood, that she had not heard from anyone else, and Council Member Laster asked if the City had done something physically in that neighborhood that changed the drainage scope and if so what were they doing to fix it, and Mayor Parker stated no, but there was some new development that had occurred in the neighborhood, that if he was interested please allow her to send the Public Works folks to visit with him. Council Members Davis, Adams, Hoang, Rodriguez and Christi absent.

Mayor Parker stated to Mr. Cieslewicz that they were going to try to bring Council Member Laster up to speed on his issue. Council Members Davis, Adams, Hoang, Rodriguez and Christi absent.

Ms. Josephine Pierce, 1438 Alabama, Houston, Texas 77006 (no phone) had reserved time to speak, but was not present when her name was called. Council Members Davis, Adams, Hoang, Rodriguez and Christi absent.

Mr. John Mitchell, 3525 Sage Rd., Houston, Texas 77056 (713-280-9531) appeared, presented information, and stated that he wanted to do a concert, that he was a product of inner City youth, that he started to do the planning when he was in college and joined a fraternity, that once he got older he did it for profit and it turned out very well, that he reached a stage in his life where philanthropy had become big to him, that he was present because he thought the City was the best partner for this project, that they would like to give away tickets to thousands of youth. Council Members Adams, Hoang and Rodriguez absent.

Council Member Burks asked what type of support did Mr. Mitchell need from the City of Houston, and Mr. Mitchell stated that access, that he wanted the City to partner with him on this event. Council Members Adams, Hoang and Rodriguez absent.

Council Member Green stated that there was an Arts Alliance Board that provided grants and did programming for arts so that would be an application process, if a particular department had an interest in a program or event that Mr. Mitchell was doing then that department would partner with him to do that, that they could try to point him in the right direction. Council Members Adams, Hoang and Rodriguez absent.

Mr. Andrew Dobbs, 3100 Richmond Ave., Houston, Texas 77098 (713-337-4196) appeared, distributed information, and stated that he was the new Director with Texas Campaign for the Environment, that he was present to talk about the One Bin For All Proposal, that the request for qualifications on this proposal came to a close on Thursday, August 22, 2013, and they had ongoing concerns about it and some suggestions on what they thought would be a better path for the sake of the environment, and reviewed the letter that he had handed out. Council Members Davis, Hoang, Rodriguez and Burks absent.

Upon questions by Council Member Christi, Mr. Dobbs stated that incineration technology was very significant, not just in terms of the air pollution problems and the fact that they reopened the loop, so they had to keep drawing new raw materials rather than closing the loop to recycling, that they could get there by extend curbside recycling to everybody and that was what they wanted. Council Members Davis, Hoang, Rodriguez and Burks absent.

Council Member Christi stated that he thought One Bin For All was separation and recycling, and Mayor Parker stated among other things, it was commoditizing the entire waste stream and instead of what they did today, which was a human being made a decision on what to separate, that it was a more of an automated process, that what she would encourage Council Members to remember was that they were in the RFP process, they did not know what the proposals would be, they did not know whether they would have a proposal come forward that they would accept, that Mr. Dobbs had raised an issue that may or may not be relevant. Council Members Davis, Hoang, Rodriguez and Burks absent.

President Joseph Charles, Post Office Box 524373, Houston, Texas 77052-4373 (713-928-2871) appeared and stated that he was requesting more time, consistent of his official national crime victim global case, and continued voicing his opinions until his time expired. Council Members Davis, Hoang, Rodriguez and Burks absent.

At 3:15 p.m. Mayor Parker stated that City Council was recessed until 9:00 a.m., Wednesday, August 21, 2013. Council Members Martin, Pennington and Noriega absent on personal business. Council Members Davis, Hoang, Rodriguez and Burks absent.

The Houston City Council reconvened at 9:00 a.m., Wednesday, August 20, 2013, with Mayor Annise Parker presiding and with Council Members Helena Brown, Jerry Davis, Ellen R. Cohen, Wanda Adams, Dave Martin, Al Hoang, Edward Gonzalez, James G. Rodriguez, Mike Laster, Larry V. Green, Stephen C. Costello, Andrew C. Burks, Jr., C. O. "Brad" Bradford and Jack Christie, D. C.; Mr. David Feldman, City Attorney; and Ms. Marta Crinejo, Agenda Director, present. Council Members Oliver Pennington and Melissa Noriega absent on personal business.

At 8:30 a.m. the City Secretary read the descriptions or captions of items on the Agenda.

At 9:12 a.m. Mayor Parker called the meeting to order, and stated that Council Member Noriega would be absent today, family issues, and they wished her well with that. Council Member Davis absent.

Council Member Christi that Hermann Park would be celebrating a hundred years next year and he and Council Member Adams cut the ribbon, helped dig the hole for the Grand Gateway, and the Houston Parks and Recreation, the Conservatory for Hermann Park and very giving citizens, that it would be a sight to behold on Main Street, coming into Hermann Park. that it was important that they either opt in with their deed restrictions, if they did not have deed restrictions there was a process they could go through, that because of the situation where people thought they could be exempted and when they passed away they did not have to worry about paying taxes, that was a myth, and the people of Houston needed to know exactly, that he asked on Council how would they notify people about the changes that would happen, it was important that citizens of Houston get involved and go to the meetings and ask questions and understand, because he wanted it to be known that he was concerned and raised the voice of speaking out for them and making sure that they understand that they had to keep their home that they had worked so hard to pay for. Council Member Gonzalez announced events he attended or would be attending; and stated that he wanted to thank Mayor Parker, Parks and Recreation Department and the Legal Department for their hard work that was put into reaching a settlement with the developer responsible for the devastating destruction that occurred at Woodland Park in early June, that he looked forward to joining the Friends of Woodland Park and the community in crafting a plan of action and making sure that all terms of the settlement were met; that he wanted to thank the Houston Fire Department Rescue Command Unit, D Shift, Chief Robert Branch, Senior Captain Keith Bogdat and Firefighter George Kudelka, who were extremely helpful last week when one of their staff members, out doing Council work, found themselves stuck inside a ditch while driving in the community, that fortunately it happened in front of Rescue Command's Historic Building, Old Station No. 15 and the team was able to help; that he wanted to thank the Houston Fire Department, yesterday they were dispatched to a fire in the 200 Block of Cavalcade at Charmin, District H, and upon arrival the house was heavily engulfed in fire and smoke and firefighters changed to a defensive attack on the fire within five minutes after their arrival, several residents were able to safety escape the house, however one individual was trapped and rescued by HFD, that approximately 45 firefighters responded to the incident, which was tapped out about 4:50 p.m., that he wanted to give them kudos and thanked them for serving Houston on a daily basis; that he wanted to offer a special thanks to the District B team, who last Friday helped the District H team pickup and transport over 200 backpacks donated by Mayor Parker for the back to school fair and to the District H community. Council Members Brown, Davis, Martin, Hoang and Rodriguez absent.

Mayor Parker stated that she wanted to congratulate Council Member Gonzalez on the work on Woodland Park, Mr. Feldman negotiated the settlement and they thought it was a

significant settlement and should send a strong message, but Council Member Gonzalez was on the issue from the moment they found out about it and had been a champion on it, that they needed to send a strong message, whether it was a street tree or any tree on public land they wanted to act to protect the. Council Members Brown, Davis, Martin, Hoang and Rodriguez absent.

Council Member Adams stated that she also wanted to add her staff member, Ms. Risha Batey, to Council Member Gonzalez transport of the backpacks, and thanked her for getting the van so they could get the backpacks; that she wanted to thank Officer Anders and for Council Member Gonzalez for communicating with her concerning boarding houses in the community, that she knew the ordinance would be in effect in November, but they were starting to have issues with boarding houses, there was an emergency meeting last night in the Honey Circle Community concerning a boarding house, there were currently 17 residents in the boarding house on Palm Street, that it was like an overnight pop-up, that everyone jumped on the issue and she wanted to commend the Honey Circle Community, HPD and Legal for working together on this issue because the house was not up to standard to accommodate 17 people; and announced events she attended or would be attending; that they wanted to give condolences to Mr. Skipper Lee Frazier for the passing of his wife, Ms. Martha Orellia Frazier. Council Members Brown, Martin, Hoang and Rodriguez absent.

Council Member Green announced events he attended or would be attending; and stated that HPD Officer Omar Garcia Chavez was a night shift patrol officer assigned to the South Gessner Division, he responded to a criminal mischief charge at a Valero Gas Station, when a vehicle had rammed the store in an attempt to steal the ATM, that Officer Garcia Chavez was able to locate the suspects vehicle and detained two suspects, that his good policing resulted in the apprehension of the suspects, cleared approximately 28 cases linked to smash and grab burglaries of ATM machines and identified 9 other suspects who were possibly related to the crimes, that he wanted to congratulate Office Garcia Chavez who was truly one of Houston's finest; that he had forwarded an e-blast to the Hiram Clarke/Fort Bend Houston community leaders about applying for the special minimum lot size applications, that he would forward a similar e-blast next week to the Westbury, Brayes Oaks, Willow Meadows, Willow Bend, Westwood and South Braeswood comities, that for those neighborhoods that already had the language in their deed restrictions addressing the minimum lot size and/or building line requirements, they strongly encouraged them to consult with a private attorney to ensure their restrictions were valid in all respects and provided the protections set forth therein, that it was important to understand that the District K Office simply reviewed their deed restrictions for pertinent language and was making no assurance representations regarding the actual validity of their deed restrictions, the applications and information about this program could be found online with the Planning Department or their webpage or they could contract Mr. Calvin Calvey, Planning Department, at 713-837-7701. Council Members Brown, Adams, Martin, Hoang, Rodriguez and Christi absent.

Council Member Davis announced events he attended or would be attending. Council Members Brown, Adams, Martin, Hoang, Rodriguez and Christi absent.

Council Member Cohen stated that Ms. Cindy Zerwas, wife of State Representative John Zerwas, passed away, that she was a terrific woman and had been ill for some time. Council Members Brown, Adams, Martin, Hoang, Rodriguez and Christi absent.

There being no further business before Council, the City Council adjourned at 9:53 a.m. Council Members Pennington and Noriega absent on personal business. Council Members Brown, Adams, Martin, Hoang, Rodriguez and Christi absent.
