



Remember to Attach Any Part Of The Campaign Finance Report Form Needed To Report And Explain Corrections

The person who prepared the original report was indicted by a Grand Jury on charges of First Degree Felony Theft and is currently being held in the Harris County Jail awaiting trial. The ensuing examination by investigators of the District Attorney's Office, the bank's fraud examiners, and outside accountants hired by the Committee's political consultants have discovered errors which this report corrects.

This report corrects the following items:

1. \$500 was added to item 14, sub-item 2 (total political contributions).
2. \$1723.69 was replaced with \$1763.29 in item 14, sub-item 5 (total political contributions maintained as of the last day of the reporting period).
3. A political contribution of \$500 from Mr. Austen Furse was added to Schedule A page 1/1, Report page 3/3.

We request that the Commission consider waiving any fines that may be incurred by the filing of this correction.
