

The property damage I sustained, both personal and campaign-related, was extensive due to approximately two feet of water in my home.


Some of the documents damaged during the storm were records of financial expenditures and contributions needed to complete my July 16, 2001 Officeholder Campaign Finance Report.

Immediately, upon realizing that some of these documents were damaged, I contacted the bank to get copies. Because of the amount of time the bank needs to turn such a request around, I need additional time to submit an accurate campaign finance report.

I am aware of the deadline specified in state law. I want this letter to serve as a formal notice that circumstances beyond my control have prevented me from meeting that deadline. This letter is also inform you that I will need an additional (14) fourteen business days from Monday, July 16, 2001, 5:00 PM to submit my completed campaign report.
