

Remember To Attach Any Part Of Form C/OH Needed To Report And Explain Corrections

On Schedule A of the 30 day report covering 7-1-01 through 9-27-01 an address for a contribution from Antonio Ballesca and a contribution from Mrs. Antonio Ballesca was inadvertently omitted. This corrected report lists their address as 20275 Sunny Shores Dr., Humble, TX 77346.

The previous report also omitted an Out-of-state-PAC ID# for two entries, GOPAC State A on 9-24-01 and JP Morgan Chase PAC on 9-5-01. The Out-of-state-PAC ID# is now listed for both contributors.

On Schedule F of the original filed report were three entries reimbursing me with the purpose as Auto Expense. In this corrected report, I have further defined that purpose as Mileage reimbursement for political/campaign activities.

On the original filed report were three entries reimbursing me for political expenses. Schedule G was inadvertently omitted which itemized those campaign expenses that I paid for personally and got reimbursed for. Attached is Schedule G itemizing those expenditures.

Attached is a revised Cover Sheet pg 2 with an updated amount for Total Expenditures. This amount reflects the total expenditures in Schedule F of the original filed report and includes the entries on Schedule G that are listed in this revised report.

All of these mistakes were clerical errors.


