


Remember To Attach Any Part Of Form C/OH Needed To Report And Explain Corrections

On Schedule F of the July 15, 2002 report covering 1-1-02 through 6-30-02 an address for the expenditure to the National MS Society on 5-3-02 was inadvertently omitted. That address is now listed.

The previous report also omitted the expenditure's purpose on three entries: Sterling Bank on 4-30-2002 and Webvertising on 5-3-02 and Voice Stream Wireless on 5-3-02. Those purposes are now listed.

This corrected report also gives further explanation on the expenditure to Wayne Voss on 1-9-2002 and Robert C. Pelfrey on 2-27-2002.

On Schedule F of the original filed report were five reimbursements to me with the purpose as Auto Expense. In this corrected report, I have further defined that purpose as Mileage reimbursement for political/campaign activities.

On the original filed report were seven entries reimbursing me for political expenses. Schedule G was inadvertently omitted which itemized those campaign expenses that I paid for personally and got reimbursed for. Attached is Schedule G itemizing those expenditures. On four of the itemized expenditures, the purpose reflects that it was for travel expenses that were inadvertently paid by the campaign in error. I reimbursed my campaign on 5-13-2003 to which cover the amount of these expenses.

All of these mistakes were clerical errors.


