

I respectfully request a letter from Robert Mannas, with the TEC legal division, that clarifies his advise to the Orlando Sanchez for Mayor campaign regarding the reporting of out-of-state PACs.


The campaign was told that if a contribution over \$500 from an out-of-state PAC was received, we must only list the out-of-state PAC ID number on the contribution/expenditure report. This is an understandable error because reporting requirements regarding are different for electronic filings and paper filings. Specifically, with electronic filing the campaign only needs to list the out-of-state PAC ID number. With a paper filing, both the out-of state PAC ID number plus the PAC's Statement of Organization are required.

Five out-of-state PAC contributions were reported listing only the PAC ID number as advised by the Texas Ethics Commission lawyer. We have since filed amended reports that included the required documents, which we had in our possession.

I further request that the Commission consider amending the requirement to only include the out-of-state PAC's ID number and not their Statement of Organization with paper filings. This would be the same information as required in the electronic filings. Equal reporting requirements for each method of filing is fairer and less confusing for the campaigns.


