

### **EXPLANATION OF CORRECTIONS TO RUNOFF ELECTION REPORT:**

We are amending Schedule A, which originally reported an in-kind contribution in the amount of \$1,440 from Kenneth Edwards on November 18, 2003 and a contribution in the amount of \$8,560 from Kenneth Edwards on November 19, 2003. These contributions were actually made by Pipefitters Local Union #211 C.O.P.E. The incorrect identification of the contributor in the original report was the result of a computer database error.

We are amending Schedule A, which originally reported a contribution in the amount of \$5,000 from Gov. William P. Hobby on November 21, 2003. Half of this contribution was from Diana Hobby but was incorrectly attributed to Gov. William P. Hobby. This correction reflects what truly happened: a \$2,500 contribution from Gov. William Hobby on November 21, 2003 and a \$2,500 contribution from Diana Hobby on November 21, 2003.

We are amending Schedule A, which originally reported a contribution in the amount of \$10,000 from Barry Palmer on November 13, 2003. This contribution was actually made by Coats, Rose PAC. The incorrect identification of the contributor in the original report was the result of a computer database error.

We are supplementing Schedule G to report an expenditure from personal funds that was inadvertently omitted from the original report.

Based on the foregoing, "Total Expenditures" reflected on the report increased to \$2,542,013.12.
