

### **EXPLANATION OF CORRECTIONS FOR JULY 15, 2004 REPORT:**

We are supplementing Schedule A to report two contributions from Sue Strange, which were inadvertently omitted from the original report.

We are amending Schedule A, which originally reported a contribution in the amount of \$10,000 from James F. Thompson on April 4, 2004. \$5,000 of this contribution was from Susan S. Thompson but was reported incorrectly as a result of a computer database error. This correction reflects what truly happened: a \$5,000 contribution from James F. Thompson on April 4, 2004 and a \$5,000 contribution from Susan S. Thompson on April 4, 2004.

We are amending Schedule A, which originally reported a contribution in the amount of \$1,000 from Gov. William P. Hobby on March 5, 2004. Half of this contribution was from Diana Hobby but was incorrectly attributed to Gov. William P. Hobby. The correction reflects what truly happened: a \$500 contribution from Gov. William P. Hobby on March 5, 2004 and a \$500 contribution from Diana Hobby on March 5, 2004.

Based on the foregoing, "Total Contributions" reflected on the report increased to \$1,089,942.53.
