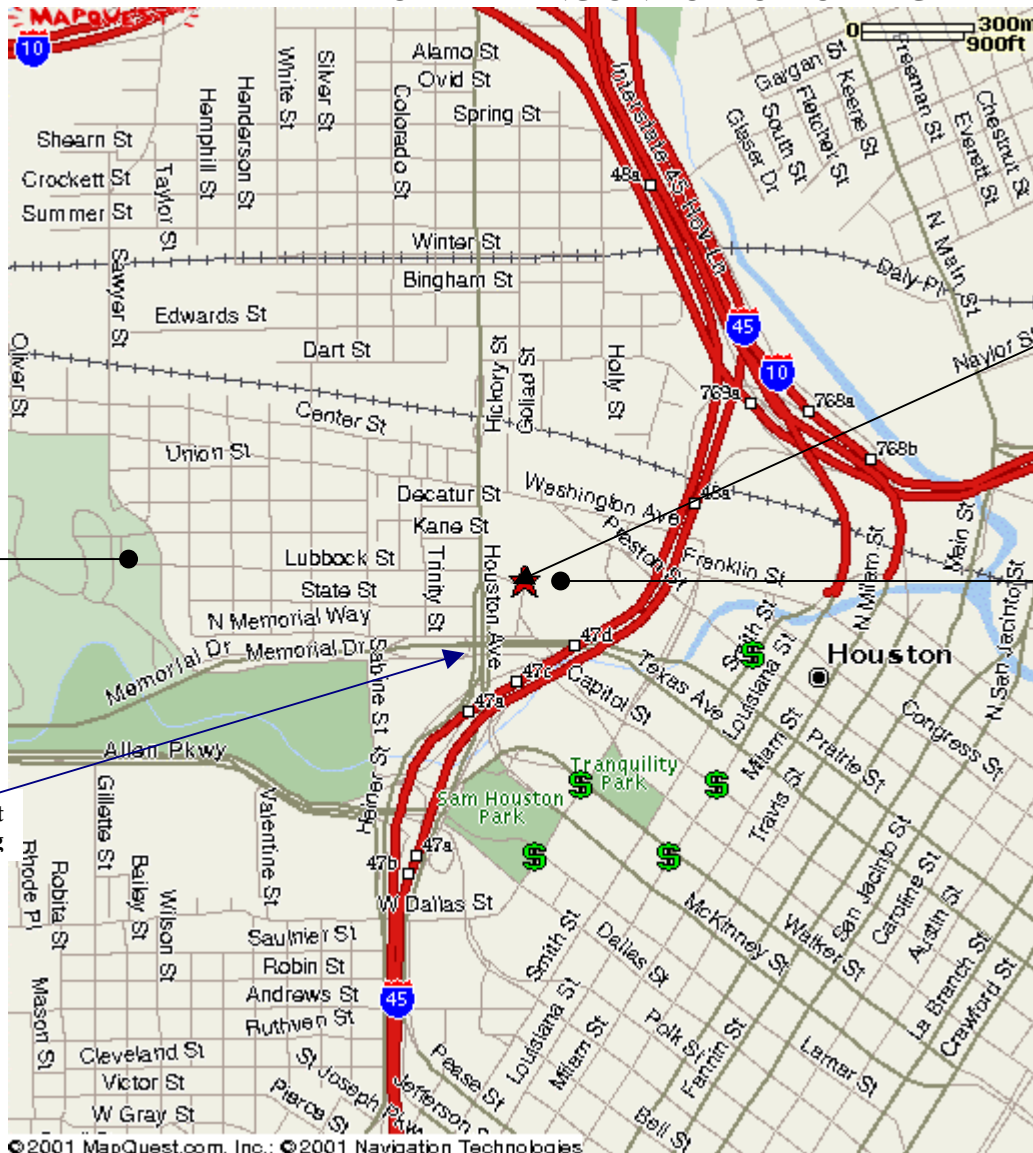

LOT H DIRECTIONS

I-45 Southbound exit Milam, right on Franklin to Washington Ave., left on Houston Ave., right into Lot H.

I-45 Northbound, take Memorial Dr., exit left on Memorial Dr., left on Houston Ave., right into Lot H.

Memorial Dr. eastbound to Houston Ave., right into Lot H.

From Downtown take Capitol St. to Memorial Dr., left on Houston Ave., right into Lot H.

FROM:
I-45 North Frwy.

Exit McKinney, take left on Bagby, left on Capitol.

- I-45 South, Gulf Frwy.** **Exit Houston Ave., take right on Lubbock (stop light)**
- 59 North, Eastex** **Take I-10 West (San Antonio), exit Main St., left on Main, right on Franklin/Washington, left on Houston Ave., left on Lubbock.**
- 288 South** **Take I-45 North (Dallas), exit Houston Ave., right on Lubbock (stop light).**
- 290 NW (Austin)** **Take I-10 East bound, exit downtown Smith St., right on Franklin/Washington, left on Houston Ave., left on Lubbock.**
- I-10 East (Beaumont)** **Exit Main St., left on Main St., right on Franklin/Washington, left on Houston Ave., left on Lubbock.**
- I-10 West (Katy)** **Exit downtown Smith St., right on Franklin/Washington, left on Houston Ave., left on Lubbock.**
- 610 Loop** **Follow instruction from one of the connecting freeways.**

↓_NOTE: FRANKLIN TURNS INTO WASHINGTON. AT HOUSTON AVENUE TURN LEFT. AT LUBBOCK TURN LEFT. STAY IN RIGHT LANE AND GO AROUND PARKING LOT TO ENTRANCE AT BACK

DIRECTIONS FOR BUS RIDERS: You can transfer from one of many METRO routes to Downtown Houston and catch Trolley E at a designated bus stop on Walker between Smith and San Jacinto Streets. Trolley E runs every 7 minutes from 6:30 a.m. to 7:30 p.m. Jurors ride free. Show your Municipal Courts Summons to the bus operator and ride METRO to court for free. Contact METRO at 713/635-4000 and tell the representative you need to go to jury duty at the Municipal Court on Lubbock St. Then ask for the route and schedule nearest your home that will allow you to ride METRO and transfer to Trolley E in Downtown. DIRECTIONS FOR PERSONS DRIVING: If you decide to drive, jurors can park for free in Lot H located at Houston Ave. and Memorial Dr. (Eastbound service road) and ride Trolley E for free to Municipal Court on Lubbock St.
