Public Notice Revision (November 22, 2011) - HCDD proposes reduce the “Technical Assistance/Housing Information/ Resource Identification line item” by \$70,815.25 and move the funds to “Tenant Based Rental Assistance” under the 2008 Annual Action Plan for 2005-2009 Consolidated Plan under the Housing Opportunities for Persons with AIDS (HOPWA).

The public has thirty days (30) to comment on these proposed items. The thirty-day period extends from Thursday, December 8, 2011 through Monday, January 9, 2012. Following the public comment period, the Action Plan/Budget amendments will be submitted to City Council for approval.
