Community meetings set to help neighborhoods apply for new tools to retain their residential character

HOUSTON, May 2, 2013 – City Council recently approved amendments to Chapter 42 of the Code of Ordinances. Previously, residents inside Loop 610 could apply to designate a Special Minimum Lot Size or Building Line (setback) on blockface by blockface basis. These tools now extend to the entire City of Houston and a new tool has been added that allows the establishment of a Minimum Lot Size Area.

The Minimum Lot Size Area designation prevents lots from being divided below a certain size established by a calculation of the lots in the subdivision. This prevents lots from being split into smaller sized lots that are typically found in townhome developments.

After an initial application and community process, 55% of the owners must agree to the designation. City Council must vote to approve the designation. Once established the designation remains in effect for 40 years. The Area must not contain more than 500 lots within the same platted subdivision or 400 lots within different platted subdivisions.

A series of community meetings is being held to help communities understand how to apply for these designations. The following is a list of scheduled meetings.
