IV. CONSIDERATION OF INITIATION BY HAHC OF THE LANDMARK DESIGNATION APPLICATIONS for the Alabama Theatre at 2922 S. Shepherd including the Alabama Shopping Center – 2900 to 2946 S. Shepherd Drive (west side of the 2900 Block of S. Shepherd between Kipling and W. Alabama) and the River Oaks Theatre at 2009 W. Gray including the River Oaks

Community Center Shopping Complex – 1952 to 2050 W. Gray (north and south sides of W. Gray between Driscoll and S. Shepherd Drive

Motion was made by Ms. Tudor, seconded by Mr. Longoria, to instruct the Planning official to prepare the Landmark Designation Applications for the Alabama Theatre at 2922 S. Shepherd including the Alabama Shopping Center – 2900 to 2946 S. Shepherd Drive (west side of the 2900 Block of S. Shepherd between Kipling and W. Alabama) and the River Oaks Theatre at 2009 W. Gray including the River Oaks Community Center Shopping Complex – 1952 to 2050 W. Gray (north and south sides of W. Gray between Driscoll and S. Shepherd Drive. Motion carried unanimously.

c. WALTER BOYD HOUSE AT 3424 WICKERSHAM LANE

Madame Chair opened and closed the public hearing as there were no speakers to this item.

Motion was made by Ms. Tudor, seconded by Mr. Fruge, to accept staff's recommendation that the Houston Archaeological and Historical Commission recommend to the Houston Planning Commission the Landmark Designation of the Walter Boyd House at 3424 Wickersham Lane. Motion carried unanimously.

d. JOSEPH H. RUSSELL HOUSE AT 2232 BRENTWOOD DRIVE

Madame Chair opened and closed the public hearing after the speaker.

Motion was made by Ms. Tudor, seconded by Mr. Bartell, to accept staff's recommendation that the Houston Archaeological and Historical Commission recommend to the Houston Planning Commission the Landmark Designation of the Joseph H. Russell House at 2232 Brentwood Drive. Motion carried unanimously.

Motion was made by Mr. Bartell, seconded by Dr. Moore, to accept staff's recommendation that the Houston Archaeological and Historical Commission recommend to the Houston Planning Commission the Landmark Designation of the Jacques P. Adoue House at 2135 Looscan Lane. Motion carried unanimously.


