III. PUBLIC HEARING AND CONSIDERATION OF A PROTECTED LANDMARK DESIGNATION APPLICATION FOR EXISTING LANDMARK FOR JEFFERSON DAVIS HOSPITAL – 1101 ELDER STREET

The Chair opened and closed the public hearing. There were no speakers.

Motion made by Mr. Cosgrove, seconded by Mr. Garcia-Herreros that the Houston Archaeological and Historical Commission recommend to City Council the Protected Landmark Designation of the Jefferson Davis Hospital at 1101 Elder Street. Motion carried unanimously.

IV COMMENTS FROM THE PUBLIC AND THE HAHC

Joy Tober asked the Commission to clarify the side setback issue from the previous agenda item.

Kent Marsh informed the Commission that he has set up a Committee that consists of Houston Heights District East homeowners and will communicate with the homeowners in the District and Historic Preservation staff. They have formed a process to obtain the applications each month, provide input back to staff so staff can give input to the HAHC. He hopes to expand the Committee to other districts. Also, he will be setting up a walking tour for the three Heights Districts and will be asking the Commission for dates in the near future.

Sue Lovell congratulated the Chair on his position. She told the Commission that the people moving into the neighborhoods like the Heights want more house and less yard. The projects coming before the commission are not what the builders want but what their customers are wanting. She asked the Commission to allow them to invest in these neighborhoods and asked the Commission to take that into consideration. She also mentioned she has people lined up to invest in the Design Guidelines and she also volunteered to Chair the Committee.

Commissioner Hellyer pointed out that there were 39 items on the agenda today and 33 were approved at about 87% and there was one deferral.

Minnette Boesel asked that the Commission give a presentation on some projects set by example that were approved on the consent agenda so the audience and people watching TV can learn what great projects go through the consent process.

Commissioner Bucek mentioned that the preservation training session is easier to follow when it is at the beginning of the meeting.

Commissioner Welsh suggested that the preservation training session should include great projects that have been granted Certificates of Appropriateness from the previous month.

There being no further business brought before the commission, a motion was made by Mr. Cosgrove, seconded by Mr. Yomeyer to adjourn the meeting at 5:23 p.m.
