What are the Consolidated & Annual Action Plans?

Beginning in 1995 the U.S. Department of Housing and Urban Development (HUD) required local communities and states to prepare a Consolidated Plan to receive federal housing and community develop funding. The Plan consolidates into a single document the planning and application requirements for Community Development Block Grants (CDBG), the HOME Investment Partnership Program (HOME), the Emergency Solutions Grant (ESG), and the Housing Opportunities for Persons with AIDS (HOPWA) funding.

The Plan discusses the resources available to meet the needs of low-to-moderate income Houstonians. Long-term goals and strategies are discussed in the five (5) year Consolidated Plan, and how cities and states propose to spend federal block funds is discussed in the Annual Action Plan.

The Consolidated Plan discusses the Strategic Plan, Needs Analysis, Citizen Participation, Monitoring, Objectives, Public Housing, and Barriers to Affordable Housing, Resources, and Priorities.

The Annual Action Plan discusses the Activities (Projects), Monitoring, Annual Objectives, Public Housing, Program Requirements, Application for Funding, and Barriers to Affordable Housing, Resources, and Priorities.


