Arcade, when referred to in this application, means Adult Arcade or Adult MiniTheater as defined in section 28-81 of the amended Code of Ordinances of The City of Houston.

This permit application MUST be accompanied by the following:

The required permit fee of \$275.00. This fee is nonrefundable.

1. A certified copy of the assumed name, certificate filed in compliance with the Assumed Business of Professional Name Act if the Arcade is to operate under an assumed name.
2. A Diagram of the Adult Arcade showing a plan specifying the location of one or more manager's stations and the location of all lighting fixtures, areas where patrons will be excluded from being and the location where the permit, if issued, will be displayed (pursuant to Section 2891(b) of the Code).
3. Certified copy of the lease agreement between the landowner and the tenant showing current lease arrangements.
4. Signed, dated and notarized letter from the landowner (or representative) indicating that the applicant has permission to operate and Adult Arcade on the premises.
5. A copy of the applicant's valid Government issued identification.
