I write to you with joy in my heart for this opportunity to nominate Houstonian Esmeralda Peña Garcia for the Mayor's Hispanic Heritage Award for Lifetime Achievement. # JUDGE ESMERALDA PEÑA GARCIA

## Associate Presiding Judge of The City of Houston Municipal Courts

Judge Esmeralda "Essie" Peña Garcia is in her 33<sup>rd</sup> year serving the City of Houston and State of Texas as a Municipal Court Judge. She started her Judicial career in 1987 and in 2016 was named Associate Presiding Judge overseeing the Judicial Operations of the Court and supervising 18 full-time Judges. She has been licensed by the State Bar of Texas for 38 years.

Judge Peña Garcia is the Immediate Past President of the Texas Municipal Courts Association (TMCA). TMCA represents over 1,200 Municipal Court Judges and staff throughout the State and concurrently serves as Past President of the Texas Municipal Courts Education Center (TMCEC). Judge Peña Garcia has served on the TMCEC faculty, teaching Municipal Judges in regional seminars throughout Texas.

In recognition of her 30 years of Judicial Service, Mayor Sylvester Turner proclaimed October 11, 2016 as "Judge Esmeralda Peña Garcia Day" in the City of Houston. Judge Garcia recently received the Texas "Women Making History" Award and the Mexican-American Bar Association of Texas Foundation Award for Lifetime Achievement, and the National Hispanic Professionals Organization-Houston Lifetime Achievement Award. She has received Official Proclamations and Recognitions from Texas Governor Greg Abbott, U.S. Congresswoman Sheila Jackson Lee, U.S. Congresswoman Sylvia Garcia and Chief Justice Nathan Hecht of The Texas Supreme Court of Texas, The National Hispanic Bar Association Service Award, the Hispanic Bar Association of Houston, the Mexican-American Bar Association of Houston, in recognition of her Judicial and community service to Houston, the Hispanic community and the State of Texas. In 2016, the UH Law Center recognized Judge Peña Garcia as "Pioneer in Diversity at the UH Law Center" for her work in increasing diversity representation in UH Law School Admissions. Judge Garcia received the 2019 Speaker Award from the Hispanic Law Students Associations of Thurgood Marshall School of Law, The University of Houston Law Center, and South Texas College of Law Houston.

Community awards have included the Pan American Round Table of Houston's "Latina Law and Order" Lex Award", Navidad En El Barrio's "VIDA Award" for service to families and children, and Leading Ladies Award for "Latina Leader for Young Ladies".

In 1989, Judge Garcia was President of the Mexican-American Bar Association of Houston. She also served on the Board of Directors of the Municipal Courts Section of the State Bar of Texas and Regional Director of the Hispanic National Bar Association. She has been active with numerous professional organizations, serving on boards and committees, including the Supreme Court of Texas District Committee on Admissions, the Committee of 100 for Review of Merit Selection of Texas Judges, and other State Bar of Texas committees. During her 13 years in private law practice, Judge Garcia

specialized in Criminal, Juvenile, and Family Law. She was frequently appointed to represent juvenile defendants in high-profile cases.

She received her BA in Sociology from the University of Houston in 1974 and her Doctor of Jurisprudence from the University of Houston Law Center in 1982. In 1981, she was elected President of the UH Student Bar Association, making her the first Hispanic to serve in this position, and leading the effort for the inclusion of minority students on the Admissions Committee. She has received the "Distinguished Service Award" from the UH Law Center Faculty. Prior to law school, Judge Garcia worked for Harris County Children's Protective Services on the Abuse Team

Judge Peña Garcia's community service in Houston spans over 40 years focusing on education, scholarships, and working with minority and minority-at-risk youth.

- She enjoys working with *Navidad En El Barrio* in its mission to provide Christmas gifts and fulfill "Little Wishes" to less fortunate children and families.
- She is the Past Director of the Pan American Round Table of Houston, an organization providing college scholarships to high school seniors, focusing on Latina young ladies who will be the first in their families to attend college.
- Served on the Harris County Children's Mental Health Advisory Board
- For 22 years, has volunteered with the Houston Livestock Show and Rodeo. In 2016, she earned "Lifetime Committeeman" status and continues to serve on the International Committee and Go Tejano Committee raising scholarship funds for Hispanic students.
- Judge Peña Garcia is a frequent speaker on Career Day and Law Day at various schools. In the past, she worked with Our Lady of Guadalupe School in the barrio and formed its first Chess Club in the 1994, obtained donated chess boards, taught chess after school, twice a week, for a school year. She has been participated in mentorship programs at Ridgecrest Elementary and Northbrook High School. Judge Garcia has been a Hispanic Heritage Month speaker in various schools, and in 1992 created the "Mayan Hieroglyphics" classroom activity. She has received recognition as a "VIP-Volunteer in Public Education" by HISD.

Judge Essie Peña Garcia was born in Houston, growing up in Second Ward *barrio*. She attended Our Lady of Guadalupe School, and graduated *cum laude* from Stephen F. Austin High School. She was the first Hispanic Cadet to achieve the rank of ROTC Lieutenant Colonel and first Hispanic member of the ROTC City Brigade Staff. She is an Army qualified "Expert" with .22 Rifle, and Certified Open Water Scuba Diver. She is the first in her family to graduate from college.
