

City Council Chamber, City Hall, Tuesday, December 11, 2012

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, December 11, 2012, Mayor Annise Parker presiding and with Council Members Helena Brown, Jerry Davis, Ellen R. Cohen, Al Hoang, Oliver Pennington, Edward Gonzalez, James G. Rodriguez, Mike Laster, Larry V. Green, Stephen C. Costello, Andrew C. Burks, Jr., C. O. "Brad" Bradford and Jack Christie, D. C.; Ms. Lynette K. Fons, First Assistant City Attorney, Litigation, Legal Department; Ms. Marta Crinejo, Agenda Director and Ms. Stella Ortega, Agenda Office present. Council Member Wanda Adams and Mike Sullivan absent on personal business. Council Member Melissa Noriega out of the city on personal business.

At 1:46 p.m. Mayor Parker called the meeting of the City Council to order and stated that they would begin with presentations and proclamations and called on Council Member Gonzalez. Council Members Brown, Davis, Rodriguez, Costello and Burks absent. NO QUORUM PRESENT.

Council Member Gonzalez stated that he would ask Ms. Debbie Harwell and others to please join him at the podium, that he was doing this presentation on behalf of Council Member Noriega, that they were here to celebrate Houston History Magazine in their tenth year of publication, and Mayor Parker presented a proclamation that proclaimed December 11, 2012, as "Houston History Magazine Day in the City of Houston", that she wanted to thank them for the work that they did. Council Members Brown, Davis Adams, Sullivan, Rodriguez, Costello and Burks absent. NO QUORUM PRESENT.

Ms. Harwell stated that she wanted to thank Mayor Parker and Council Member Gonzalez, the other Council Members and Council Member Noriega who could not be present today, that they appreciated what steadfast supporters they had all been at the University of Houston and of Houston history, and thanked them for the proclamation. Council Members Brown, Davis Adams, Sullivan, Rodriguez and Burks absent. NO QUORUM PRESENT.

At 1:54 p.m. Mayor Parker called on Council Member Gonzalez for the invocation and pledge of allegiance. Council Members Brown, Rodriguez and Burks absent.

At 1:56 p.m. the City Secretary called the roll. Council Members Adams and Sullivan absent on personal business. Council Member Noriega out of the city on personal business. Council Members Brown, Rodriguez and Burks absent.

Council Members Gonzalez and Bradford moved that the minutes of the preceding meeting be adopted. All voting aye. Nays none. Council Members Brown, Rodriguez and Burks absent. MOTION ADOPTED.

Council Member Cohen moved the rules be suspended for the purpose of moving Mr. Tom Dornbusch to the top of the 2 minute agenda speakers list, seconded by Council Member Gonzalez. All voting aye. Nays none. Council Member Brown and Burks absent. MOTION 2012-0834 ADOPTED.

At 2:00 p.m. the City Secretary began calling the public speakers. Council Members Brown and Burks absent.

Mr. Tom Dornbush, 6110 Tyne St., Houston, Texas 77007 (713-869-1185) appeared and stated that he was President elect of the Washington Avenue Coalition Super Neighborhood No. 22 Council and a long time resident of Woodcrest and had some material to pass out to the Council Members, that he would ask that they approve the Parking Benefits District Ordinance

and assure that the pilot program had sufficient time to prove it's effectiveness for the betterment of the urban community, that he wanted to thank the stakeholders, who they were going to hear from today speaking in favor of the Parking Benefits District. Council Members Brown and Burks absent.

Ms. Larissa Lindsay, 1816 Kane, Houston, Texas 77007 (713-540-0551) appeared and stated that she lived in the Old Sixth Ward, where they currently had Residential Permit Parking, that she strongly supported the Washington Avenue Parking Benefits District, that since the implementation of permit parking in her neighborhood there had been fewer instances of nightclub visitors urinating in front yards, gun shots, breaking bottles in the streets, screaming fights, blocked streets, along with other things that were not discussed in polite company, that were going on late evenings until 5 a.m., that their end of Washington Avenue was quite at the moment but they did have a restaurant under construction and once they were open they may have some parking issues to deal with again, that this was new and change was hard and yes she realized there were risks, but it was a start and with what she thought had excellent potential based on what she had already learned in her neighborhood. Council Members Brown and Burks absent.

Mr. Max Gonzalez, 2206 Kane, Houston, Texas 77007 (832-274-5504) had reserved time to speak, but was not present when his name was called. Council Members Brown and Burks absent.

Mr. Roland Lorenzo, 3003 Ferndale, Houston, Texas 77098 (713-397-2285) appeared and stated that he was the owner of two restaurants and a small market on Washington Avenue he believed that the proposed Washington Parking Benefit District would be a very good thing, that it would serve to improve the vitality of the important corridor and the surrounding neighborhoods, that his family operated two Mexican Restaurants and an Italian Steakhouse on Washington Avenue so they would be very much affected by this, that he wanted to thank them for listening and for their service to the City. Council Members Brown and Burks absent.

Mayor Parker and Council Members Cohen, Costello and Gonzalez stated that they wanted to commend Mr. Lorenzo for investing in the Washington area and for his interest in the issue. Council Members Brown and Burks absent.

Ms. Erin Dyer, 1520 Oliver St., Houston, Texas 77007 (832-553-5930) appeared and stated that she was present representing Lovett Homes and Lovett Commercial, that she had been closely following the evolution of the Washington Corridor for the past ten years, that Frank Liu was principal of Lovett and a unique perspective on Washington Avenue in that he owned both residential and commercial properties along the corridor, that in the last five years Lovett had built over 200 homes along Washington and planned to continue to invest in the residential development along the area, that they also owned 7 acres at the corner of Washington and Silver, which included two unique older buildings, which they had made efforts to preserve, that they would eventually like to develop it into a high density, mixed use, commercial development combining old and new, that Lovett's goal was to see continued high quality commercial and residential development along the corridor that enhances the quality of life within the neighborhood surrounding it, that was why Mr. Liu, and all of the Members of the Washington Avenue Developers Association, WADA, last night, unanimously voted in favor of the Parking Benefit District, that this was a great opportunity for Washington to be a premier, pedestrian friendly boulevard in the City, where Houstonians would be proud to bring their out of town guests. Council Members Brown, Hoang and Burks absent.

Mr. Carl Detering, 3028 Washington Ave., Houston, Texas 77007 (713-863-4710) appeared and stated that his family had owned land along the Washington Avenue Corridor for over 100 years, that he owned and operated a building materials company, The Detering Company,

along Washington Avenue, east of Studemont, that he was present to express support for the proposal to create a Parking Benefit District in the Washington Avenue Corridor; that some Washington Avenue businesses provide no more parking spaces than the minimum required by City ordinance and some charged their patrons to park in the space provided, that many did not provide employee parking and because parking on City streets was free employees and patrons searched for free street parking in area neighborhoods, that this phenomenon had created hardships for residents and small businesses alike; that he was present to endorse the proposed Washington Avenue Parking Benefit District because his primary interest was that Washington Avenue continue to develop in a sustainable way. Council Members Brown, Hoang and Burks absent.

Council Member Cohen stated that she had a letter from Mr. Ock, the Hanover Company, and read that he was an active developer of residential and mixed use urban projects in Houston he wanted to express his support for creating Parking Benefit Districts in high density urban mixed use areas such as Washington Avenue and Rice Village, that the meters would help deter all day parkers that might not necessarily be paying customers of restaurants and retailers, thereby freeing up more parking spaces for paying customers, and essentially that was what Mr. Detering was saying and Mr. Detering stated yes. Council Members Brown, Davis and Hoang absent.

Ms. Mary Jane Buschlen (did not wish to make her address or phone number public) appeared and stated that she represented the Cottage Grove Neighborhood on the Washington Avenue Memorial Park Super Neighborhood 22, that the Super Neighborhood 22 had been seeking relief from hardships caused by the parking shortage along Washington Avenue since the Spring of 2009, when a group of stake holders came to the City Council and asked Mayor White to establish a task force aimed at addressing issues that arose from the areas explosive growth, that about a month alter Council Member Noriega hosted a townhall meeting at which participants addressed issues arising from the growing number of night clubs without sufficient parking, that in 2009 and 2011, Super Neighborhood 22 held candidate forums for City Council races at which these issues were presented in words and pictures and the candidates were asked what they would do to address them if elected, that every candidate agreed to support a community consensus should one develop, that thanks to Council Member Cohen's leadership a community consensus had formed around the proposed Parking Benefit District, that on behalf of Super Neighborhood 22 she would ask that they reward and encourage the effort that had yielded this consensus by approving the proposed Parking Benefit District. Council Members Brown, Davis, Hoang, Pennington and Christi absent.

Ms. Marlene Bitz-McCourt, 3913 Barnes St., Houston, Texas 77007 (832-405-0299) appeared and stated that she was a resident of Magnolia Grove and also the President of the Civic Club, that she was present in favor of the Parking Benefit District from a residents point of view, that as she talked to residents as well as business owners they saw it as a matter of safety and convenience, that safety in that they would no longer have drunk people parking in front of their houses, that convenience, she would not have to look for a place to park if she wanted to come home and then go back out to a job site, that with the money they could improve Washington Avenue and the safety would be crossing the streets, that business owners were for it as well. Council Members Brown, Davis, Hoang, Pennington and Rodriguez absent.

Mr. Steven Rodriguez, 2316 Center St., Houston, Texas 77007 (832-294-8959) appeared and stated that he was present on behalf of the Kung Fu Saloon, off of Washington Avenue, as well as being a resident of Washington Avenue, that he was definitely for the proposed Parking Benefit District, that the popularity of Washington Avenue establishments had created a shortage of parking, which caused employees and customers to search for parking on neighborhood streets, which were often too narrow for cars to park safely, that they were hopeful that the revenue from the parking meters could be used to help pay for badly needed security in

the area such as theirs, as well as other places on Washington Avenue, that every week they paid for off duty officers at their bar, they were the only bar that did this and did it in conjunction with the neighbors. Council Members Brown, Davis, Hoang, Pennington and Rodriguez absent.

Mr. Josh Flowers, 4218 Washington, Houston, Texas 77007 (512-557-0681) appeared and stated that he was a new bar owner on Washington Corridor, Little Jay's Bar, that they had been opened for two months and the growing sentiment and statements that he got from his customers was that parking was the largest issue, that he had leased a separate parking lot in order to have free parking for his customers, that he believed that the Parking Benefit District would benefit all of the businesses along the street as a whole. Council Members Brown, Davis, Hoang, Pennington, Rodriguez and Green absent.

Ms. Phyllis Moss, 2520 Wichita, Houston, Texas 77004 (713-775-2959) appeared and stated that she was a resident of the Third Ward, specifically the MacGregor Super Neighborhood and lived in Riverside Terrace on the corner of Wichita and Live Oak, that a club recently opened in the neighborhood around the corner from her home on Southmore, that the parking from the club was creating a huge issue for her and her neighbors, that they submitted an application that had been approved for restrictive residential parking, which would come up on Wednesday for a vote, and they were asking for the Council Members support. Council Members Brown, Davis, Hoang, Pennington, Rodriguez and Green absent.

Mr. Oscar Lara, 6610 Avenue E., No. 3, Houston, Texas 77011 (713-505-6247) appeared and stated through an interpreter that he was a member of the Faith and Justice Workers Center, and even through he had been affected by wage theft he was not present to speak about his personal history, that the City Council had heard many stories as his, that he was present to speak about solutions to wage theft that affected so many people in Houston, that during the year they had brought various suggestions to the City Council, that the City had not taken any action to help their families, that they were tired of speaking about their stories, that even through they had been victims of wage theft they had taken the initiative to educate their community and they were asking the City Council to do the same and change the conversation, they wanted to talk about solutions. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, Green and Bradford absent. NO QUORUM PRESENT

Mr. Antonio Renobato, 9957 South Court, Houston, Texas 77099 (832-287-4259) appeared and stated through an interpreter that he was also a member of the Faith and Justice Workers Center and was present to support his fellow workers and those who could not be present today. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, Green and Bradford absent. NO QUORUM PRESENT

Ms. Carmen Galan, 322 Sunnyside, Houston, Texas 77091 (832-259-4158) appeared and stated through an interpreter that she was also affected and was a member of the Faith and Justice Workers Center, that she had been affected three times with wage theft from different people, that the money that was stolen from them they had worked for and they needed the money to pay for their utilities, that they wanted there to be a law or an ordinance because there were so many of them affected by wage theft, please help them. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, Green and Bradford absent. NO QUORUM PRESENT

Mayor Parker asked if Ms. Galan had reported the theft to the police, and Ms. Galvan stated that the people who employed her asked her what could she do, and Mayor Parker stated that it was theft, wage theft, that it was possible to take action if she reported it to the police, that many instances of wage theft had to do with day labor and the workers whose wages were stolen did not know the names or how to contact the people who stole from them, but if they new the names, where they lived or where the business was they could work with her to prosecute. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, Green and Bradford absent.

NO QUORUM PRESENT

Ms. Galan stated that through an interpreter they did go to work and were asked to fill out a paper for which they paid \$172, that happened six months ago, that she had to pay for an interpreter, and Mayor Parker stated that she did not have to pay a translator to have a conversation with a police officer, that she would ask that Ms. Galan follow up with them so that they could see what could happen in her particular instance. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, Green and Bradford absent. NO QUORUM PRESENT

Mayor Parker asked that Citizens Assistance work with Ms. Galan, that she knew that Sergeant Herndon was present. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, Green and Bradford absent. NO QUORUM PRESENT

Council Member Christi asked if this inequity went through the Police Department, they did not need a new ordinance did they, and Mayor Parker stated that she believed the public speakers were making multiple requests, one, if there was any vendor that actually did business with the City that did not pay their employees the City certainly had recourse and they could prevent them from doing business with the City in the future, but for the private employer who may offer work to one of the speakers present there was a State Wage Theft Law and they could assist in prosecution, but as she stated, the difficulty was often that the worker did not know how to track down the individual or company that cheated them, but if they did they would work with them to prosecute, and Council Member Christi asked if it was actual wage theft was there a way to reduce the \$172 to a very reasonable amount, and Mayor Parker stated that she was not sure what that amount was for, and Ms. Bolanos stated that she believed it was the court fee that Ms. Galan had to pay to file a claim against the contractor. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, Green and Bradford absent. NO QUORUM PRESENT

Mayor Parker stated that may very well be that it was a court fee, but wage theft was theft, that one of the things that she had discussed with Council Member Gonzalez, because the issue seemed to be rising more frequently, was that the Chief was assigning an individual in the Police Department to be the point of contact for wage theft issues so that things they could not address would not get dropped. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, Green and Bradford absent. NO QUORUM PRESENT

Council Member Gonzalez stated that one of the challenges that he thought existed was that there was different areas of law, some of them fell within civil law, if there was a contractual kind of disagreement, there could be a criminal aspect to it where HPD would be the point of contract, and there could be some translation issues some time, so finding a point of contact could be very helpful, and also making sure that in their contracts it was clear what the process was if there was a claim of wages not being paid. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, Green and Bradford absent. NO QUORUM PRESENT

Mr. Jose Sanchez, 3915 Chenevert, Houston, Texas 77004 (832-715-5975) appeared and stated that he was with the Houston Workers Center, that over the past year they had met with many of their staff and shared many reports and stories about the affect of wage theft in Houston and also brought various Houston workers and their families to speak to the City Council about their experiences, like they did today, that they wanted to thank all of them who had lent their ears to their issue and had asked questions, provided feedback and showed their support, but most of them who had taken concrete action to help Houston working families, that they also wanted to thank Mayor Pro Tem Gonzalez who had shown leadership and had been a great resource in this issue, that they looked forward to working with them in the upcoming year for concrete action to insure that the value of the work was upheld; that they did work directly with HPD and it was actually under their Theft of Services, they did take wage theft claims,

however they had conversations with the District Attorney where they had been told directly that they would not be prosecuting any of these claims, so that would definitely be a conversation that they would love to follow up with the Mayor and Council Members. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, and Bradford absent.

Mayor Parker stated that the District Attorney, unfortunately, did not work for her. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, and Bradford absent.

Council Member Gonzalez stated that he wanted to thank Mayor Parker because she had listened, that it had been a slow process and bureaucracy sometimes moved slow, that it was a complex issue because they had different entities, that to him it was fundamental, if somebody worked they should get paid and thought that was something that they needed to make sure was taken care of, at least within their purview and at least creating a process so that everybody knew who the point of contact was, that the City Legal Department was very competent, they were looking at this issues and the information provided. Council Members Brown, Davis, Hoang, Pennington, Rodriguez, and Bradford absent.

Mr. Max Gonzalez, 2206 Kane, Houston, Texas 77007 (832-274-5504) appeared and stated that he was both a resident and business of the Historic Sixth Ward on Washington Avenue, that was present to vocalize his support for the Parking Benefit District for Washington Avenue, that he believed that the Parking Benefit District would help further proper development on Washington Avenue and create a real opportunity for the community to thrive, that he would like to challenge the City of Houston to look at all of their neighborhoods in a unique perspective where they could meet the needs of those communities. Council Members Davis, Hoang, Pennington, Rodriguez, and Bradford absent.

Mr. Steven Williams, no address, no phone, had signed up to speak, but was not present when his name was called. Council Members Davis, Hoang, Pennington, Rodriguez, and Bradford absent.

Ms. Synthia Hall, 1515 Sidnor St., Houston, Texas 77020 (832-886-7771) had signed up to speak, but was not present when her name was called. Council Members Davis, Hoang, Pennington, Rodriguez, and Bradford absent.

Mr. Barry Rosette, 3618 Lindenfield, Katy, Texas 77449 (832-483-3231) appeared and stated that he was present on behalf of his wife and son, they were involved in a motor vehicle accident on August 25, 2012 at about 8:15 a.m., that his wife called him in a panic and told him she had just been struck by a truck and knocked into a ditch, that the police was dispatched to the location to investigate the accident, that he rushed to the location also and found a mess in the middle of Highway 6, just south of Briarforest, that after he arrived another lady arrived screaming that was her vehicle and later in the investigation the police began to clear the roadway and asked that the vehicles go to a second location where they would give them the information of all of the parties involved in the accident, that it was later determined that the accident was a hit and run, or FSGI, and the party that arrived after he arrived and claiming that their vehicle was at that scene never went to the second location, when they called later to ask for information about all of the parties involved in the accident they were told to wait for an accident report to be released and to get that information from the report, that he waited the 10 days to get that information and they found out the accident report was incomplete and that he would have to get it from some other means, that they filed all their information with the insurance companies and they were not able to get all of the information, that he began to call the hit and run division to get more information and he was told that it had not been assigned to a investigator and he continued to call since October 25, 2012 and was not given any information or who it had been assigned to, that when he scheduled the meeting with City Council was when the movement began to happen and still today he did not have the

information on anybody or the owner of the vehicle, other than the information that was in the report that appeared to be unreliable about the accident, that it had led to additional expenses for them and still today their expenses had been led to a collection against them. Council Members Hoang, Pennington, Rodriguez, Costello and Bradford absent.

Council Member Christi asked if Mr. Rosette had a picture of the other car or license plate number, and Mr. Rosette stated that he had pictures in his phone and the license plate that was on the vehicle, that the offense report that went along with the accident report was unreliable, that he discovered that the wrecker that was carrying the vehicle that caused the accident left the scene first and they were unable to get complete information from that vehicle or the parties involved. Council Members Hoang, Pennington, Rodriguez, Costello and Bradford absent.

Mayor Parker stated that she had a note from the Police Department, the case was assigned to Officer McClean, HPD Hit and Run Division, and there were no witnesses to the identity of the driver responsible for the accident and that was the challenge, that Sergeant Herndon, HPD, was present and could follow up with Mr. Rosette to make sure he got a complete answer, that she would assume that if he had information on the car and that car was towed from an accident scene by a City of Houston licenses wrecker that they could in fact determine whose car that was and who was driving it and there might be more of an investigation to be done, so if he would allow Sergeant Herndon to visit with him and she would ask that he follow up with her as well. Council Members Hoang, Pennington, Rodriguez, Costello and Bradford absent.

Upon questions by Council Member Green, Mr. Rosette stated that when they were asked to leave the street by the police officer on the scene they complied with the request and went to the second location, that the issue was that the party that claimed ownership of the vehicle was at the scene, his wife noticed that a part of that party or group, who she believed could possibly be the driver, due to his injuries and dishevelment from the accident, that the name of that person or the owner the vehicle was unreliable from the police report because they were not at the second scene. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

Mayor Parker stated that she thought the issue was that they did not know which individual was actually driving the car. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

Ms. Cecile Roeger, 6509A Almeda Rd., Houston, Texas 77021 (713-440-3714) appeared and stated that she was a Dominican Sister, they were partners or supporters of the Faith and Justice Workers Center and she was present today because she was concerned about workers rights and safety on the job, that it was of great concern that the City had no system in place to insure that employers doing business with the City engage in sound business practices, that many violations occurred every week by Houston employers connected with the City through permits and licenses, that as Jose mentioned many of the Council Members had met with members of the workers center and they appreciated their support and interest in changing the way workers were treated and she urged them to develop and put in place a system that held unscrupulous employers accountable for violations and helped responsible businesses grow. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

Mayor Parker stated that they did have the ability to impose sanctions and to prevent people from doing business with the City of Houston who were direct contractors, that she had plenty of authority to do what she needed to do, in her view, for any City contractor who did not pay their workers, that someone who worked in the City of Houston was not considered a City contractor, they put the two issues together, they were separate issues and provided different challenges, that she gathered that they would like the City to pass an ordinance that would prohibit anyone who was not charged with wage theft but convicted of wage theft from getting

City permits or licenses, and Ms. Roeger stated yes. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

Council Member Cohen stated that Ms. Roeger had done miraculous things for the community to make it a better world, that she wanted to thank her for her passion. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

Ms. Karen Easteling, 607 Thornton Rd., No. 105, Houston, Texas 77018 (832-790-9050) had reserved time to speak, but was not present when her name was called. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

Mr./Coach R. J. (Bobby) Taylor, 3107 Sumpter, Houston, Texas 77026 (FA3-4511) had reserved time to speak but was not present when his name was called. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

Ms. Tomaro Bell, 3248 Charleston, Houston, Texas 77021 (713-825-8449) had reserved time to speak but was not present when her name was called. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

Ms. Lauren Barrash, 155 Silver St., Houston, Texas 77007 (713-863-9283) had reserved time to speak but was not present when her name was called. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

President Joseph Charles, P. O. Box 524373, Houston, Texas 77052-4373, appeared and stated that he needed to correct the City Secretary for chopping up his case address repeatedly; that he was the U. S. President and declared martial law upon the City, County and Texas State government system; and continued expressing his personal opinions until his time expired. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

At 3:03 p. m. Mayor Parker stated that City Council was recessed until 9:00 a.m., Wednesday, December 12, 2012. Council Members Adams and Sullivan absent on personal business. Council Member Noriega out of the city on personal business. Council Members Hoang, Pennington, Rodriguez and Bradford absent.

The Houston City Council reconvened at 9:00 a.m., Wednesday, December 12, 2012, with Mayor Annise D. Parker presiding and Council Members Helena Brown, Jerry Davis, Ellen R. Cohen, Wanda Adams, Mike Sullivan, Al Hoang, Oliver Pennington, Edward Gonzalez, James G. Rodriguez, Mike Laster, Larry V. Green, Andrew C. Burks, Jr., C. O. "Brad" Bradford and Jack Christie, D.C.; Mr. David Feldman, City Attorney; Ms. Marta Crinejo, Agenda Director, and Ms. Stella Ortega, Agenda Office, present. Council Member Stephen C. Costello absent on personal business. Council Member Melissa Noriega out of the city on personal business.

At 8:17 a.m. the City Secretary read the descriptions or captions of items on the Agenda.

At 9:09 a.m. Mayor Parker called the meeting to order and stated that the first item on the agenda was a public hearing. Council Members Davis, Adams, Rodriguez, Burks and Bradford absent.

HEARINGS - 9:00 A.M.

1. **PUBLIC HEARING** regarding the designation of **REINVESTMENT ZONE NUMBER TWENTY-FOUR, CITY OF HOUSTON, TEXAS ("GREATER HOUSTON ZONE") - DISTRICTS D - ADAMS; H - GONZALEZ; I - RODRIGUEZ and K - GREEN** – was called. Council Members Davis, Adams, Rodriguez, Burks and Bradford absent.

The City Secretary stated that Mr. Ralph De Leon would make remarks concerning the hearing. Council Members Davis, Adams, Rodriguez, Burks and Bradford absent.

Mr. De Leon stated that in accordance with Section 311.003 of the Texas Tax Code before a municipality could adopt a ordinance creating a reinvestment zone the municipality must hold a public hearing, that the hearing today was regarding the designation of Tax Reinvestment Zone No. 24, The Greater Houston Zone, being an area of approximately 7,109 acres the proposed reinvestment zone was located in a non contiguous geographical area of the City consisting of two sectors, northern and southern sectors, that consisting of 206 acres the northern sector could generally be described as the eastern portion of a central business district currently not already covered by an existing TIRZ; and consisting of 6,902 acres the southern sector could generally be described as the area extending from Old Spanish Trail on the north, Almeda Genoa on the south, Main Street on the west and State Highway 288 on the east, that conditions within the proposed boundaries of the zone could be described as large tracts of underdeveloped and vacant land, that existing public infrastructure could be characterized as a lack of adequate roads, sidewalks, storm sewers, waste water and water systems, that an executive summary describing previous Council actions related to the creation of the Greater Houston Zone and a preliminary reinvestment zone financing plan had been provided to each Council office, that goals and objectives identified in the proposed plan included provisions for the design and construction of public utility systems, major and minor road ways and streets, development of cultural and public facility improvements and homeless housing programs, that the proposed term of the zone was projected to be 30 years, that the City of Houston would participate at 5% of it's tax rate and Harris County would participate at 65% of it's tax rate, that conservative growth estimates projected the zone would generate approximately \$265 million in increment revenue over the 30 year period; that in closing City staff would later today bring forward a recommendation for Council to approve the designation of Reinvestment Zone No. 24. Council Members Davis, Adams, Rodriguez and Burks absent.

Mayor Parker requested the City Secretary to call the public speakers. Council Members Adams, Rodriguez and Burks absent.

Mr. Kirk Farris, 1654 Bonny Brea, Houston, Texas 77006 (832-859-8187) had reserved time to speak, but was not present when his name was called. Council Members Adams, Rodriguez and Burks absent.

Ms. 1403 Nance, Houston, Texas 77006 (713-857-3296) had reserved time to speak, but was not present when her name was called. Council Members Adams, Rodriguez and Burks absent.

Mr. Michael Morton, 1206 Nance, Houston, Texas 77002 (713-459-2665) appeared and stated that he was a native Houstonian, an architect, a small business owner and the proud owner of a historic building in the downtown warehouse district, that he was present to request that the City Council help the Warehouse District to become part of a TIRZ, that as others today would say they should be included in an economic simulation jurisdiction along with the adjacent areas included in TIRZs 3, 21, 23 and possibly 24, that given the same opportunities as their neighbors they could improve their area and remove the blighted conditions that currently exist, that he and others in the area would like to further develop their properties and have the benefit of being within a TIRZ, that they could look at "Exhibit A" that was passed out to the Council Members, along with Mr. Howe's memo, and they could see the area that he was talking about, the Warehouse District, bounded on the north by I-10 and the south by Buffalo Bayou, that it was an overlooked area. Council Members Adams, Rodriguez and Burks absent.

Mayor Parker asked if he was aware that they were creating the TIRZ on behalf of the

County, that the City was not participating and asked if he had conversations with the County about being included in their TIRZ, and Mr. Morton stated that no he had not, that he wanted to thank her for asking because he wanted to be clear, that he was not asking that they be included in part of TIRZ 24, he was asking that they be adopted by TIRZ 3, and Mayor Parker asked some future TIRZ, not the TIRZ they were considering today, and Mr. Morton stated that was right. Council Members Adams, Hoang and Burks absent.

Council Member Gonzalez stated that there were other adjacent TIRZs in the area that perhaps would be a better fit and more appropriate for what Mr. Morton was trying to accomplish and he certainly would be supportive of that, working with any other Council Member that may have some oversight over that particular TIRZ, that he had spoken to Mr. Icken, the Chief Development Officer, and he was aware of the situation and looking to see what could be done with an adjacent TIRZ. Council Members Adams and Burks absent.

Mr. Andy Lear, 710 McKee, Houston, Texas 77002 (713-953-9100) appeared and stated that they were also in the area that seemed to be the forgotten zone, but were in downtown Houston, that they also spoke with the City, after they had signed up to speak at the public session, and they recommended that they look at perhaps joining TIRZ 3, or one of the other TIRZs, that he was the managing partner of an investment group that owned 12.8 acres of property on Buffalo Bayou, at the northeast corner of I-10 and US 59, that the property was the largest contiguous privately owned tract in downtown Houston, that downtown had always been defined as the area between Highways 45, to the west, 59 to the east and I-10 to the north, that this was also the boundary of the Houston Downtown Management District, but they were properties apart; that they were asking to amend the TIRZ boundary to include the Warehouse District properties in downtown Houston so that the boundaries of the northern part of downtown corresponded to the Downtown Management District boundaries; that the other issue was that they were interested in expanding the Downtown Living Initiative, Chapter 38 Program, that they were trying to encourage the development of downtown properties, that it made little sense to provide \$15,000 subsidies to the properties on the south side of Buffalo Bayou and not provide the same to properties north of Buffalo Bayou, that both sides of the bayou were in the Downtown District and both sides paid taxes to the Downtown Management District, that they had been approached by a high end multi family builder who said they would consider their tract for development assuming they were in the 380 Program, that Council Member Rodriguez had been very supportive of their efforts for inclusion of the properties in the Warehouse District and hoped and trusted that the other Council Members considered offering the same support.

Council Member Gonzalez stated that Mr. Lear made some great points and they would continue to work closely with him and others in the area to really enhance the area and foster more economic development and job creation, that they would work to set up a meeting with the decision makers to make it happen.

Council Member Rodriguez stated that he wanted to be helpful as well on this initiative, that he thought it was a great 380 agreement that they had and would like to see it utilized over the area because it was ripe for development, that he would be happy to assist Council Member Gonzalez in any way they could and Mr. Lear's developers as well. Council Member Burks absent.

Mayor Parker stated that as long as every one was clear that this was not the purpose of today's TIRZ. Council Member Burks absent.

Council Member Christi stated that Mr. Lear, in his presentation, made an insinuation that some of that residential incentive, the \$15,000, was it a disincentive north of the bayou, and Mr. Lear stated that it was a disincentive because they did not have it, otherwise this was a very large incentive to build multi family residential housing, and they were part of the Downtown

Management District and they basically represented 150 acres of whatever was north of downtown and were on the eastern side of it, but for some reason the 380 Program never jumped the bayou to take in their area, which for them did not seem to be correct. Council Members Pennington and Burks absent..

Mr. Milton Howe, 908 Wood St., Houston, Texas 77002 (713-857-1554) appeared and stated that he owned the Houston Studios building on the northside of Buffalo Bayou, on Wood Street, that he was part of the Warehouse District and was present merely to reinforce what had already been said, that he sent out a memo that they were anxious for the Warehouse District to become part of a TIRZ, that they had been advised that they really wanted to be part of TIRZ 3, so they would like to see that happen as soon as they could and also to gain access to the 380 Program.

Mayor Parker asked if there were any other speakers on the issue, and hearing none requested a motion to close the public hearing.

Council Member Gonzalez moved to close the public hearing, seconded by Council Member Rodriguez. All voting aye. Nays none. Council Member Costello absent on personal business. Council Member Noriega out of the city on personal business. MOTION 2012-0835 ADOPTED.

Mayor Parker stated that they had created TIRZ 24, that there were representatives of the County present in the audience, that she appreciated working closely with them once again to a mutual benefit.

Mayor Parker stated that they now had the presentation of the Monthly Operations and Financial Report and recognized Mr. Ronald Green, City Controller, and Mr. Kelly Dowe, Director of Finance.

REPORT FROM CITY CONTROLLER AND THE CITY ADMINISTRATION REGARDING THE CURRENT FINANCIAL STATUS OF THE CITY including but not limited to, a revenue, expenditure and encumbrance report for the General Fund, all special revenue funds and all enterprise funds, and a report on the status of bond funds – was presented.

Mr. Green and Mr. Dowe reviewed the Monthly Operations and Financial Report, a copy of which is in the City Secretary's office for review. Council Member Davis absent.

Upon questions by Council Members Burks and Bradford, Mr. Dowe stated that as to Receipt Ambulance Revenues theirs were actually increased on going collections above what they projected for the budget, that they were actually, at this point, above budget, they had budgeted \$45.3 million and now they were at \$46.8 million, and Mr. Green stated that he believed that theirs was based on the first four months of trends, they would probably adjust those numbers as the year went on, but for right now they wanted to remain a little more conservative at this point, based on what actually had come in, that they would follow up with

Council Member Burks and get him that information; and Mr. Dowe stated that the Controller was right at budget, they just felt comfortable with the collection efforts they had instituted thus far and they were a little closer, they dealt with them day to day and he understood the Controller's position in wanting to wait and see a little bit more time, that just with the four months under their belt they felt comfortable going ahead and raising the total year collections at this point, that it was a combination of collection on current services, passed services rendered, getting back into past due collections and with rate charges the higher recoveries from Medicare and Medicaid that they were getting on an ongoing basis, that there was a portion of that was on time based on collections of past due revenue; that it was the City's policy not to deny anyone transport based on ability to pay or any other reason so they absolutely had transports, but he did not think it would be affected by the fee they were charging Medicare, Medicaid and private insurance, and Council Member Bradford asked if in the patients that actually paid did they see a decrease in the number of people who were paying because of the additional cost, and Mr. Dowe stated that they could get that information for him. Council Member Davis absent.

Council Member Bradford moved to accept the Monthly Operations and Financial Report, seconded by Council Member Gonzalez. All voting aye. Nays none. Council Member Costello absent on personal business. Council Member Noriega out of the city on personal business. Council Member Davis absent. MOTION 2012-0836 ADOPTED.

Controller Green stated that Mayor Parker was wearing a nice jersey, and Mayor Parker stated "go Dynamo", that it was a Galaxy Jersey sent to her by the Mayor of LA, that they had a little wager going and the Galaxy won.

Council Member Rodriguez moved to suspend the rules to consider Item Numbers 31 and 31a out of order at this time, seconded by Council Member Gonzalez. All voting aye. Nays none. Council Member Costello absent on personal business. Council Member Noriega out of the city on personal business. Council Member Davis absent. MOTION 2012-0837 ADOPTED.

foresaw any controversy with what was put on their wall signs.

Mayor Parker stated that it was very tightly controlled, it was designed to allow the new Convention Center Hotel to have the very same signage possibilities that the existing Convention Center Hotel had, that it was not applicable to the larger downtown community and it was designed to allow parity between the two hotels.

Mayor Parker stated that there were a number of folks present from Houston First and asked that the Houston First Board stand and be recognized; and that Mr. Mixner, the developer, was present and they understood he had built a first class product in many other places, but this was his hometown and they expected a little extra, that he had actually indicated that so they were looking forward to working with him.

Council Member Rodriguez stated that he also wanted to recognize Mr. Andy Icken and his team, who had done a lot of due diligence on the project, that he wanted to thank everyone and appreciated their working with his office and the City to put on this added jewel.

Council Member Green moved to suspend the rules to consider Item No. 12 out of order at this time, seconded by Council Member Gonzalez. All voting aye. Nays none. Council Member Costello absent on personal business. Council Member Noriega out of the city on personal business. MOTION 2012-0838 ADOPTED.
