

City Council Chamber, City Hall, Tuesday, May 14, 2013

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, May 7, 2013, Mayor Annise Parker presiding and with Council Members Helena Brown, Jerry Davis, Ellen R. Cohen, Wanda Adams, Dave Martin, Al Hoang, Oliver Pennington, Edward Gonzalez, James G. Rodriguez, Mike Laster, Larry V. Green, Stephen C. Costello, Andrew C. Burks, Jr., Melissa Noriega, C. O. "Brad" Bradford and Jack Christie, D. C.; Mr. Harlan Heilman, Division Chief, Claims & Subrogation Division; Ms. Marta Crinejo, Agenda Director and Ms. Stella Ortega, Agenda Office present.

At 1:44 p.m. Mayor Parker called the meeting to order and stated that they had three proclamations this morning and recognized Council Member Brown for the first proclamation. Council Members Davis, Cohen, Martin, Hoang, Rodriguez and Green absent.

Council Member Brown invited Mr. Richard Hill, Executive Director of Mission of Yahweh, to the podium and presented a proclamation to the Mission of Yahweh, and stated they were a non profit homeless shelter founded in 1961 through the vision of the late Helen Gay, better known as Sister Gay, with a mission to help shelter homeless women and children within the Houston community, and Mayor Parker stated that the City of Houston sincerely appreciated the work of the Mission of Yahweh, and therefore, she, Annise Parker, Mayor of the City of Houston, hereby proclaimed May 17, 2013 as Mission of Yahweh Day in Houston, Texas. Council Members Davis, Cohen, Martin, Hoang, Rodriguez and Green absent.

Mr. Hill thanked Mayor Parker and Council Member Brown for giving them this opportunity and for recognizing them, they really did try to make a difference helping homeless women and children in the Houston area, that he wished the problem would go away, but so many people needed their help and they were excited to continue the wonderful work and be able to try to help more people. Council Members Cohen, Martin, Hoang, Rodriguez, Laster and Green absent.

Mayor Pro Tem Gonzalez, Council Members Noriega, Pennington and Costello thanked Mr. Hill and the Mission of Yahweh for all they did for women and children and for their service to the City of Houston. Council Members Adams, Martin, Hoang, Rodriguez and Green absent.

Mayor Pro Tem Gonzalez recognized Council Member Rodriguez for the next presentation. Council Members Cohen, Adams and Green absent.

Council Member Rodriguez stated that it was exciting to make a presentation to a truly admirable organization, the Rod Ryan Show, 95.4 The Buzz, and invited Mr. Ryan and his support staff to join him at the podium and recognized some of the former staff members of the Rod Ryan Show, that since 2004 the show had been on the air and they had also been radio personalities working in the community but committed to raising funds for some incredible organizations, they had raised over \$1.4 million, for many organizations such as M.D. Anderson, The Aids Foundation Houston, The Houston Food Bank and a District I non profit, The Houston Furniture Bank, and presented a proclamation to the Rod Ryan Show, and Mayor Parker stated therefore, she, Annise Parker, Mayor of the City of Houston, hereby proclaimed today as the Rod Ryan Show in Houston, Texas, and thanked them for what they did for their community. Council Members Cohen, Adams and Green absent.

Mr. Ryan stated that they were incredibly humbled to be at Council today, this was a really amazing thing, that it was called the Rod Ryan Show but was a huge team effort, that it meant a lot and he wanted to thank all of his co-workers and the great listeners who had come to join them, that the City took him in in 2004 and they hit the ground running and wanted to do some things for the City, that it had been a great run, that he had never come across more generous

people anywhere he had lived in the Country, that it was truly an honor and thanked Mayor Parker and the City Council. Council Members Adams and Green absent.

Mayor Pro Tem Gonzalez and Council Member Noriega thanked Mr. Ryan for all that he did and for their service to the City of Houston. Council Members Cohen, Adams and Green absent.

Mayor Pro Tem Gonzalez recognized Council Member Costello for the next proclamation.

Council Member Costello invited Father T. J. Martinez to join him at the podium and stated that Cristo Rey Jesuit was a non profit high school, like a charter school, and was run by the Jesuits and Father Martinez, that he visited the high school, which was the converted Mount Carmel High School, in Council Member Rodriguez District I, that they were joined by the partial class of sophomores, that it was an interesting school where the tuition was free to the students, however they had to work for a living, they had corporations that hired the students annually and paid the school for their services, and Mayor Parker stated that they had to have options for their students and the most important thing they could give their young people was an education and the tools to succeed in their adult lives and Cristo Rey certainly did that, and therefore, she, Annise Parker, Mayor of the City of Houston, hereby proclaimed today as Cristo Rey Jesuit Day in Houston, Texas.

Father Martinez thanked Council Member Costello on behalf of Cristo Rey Jesuit, that Council Member Rodriguez was present when he landed in Houston four years ago to start the school, and Council Member Gonzalez had been at different functions that they had, that it had been good to start a school for children that could never afford necessarily a college preparatory school, that really engaged their life and family, and the City, in terms of education reform and following in the footsteps of what KIP and YES Prep had done ten years ago, that he always thought that Texans were a can do type of people and thought outside of the box and Cristo Rey Jesuit was definitely think outside of the box, that they started out four years ago with 60 kids and three years later the school had 400 children at Cristo Rey Jesuit and all of them on a 100% scholarship, they started with a few jobs that would help pay for their education and had jumped to 111 corporate sponsors and now he could tell them that all 400 children had a job and work their way through the school, that he was happy to report to the Mayor and City Council that as of last week, in an area that sometimes showed the statistic for Latin American and African American brothers and sisters of a 60% drop out rate, on June 1, 2013, their first graduating class a 100% of their children would graduate and 100% had been accepted into college.

Council Members Noriega, Rodriguez, Christi, Burks and Adams congratulated Father Martinez and thanked him and Cristo Rey Jesuit for all they did, and Council Member Adams asked to hear from one of the students. Council Member Martin absent.

Ms. Selena Dunbar, a sophomore at Cristo Rey Jesuit, stated that she loved the school mostly because of the work program, she had a wonderful job at Freds Construction and they had taught her so much and she had learned so much there, that going into the working world she was not scared at all, that at the school and the small community she had learned so much and it was a wonderful school. Council Member Martin absent

Father Martinez stated that Selena, this summer, had been invited by Stanford to spend the entire summer with them to study and prepare for eventual matriculation at the university. Council Member Martin absent.

Mayor Pro Tem Gonzalez and Council Members Pennington thanked Father Martinez for all he did for the community and the City of Houston.

At 2:13 p.m. Mayor Pro Tem Gonzalez recognized Council Member Pennington for the innovation and Pledge of Allegiance, and Council Member Pennington invited Reverend Bill Denham, Associate Rector for Caring and Connecting Ministries at Saint Lukes Methodist Church, for the innovation and Council Member Pennington led all in the pledge.

At 2:19 p.m. Mayor Parker requested the City Secretary to call the roll.

Council Members Gonzalez and Burks moved that the minutes of the preceding meeting be adopted. All voting aye. Nays none. MOTION ADOPTED.

Mayor Parker recognized Council Member Gonzalez for a point of order.

Council Member Gonzalez moved that the rules be suspend for the purpose of hearing Ms. Cynthia Sidney and Ms. Shelia Dotson out of order, seconded by Council Member Hoang. All voting aye. Nays none. MOTION 2013-0308 ADOPTED.

Council Member Laster moved that the rules be suspend for the purpose of hearing Mr. Arnoff Burudgunte out of order, seconded by Council Member Hoang. All voting aye. Nays none. Council Member Gonzalez absent. MOTION 2013-0309 ADOPTED.

Mayor Parker stated that she was going to apologize in advance, she had a meeting in her office at 3:00 p.m. and would have to slip away, that she would get as far on the speakers list as she could.

Mr. Barry Klein, 1509 Everett, Houston, Texas 77009 (713-224-4144) appeared and stated that he was with the Houston Property Rights Association and was present to speak against the proposal to approve the BRT line on Post Oak, and asked that they send it back to the Mayor's office and have a first ranked economist, who studied transportation matters, study that proposal, that he suggested that they look at the big picture and not simply looking at a proposal to put, what looked to him, a \$200 million program on Post Oak.

Mayor Parker stated that they always liked to acknowledge the presence of their former colleagues and would note that former Council Member Stardig was present in the Chamber.

Ms. Diane Schenke, 3211 Harrisburg, Houston, Texas 77003 (713-928-9916) appeared and stated that she was President of the Greater East End Management District and was present to speak on Item No. 39 on the agenda tomorrow, which was to approve an interlocal agreement between the City of Houston and Harris County for the construction of a trails and on road bike lanes, that this construction would be part of an overall effort, under the City of Houston Tiger Grant, to achieve interconnected bike ways throughout the inner core of Houston, more over Harris County would be constructing 10 foot sidewalks connecting all of the East End Rail stops to the existing Harrisburg trail, making it safe and easy to use the trail to access the light rail, and she had distributed maps that showed them the extent of the construction that would be undertaken, that the Interlocal was a great partnership between the County and the City, that the County had bids on the project and was ready to award the contract at next Tuesday's Commissioners Court meeting, if the City did not approve the Interlocal agreement tomorrow there would be at least a three week delay for a project that was ready to go.

Mayor Parker stated that she personally was very exited to see this move forward and was glad to have her present.

Council Members Rodriguez, Pennington and Gonzalez thanked Ms. Schenke for all of her hard work on this project and for working with the County.

Council Member Noriega moved that the rules be suspended for the purpose of extending time for questions of Ms. Diane Schenke, seconded by Council Member Hoang. All voting aye. Nays none. Council Member Gonzalez absent. MOTION 2013-0310 ADOPTED.

Upon discussion and questions by Council Members Christi and Noriega, Ms. Schenke stated that what the County was doing would serve as match, that to get the federal grant they had to come up with their own money that they were spending, so they were counting what the County had done as match for the federal grant. Council Member Gonzalez absent.

Ms. Jaime Brewster, 1712 Kipling, Houston, Texas 77009 (713-594-7596) appeared and stated that she was with TIRZ 19, the Upper Kirby District TIRZ, and was present to speak on behalf of the extension and expansion of the Uptown TIRZ 16 to include the restoration and revitalization of Memorial Park because it was both prudent and essential to Houston sustaining and maximizing one of Houston's greatest quality of life assets, Memorial Park, the proposed extension of TIRZ 16 would fund a master plan for the park, which would serve as a road map for the future park improvements for the years to come; that City of Houston created tax increment reinvestment zones had a proven track record of success in park redevelopment and revitalization. Council Members Davis, Gonzalez and Noriega absent.

Mayor Parker thanked Ms. Brewster for what she did in the Upper Kirby District, that she rightly pointed out that their largest and most productive tax increment reinvestment zones had all taken on park revitalization and they recently approved Levy Park, that they were doing, under absolute control of the Parks Department, approving every step, but through the TIRZ, and Ms. Brewster stated yes, and Mayor Parker stated that this was actually a routine step that they were taking. Council Members Gonzalez and Gonzalez absent.

Council Member Cohen stated that she would add that there were few people in the City who knew more about TIRZs and thanked Ms. Brewster, that she understood the problems and concerns that people had, and Levy Park was a perfect example. Council Members Gonzalez and Gonzalez absent.

Ms. Rega Richardson Waggett, 228 W. Cowan Dr., Houston, Texas 77007 (713-834 -7741) appeared and stated that Memorial Park was in need of help, there had been discussion about the need to restore the ecology of the park, the reforestation and also proposed that there was a need to restore the recreational activities at the park as well for all people to enjoy the park and it's amenities, and welcomed TIRZs funding, that she was particularly interest in the pool and fitness center at Memorial Park. Council Members Adams and Gonzalez absent.

Mayor Parker and Council Members Pennington and Burks thanked Ms. Wagget for caring about Memorial Park and the opportunities to swim in Houston. Council Members Adams and Gonzalez absent.

Ms. Hanna Waggett, 228 W. Cowan Dr., Houston, Texas 77007 (713-834-7741) appeared and stated that during her senior year in undergrad she wrote a feasibility report regarding ways to increase the hours of the Memorial Park pool at minimum cost, which she had shared with the City of Houston's Aquatic Division, that she would be happy to share her report via email and had a hard copy with her today if they wished to see it, that she believed that passing the TIRZ 16 could greatly benefit the Memorial Park area. Council Members Adams and Gonzalez absent.

Mayor Parker stated that she would be happy to receive her report, and Council Member Christi stated that she was singing the right song, so keep it up. Council Members Adams and

Gonzalez absent.

Mr. Clyde Bryan, 10808 Pepper Ln., Houston, Texas 77079 (713-545-4878) appeared and stated that he had some grave concerns concerning Memorial Park, that the Ima Hogg Family gave that part to the City of Houston, which meant the citizens of Houston, that he thought that Ima Hogg would roll over in her grave if she knew what they were about to do with that gift that was given to the citizens of Houston, that they were going to turn it over to a political subdivision with no elected officials and they were going to have control of the park and when that board changes out in two or three years or whatever they were not going to have any control over it, that he thought there should be public hearings before they do this and a public vote, that he thought if the City was so broke that they could not take care of the park then maybe they ought to ask Harris County to help them with the Park, as they had with other parks in the City of Houston. Council Member Gonzalez absent.

Mayor Parker stated that just repeating something that was not true, over and over again, did not make it true, that nothing happens in Memorial Park that was not signed off on by the Parks Director and he in turn was responsive to the City Council, and they had a public hearing on the issue. Council Member Gonzalez absent.

Council Member Hoang stated that what Mr. Bryan stated was not true, the TIRZ were not elected officials, all of their budget and major improvements had to be submitted to the Council and passed by the Council.

Council Member Laster stated that the park would not be given to anybody, the park would continue to be a City of Houston park owned, operated and managed by the City of Houston, the only thing that was being proposed was that the boundaries of the increment reinvestment zone would extend around the outside of the park so that the monies of the tax increment reinvestment zone could be spent inside the park for the benefit of all of the folks. Council Member Gonzalez absent.

Council Member Noriega stated that they did need some of the resources that they were talking about and in addition they may need another way to do this, but she was uncomfortable about the level of transparency with the conservancy and would feel better if they had a little tweaking of this mechanism. Council Member Gonzalez absent.

Dr. Alkebu Motapa, 5022 Crosby, Houston, Texas 77021 (713-741-5150) had reserved time to speak, but was not present when his name was called. Council Member Gonzalez absent.

Ms. Cynthia Sidney, 5515 Irish Hill, Houston, Texas 77053 (832-969-1140) appeared and stated that she was present because they all wanted safe neighborhoods and good parks and good schools, all the things that helped built strong and vibrant communities, that year after year hundreds of huge office buildings in Houston were not taxed anywhere close to their true market value, that the City and HISD had lost over \$1.5 billion in tax revenue since 2005 due to a broken commercial tax appraisal process, that she would ask the City government to take a closer look at this issue and prioritize it on the City of Houston's agenda. Council Members Pennington and Rodriguez absent.

Mayor Parker asked members of the audience not to clap and cheer, that standing was a perfect way of showing their support; that frankly this was an issue that came up right after she became City Controller and one of the first long meetings that she had with Mayor Bill White and they brought the Director of the Harris County Appraisal District in and Mayor White plopped down annual reports of several refineries just outside of Houston and it showed what they were telling their stock holders what their facilities were valued at and then he plopped down the

HCAD appraisal and it was pennies on the dollar, that the problem was that it was a requirement in State law as to how they appraised these properties, they had to attack it through State legislators, that she was happy to stand with HOPE and with TOP, that this was something that put an unequal burden on their residential property owners and for anybody who might be listening, they could only value the bricks and sticks, what was the cost of building this building, they were not allowed, under State Law, to value the commercial value of a building, so she may be \$300 million for it because she was betting on future rent and all sorts of other things, but when she goes to HCAD she forces them to lower that value to maybe \$200 million because that was what would cost her to rebuild the building, that it was a very unfair process and she was so glad that they were taking this up. Council Members Adams, Pennington, Gonzalez and Rodriguez absent.

Council Member Gonzalez stated that through the efforts of the janitors, during their situation, a light was lit on this as well, so he wanted to point out the importance of that effort, so hopefully they could continue to move this forward. Council Members Adams, Pennington and Rodriguez absent.

Council Member Christi asked if there was also a law that when they have it appraised for 5 or 10 years, was there a law that said that at the closing the sellers paid the difference of the appraisals, was there not a catch up of taxes, and Mayor Parker stated that what happens when a building changes hands they actually then had a new starting point, that there would be an announcement in the newspaper, a building changed hands for x amount and the next day they were in with a protest to say this was what the real value was, that it was based on provisions in State law, on what they based their appraisal, that residential property was generally appraised very close to it's market value, commercial property was often very much under valued, there was no mandatory disclosure in Texas either. Council Members Adams, Pennington and Rodriguez absent.

Ms. Shelia Dotson, 5714 Cebra, Houston, Texas 77091 (832-258-3361) appeared and stated that she lived in the Acres Home area and was a concerned resident, when the owners of the high end office buildings failed to pay their fair share in property taxes, she felt the consequences, that she rode all over Houston and saw the difference in the Acres Home communities and other communities, they were a community that relied on City services, when the budget was cut they felt it, there had been a lot of City budget cuts over the last several years, that she sees it in the illegal dumping and the heavy trash that was not collected, that there was money out there, if the owners of the high rise buildings would pay their fair share there would be enough money not just to solve the problems she mentioned but to encourage the growth and economic opportunities in Acres Home, that was the future that she wanted for her community, so she was asking the Mayor to take the issue of the property tax fairness seriously and prioritize it on the City's agenda. Council Members Adams, Pennington and Rodriguez absent.

Mayor Parker stated that she agreed 100% and was glad that she was present, that it was the schools that actually suffered the most. Council Members Adams, Pennington and Rodriguez absent.

Council Member Noriega stated that she brought attention to something very important, there were some things that really nobody but government could do, and the idea that taxes were an investment in her community was an idea that needed to be talked about more. Council Members Adams, Pennington and Rodriguez absent.

Council Member Green stated that if there was an issue with regard to the statute maybe in the next session they could make this a part of their Legislative agenda, that they look at the issue, if it was a State issue, maybe that was a way they could attack it. Council Members

Adams, Pennington and Rodriguez absent.

Mayor Parker stated that they had to fix it at the State level, that the City Attorney and the Finance Director met with the head of the appraisal district last week and she met earlier this week with their appointee to the appraisal district, Mr. Holtzapple, one way they could help was to provide legal support to the appraisal district, often they were out gunned by tax protest lawyers and they had discussed whether they could provide research and legal assistance and help in other ways while they were trying to get this fixed at the State level. Council Members Adams, Pennington and Rodriguez absent.

Council Member Davis stated that he would get with State Representative Turner and State Senator Whitmire to get an understanding of what had happened in the past and how they would move forward. Council Members Adams, Pennington and Rodriguez absent.

Mr. David Atwood, 1802 Kipling St., Houston, Texas 77098 (832-693-5710) appeared and stated that there were a lot of people in the City of Houston that were concerned about inequity, that he was on the Executive Committee of the Houston Peace and Justice Center, an organization who promoted human rights and economic justice, that he strongly believed in the concept of the common good, few people discussed the City budget as a vehicle for serving the public good, but that was certainly what it was, that today he felt a moral obligation to comment on the systematic under appraisal and under taxation of high end office buildings in their City, that citizens who relied on a City budget that served the public good needed them, that he would ask that they prioritize the issue of tax inequality on the City's agenda. Mayor Parker, Council Members Adams, Pennington and Rodriguez absent. Mayor Pro Tem Gonzalez presiding.

Ms. Cheryl Anderson, 918 Heights Blvd., No. 7, Houston, Texas 77008 (713-206-7264) appeared and stated that she was present on the issue of property tax fairness, commercial property owners were not paying their fair share, as they had heard in the past few minutes, that she wanted to reiterate the loss to the schools and children, that she was a retired HISD teacher for over 20 years, that schools were facing serious budget costs, that she was present to stand up for the little guys, every child, wage earner and on a fixed income in Houston, that she was asking that the City put the property tax fairness on their agenda to do something about. Mayor Parker, Council Members Cohen, Adams, Pennington, Rodriguez and Laster absent. Mayor Pro Tem Gonzalez presiding.

Mr. Joe Ballard, 6302 Rocky Nook Dr., Humble, Texas 77396 (281-850-0388) appeared and stated that he was present about stray dogs at his mother's house, who was 80 years old, that Mr. Chris Newport and ACO did an excellent job and he wanted to thank them. Mayor Parker, Council Members Cohen, Adams, Pennington, Rodriguez and Laster absent. Mayor Pro Tem Gonzalez presiding.

Mayor Pro Tem Gonzalez, Council Member Davis and Council Member Noriega thanked Mr. Ballard for the feedback and for his concern for his community. Mayor Parker, Council Members Cohen, Adams, Pennington, Rodriguez and Green absent. Mayor Pro Tem Gonzalez presiding.

Mr. Arnoff Burudgunte, 2008 Kirby Dr., Houston, Texas 77019 (713-942-1460) appeared and stated that his friends were Steven Huddenbock and Erin Senuvough, they were fifth grade students at Rive Oaks Elementary, a Vanguard Magnet School in HISD, as they progressed in this government dominated era the need for a voice in government became greater and greater, in these times of crises it became also necessary to acquire money, these two needs were bound to clash, and when they would, only problems would arise, a corporation would pay millions of dollars to elect a congressman, why, because this politician was bound to support

that corporation's interest at the Capital, that no where in the system were the people involved and the idea of representation, that was a rally cry for the American Revolution, and the principles that their fore fathers held dear, would fade into history and the right to enjoy would disappear from their society, that many politicians say that they intend to stop money from commanding government, they receive many votes from small businesses, but when they were elected they forget the promises that put them in office, when they campaign for reelection they take all their money from political action committees, many famous congressmen had been elected this way, the President had an executive organization to support such companies, which included Boeing and Chevron and to give them an advantage in the Federal Government, that he had forgotten the promises that he made four years ago, and a letter from the League of Women Voters, written last month, had not refreshed his memory, the Declaration of Independence, the document that founded this Nation stated that "governments have been instituted among men, deriving their just powers from the consent of the governed", thus he must ask the question, did they consent to the current governments methods, that he had been told that anything could make a difference, perhaps it was not true, but if the American public voiced their opinion, nearly 300 million people demanded to be heard, then the Capital would listen, and this government, of the people, by the people and for the people should not perish from the earth. Mayor Parker, Council Members Cohen, Adams, Hoang, Rodriguez and Green absent. Mayor Pro Tem Gonzalez presiding.

Upon questions and discussion by Council Members Noriega, Christi and Laster, Mr. Burudgunte stated that they did not have any grudge against the City Council; that all three of them wrote the statement, that they were a delegation from River Oaks Elementary School, that with him at the podium were Steven Huddenbock and Erin Senuvough and their mentor was Ms. Tina Salem, they were in the Fifth Grade and this was part of a project that summed up all of the things they had done in elementary school called "Exhibition", and Mayor Pro Tem Gonzalez stated he was sure they would get an "A+" for this. Mayor Parker, Council Members Cohen, Adams, Hoang, Rodriguez and Green absent. Mayor Pro Tem Gonzalez presiding.

Mr. Dub Wright, 10962 Shadow Wood, Houston, Texas 77043 (713-725-9345) appeared and stated that for the past twenty years Wrenwood had been working on their flooding issue and two weeks ago, he was not watching, all of a sudden it came up, they passed something on Item No. 27, where they approved the funding for their Street and Traffic Control and Storm Drainage, that he appreciated that, that it was something that was part of the Legacy Program that the previous Council put in and promised they would follow through and they did so, that yesterday he met with Mr. Kevin Coffee, Public Works, who gave him some wonderful information that really helped him on what they were going to be working on and Mr. Gary Norman, Public Works, had been an extremely wonderful resource for them to have, they were very excited in Wrenwood, and thanked them for following through. Mayor Parker, Council Members Davis, Cohen, Adams, Rodriguez, Laster, Green and Noriega absent. Mayor Pro Tem Gonzalez presiding.

Council Members Pennington and Brown stated that it did make a difference, they worked long and hard on a lot of projects, a lot of which they did not get done, but it was nice to know when people appreciated when it did get done. Mayor Parker, Council Members Davis, Cohen, Adams, Rodriguez, Laster, Green and Noriega absent. Mayor Pro Tem Gonzalez presiding.

Mr. Jose Moreno, 826 Hillock Bluff, Houston, Texas 77073 (314-761-3770) had reserved time to speak but was not present when his name was called. Mayor Parker, Council Members Davis, Cohen, Adams, Rodriguez, Laster, Green and Noriega absent. Mayor Pro Tem Gonzalez presiding.

conversation about freeways and what kind of risk they were at on the freeways and actually today the Houston Chronicle had an article about texting and she wanted to give them some backup information from Texas Transportation Institute, because she disagreed with some of the remarks made by the Chronicle by the National Insurance Institute, that she wanted to bring home the dangers of the roadway, she brought a vest for the Mayor that they were required, by federal law, to wear if they were out on the roadway and the speed limit was over 55 miles an hour, for a little bit of money the public could get ready right now, the temperature, for the first time, was going to go over 90 degrees this weekend, and in SafeClear they found out that the number of incidents just start tripling as the heat went up, and for just a little bit of money and repairs, such as replacing old hoses, looking at their tires, not running on empty and having a bottle of water in their vehicle was very important as the temperatures went up, and could save them from being out on the roadway that was very risky, that if they were breaking down, move to the shoulder, do not take a chance, like the people did this weekend, to push their car off of the freeway, and absolutely never stand behind their vehicle or in a moving lane of traffic, people tended to feel relaxed whenever they were out on the freeway just because they were not used to that kind of element and they did not really see the danger that they were in, and if they had learned anything with SafeClear, they learned just how seriously dangerous that was, that she also wanted to say that for SafeClear, they were prepared and knew what was coming in the summer and they also had an evacuation plan that they used in Rita that was very effective to help the public in retrieving their vehicles, that she also wanted to give them an update of the many other services that SafeClear did, like providing towing on the HOV lanes, they had saved Metro about \$400,000 a year because they did that service on the HOV and HOT lanes, that as Council Member Gonzalez had heard she was a big proponent for an ordinance on texting and hoped that House Bill 63 passes, that she was a little concerned because it had been sitting in committee since April 22, 2013, but texting and driving was something that they saw, one on one, and it was very dangerous, that she was in an accident herself where she was rear ended by a young man who was texting, to the public, what they were being told about texting, was really true and real. insurance, and other required contract documents to the City; holding the bidder in default if it fails to meet the deadlines; providing funding for engineering, testing, CIP Cost Recovery, and contingencies relating to construction of facilities financed by the Water & Sewer System Consolidated Construction Fund - **DISTRICT E - MARTIN – (This was Item 45 on Agenda of May 8, 2013, TAGGED BY COUNCIL MEMBER DAVIS)** - was presented. All voting aye. Nays none. Council Member Rodriguez absent. ORDINANCE 2013-0475 ADOPTED.

MATTERS TO BE PRESENTED BY COUNCIL MEMBERS

Mayor Parker stated that there was a break week next week, they set it aside for budget review, that it was a break week from City Council, not a break week from work because there would be a lot of budget presentations.

Council Member Bradford thanked Mayor Parker for what she just mentioned, a couple of years ago they established a week for a Council break to have time to take the budget, which she released yesterday, and go through it; that colleges and universities had recessed for the summer, for the most part, and he encouraged college students to avoid danger zones, risky activities, that the independent school districts would recess for the summer in a couple of weeks, that Houston had experienced a 33% increase in gang memberships and the risky time period for students now moved from 3:00 p.m. to 6:00 p.m. to a much broader window of opportunity for child predators, juvenile criminal activities and juvenile victimization, that the vulnerable time slot had now expanded, that the answer was more summer and after school programs for their boys and girls, that they must make funding out of school time programming a top priority and move the total after school strategy under the public safety umbrella; . Council Members Brown, Hoang, Pennington, Rodriguez and Noriega absent.

Council Member Martin announced events he attended or would be attending; and stated that he wanted to congratulate his oldest son, David, and all the graduates of 2013, that David was graduating from the University of Texas, with a degree in Biomedical Engineering, he would be starting Baylor College of Medicine in July and they were pleased and proud of the young man that he had become; that this was National Police Week and would congratulate his colleague to the right; that he wanted to congratulate Ms. Maria Casanova, who was selected as a Texas Municipal Courts Association 2012 Jurist of the Year for her distinguished service and outstanding contributions to the administration of justice. Council Members Brown, Hoang, Pennington, Rodriguez and Noriega absent.

Council Member Laster congratulated Council Member Martin on his son's graduation; and announced events he attended or would be attending. Council Members Brown, Hoang, Pennington, Rodriguez and Noriega absent.

Council Member Costello stated that he and the Mayor had a number of discussion about the challenges they had moving forward and even highlighted some of them in her press conference relative to ongoing concerns about employee benefits, since their budget was driven 70% by employee salaries and benefits, that he was pleased that Mayor Parker was making a commitment to set aside money now for maintenance, where they had deferred maintenance, that he wanted to encourage his colleagues as they moved forward during the budget process to recognize that they had these challenges and were going to continue to have these challenges moving forward, he encouraged his colleagues to attend the committee meetings. Council Members Brown, Hoang, Pennington and Rodriguez absent.

Mayor Parker stated that the intention, of course, was to pass the budget on June 19, 2013, the second opportunity to see it, that she appreciated Council Member Costello referencing the Maintenance and Renewal Line, the reason it was not larger, and could and

should be larger, was that they put aside capital dollars to do the catch up, this line item was designed to make sure that they did not have to in the future use capital items because they had not maintained their facilities in tip top condition. Council Members Brown, Hoang, Pennington and Rodriguez absent.

Council Member Gonzalez announced events he attended or would be attending; that he wanted to commend Judge Barbara Hartle and her team at the City of Houston Municipal Courts for the mini court clinics, which were designed to help citizens better understand how to handle court business and to check on the status of any potential pending cases. Council Members Brown, Davis, Martin, Hoang, Pennington, Rodriguez, Laster and Bradford absent.

Mayor Parker stated that she appreciated Council Member Gonzalez mentioning the Municipal Courts and the outreach they were doing, that it was really unprecedented for Municipal Courts to set up the community meetings where they could come in and no one was going to arrest them and no one was going to give them a hard time, just explain what they needed to do to get out of whatever jam they were in with Municipal Courts; that she wanted to welcome visitors in the Chamber, students from Carl Wunsche, Jr. High School, Spring, Texas, they were glad to have them in the Chamber. Council Members Brown, Davis, Martin, Hoang, Pennington, Rodriguez, Laster and Bradford absent.

Council Member Adams stated that she wanted to give condolences to Mr. James Brook, a Precinct Judge in the District D Community, for the passing of his wife, Mrs. Marva Brooks; announced events she attended or would be attending; that today was C. J. Messiah last day with the Mayor's Office detail, that she wanted to thank him for all of his years of service to the City of Houston and HPD. Council Members Brown, Davis, Martin, Hoang, Pennington, Rodriguez, Laster, Burks and Bradford absent.

Council Member Green announced events he attended or would be attending. Council Members Brown, Adams, Martin, Hoang, Pennington, Rodriguez, Laster, Burks and Bradford absent.

Council Member Davis announced events he attended or would be attending; and stated that this weekend the Wheatley High School girls, in Fifth Ward, captured their first UIL Track Championship, that it was the first time in history for the young ladies at Wheatley and wanted to thank them for being great student athletes. Council Members Brown, Martin, Hoang, Pennington, Rodriguez, Laster, Burks and Bradford absent.

Council Member Cohen announced events she attended or would be attending. Council Members Brown, Martin, Hoang, Pennington, Rodriguez, Laster, Burks and Bradford absent.

Mayor Parker thanked those Council Members who were able to attend the Annual Police Week Memorial Service, which happened to be last Friday night, they brought it indoors and it was not at the police memorial, but still a very fine and moving event. Council Members Brown, Martin, Hoang, Pennington, Rodriguez, Laster, Burks and Bradford absent.

Council Member Christi announced events he attended or would be attending. Council Members Brown, Martin, Hoang, Pennington, Rodriguez, Laster, Burks and Bradford absent.

Council Member Gonzalez announced events he attended or would be attending. Council Members Brown, Martin, Hoang, Pennington, Rodriguez, Laster, Burks and Bradford absent.

Council Member Adams announced events she attended or would be attending. Council Members Brown, Martin, Hoang, Pennington, Rodriguez, Laster, Burks and Bradford absent.

Mayor Parker stated that she wanted to wish Council Member Green a very Happy Birthday tomorrow. Council Members Brown, Martin, Hoang, Pennington, Rodriguez, Laster, Burks and Bradford absent.

Council Member Costello stated that his office would be happy to work with Council Member Davis office to try to do some of the things he was trying to accomplish in his district; that he wanted to wish Mayor Parker a Happy Birthday on Friday. Council Members Brown, Martin, Hoang, Pennington, Rodriguez, Laster, Burks, Noriega and Bradford absent. NO QUORUM PRESENT

Mayor Parker stated that she formally wanted to wish goodbye and God speed to Sergeant Clyde C. J. Messiah, who had been with the Houston Police Department for a very long time and had headed her security detail and worked security for a number of other Mayors and other dignitaries; that they were cautiously optimistic about the recovery of Jaime Garcia, Public Works employee, who was struck by lightning on Friday, that he was still in critical condition and would urge everybody to keep him and his family in their prayers. Council Members Brown, Martin, Hoang, Pennington, Rodriguez, Laster, Burks, Noriega and Bradford absent. NO QUORUM PRESENT
