City Council Chamber, City Hall, Tuesday, May 28, 2014

A Regular Meeting of the Houston City Council was held at 9:00 a.m. Wednesday, May 28, 2014, with Mayor Annise Parker presiding with Council Members Brenda Stardig, Jerry Davis, Ellen R. Cohen, Dwight Boykins, Dave Martin, Richard Nguyen, Oliver Pennington, Edward Gonzalez, Robert Gallegos, Mike Laster, Larry V. Green, Stephen C. Costello, David W. Robinson, Michael Kubosh, C. O. "Brad" Bradford and Jack Christie, D.C.; Mr. Dave Feldman, City Attorney; Ms. Marta Crinejo, Agenda Director and Ms. Stella Ortega, Agenda Office, present.

At 8:19 a.m. Ms. Anna Russell, City Secretary, read the descriptions or captions of items on the Agenda.

At 9:03 a.m. Mayor Parker called the meeting to order and stated that for those standing they were welcome to be in the chamber within the limits that the Fire Marshall allowed, they could not stand in the doorways, there was overflow seating in the Council Chamber in the Annex, they had been having some video feed problems, not in the City Hall building, but into the Annex, but thought that had been resolved, to those who may be trying to watch in the building if the normal municipal channel was not working they could try channel 1215, they were trying to send a duplicate feed to make sure that everybody who wanted to watch had the opportunity to watch and they would monitor the Annex Chamber to make sure the feed continued; for those who had not experienced a consolidated Council meeting they would begin with as much of the normal agenda of the City as they could, and at approximately 9:30 a.m. they would then break for the public session of City Council. Council Members David and Bradford absent.

At 9:05 a.m. Mayor Parker recognized Council Member Pennington for the innovation and pledge of allegiance. Council Members Davis and Bradford absent.

At 9:07 a.m. The City Secretary called the roll. All present.

Council Members Gonzalez and Bradford moved that the minutes of the previous meeting be adopted. All voting aye. Nays none. MOTION ADOPTED.

Council Member Gonzalez moved that the rules be suspended for the purpose of considering Item Numbers 1, 1a, 1b, 66, 66a, 67 and 67a at this time, seconded by Council Member Bradford. All voting aye. Nays none. MOTION 2014-0439a ADOPTED.

Mayor Parker stated that they would try to get through all of the consent agenda if they could.

HEARINGS - 9:00 A.M.

1. **PUBLIC HEARING** regarding the designation of a Tax Abatement Reinvestment Zone for Breckenridge Group Houston Texas, LP - **DISTRICT I – GALLEGOS** – was called.

Ms. Gwendolyn Tillotson, Deputy Director, stated that the public hearing this morning was to consider the establishment of a Tax Abatement Reinvestment Zone for Breckenridge Group Houston Texas, LP, doing business as Aspen Heights, which was a requirement pursuant to Chapter 312-204 of the Texas Tax Code, that the zone must be established prior to the adoption of an ordinance to enter into a Tax Abatement Agreement, the statute further described that the governing body may not adopt an ordinance designating an area as a reinvestment zone until a public hearing had been held, the public hearing was published in the Houston Chronicle on May 19, 2014, that pursuant to Chapter 312-204 of the Texas Tax Code

a municipality may enter into a tax abatement agreement in writing, with the owner of real property that was located within a reinvestment zone, that Section 312-202 of the Tax Code defined the criteria for designating a Tax Abatement Reinvestment Zone, one of which is that the area be reasonably likely to attract major investment in the zone that would be a benefit to the land, the request of Council was to designate in the approximate 7.7 acre site, located at 1901 Cullen Boulevard, Houston, Texas, which was in the proximity of Interstate 45 and Cullen Boulevard, as the Aspen Heights Houston Reinvestment Zone for Tax Abatement purposes, the action would enable City Council to consider approval of a Tax Abatement Agreement for Aspen Heights to support the investment of a multistory student housing development project, that Aspen Heights was a National Student Housing Developer and property manager with headquarters in Austin, Texas and constructed American Craftsman Style Homes with all of the amenities of a luxury apartment complex, the company had completed, or had under construction, 20 projects throughout the Country, that the Aspen Heights Houston proposed student housing development was the first project for the company in the City and would be constructed on a 7.7 acre site within a high poverty census block group, it was located within a quarter mile of the University of Houston and a half mile from Texas Southern University, across from the former Finger Showroom and Warehouse, it was planned as a four story, wrap style, development and would comprise 238 one to four bedroom units consisting of 739 beds. that Aspen Heights had received letters of support from a variety of sources, including University of Houston, State Representative Carol Alvarado and the Eastwood Community, in the letter of support the University of Houston Associate Vice Chancellor wrote that part of the university's mission was to engage a diverse population of students in a real world setting, and while the university continued to develop facilities on campus, they valued the importance of private organizations developing the surrounding communities, that additionally the letter stated that the university supported the City in the development of housing projects that complemented their community, that Aspen Heights planned to invest more than \$63 million in real and personal property, with much of the investment for building and related structures, that the proposed start date for the construction phase was June 2014, with completion targeted for August 2015, consistent with the Fall 2015 school year, the project investment in the building would generate approximately \$18 million of tax revenue over a 30 year period, in addition to the building improvement, which included 175 bicycle rack spaces for student bicycles, plus a B Cycle Station accessible to both the public and students. Council Members Davis and Cohen absent.

Ms. Tillotson further stated that the company planned to expand a portion of the investment to construct improvements in and around the pedestrian realm of the underpass at I-45 and Cullen Boulevard to enhance pedestrian safety and mobility, that Aspen Heights approached the City in February 2014 and submitted an application on April 4, 2014, the real property investment, that was the subject of Tax Abatement was approximately \$56 million, and represented the incremental value above the property based value, the projected taxable value was estimated at \$45 million, which was approximately 80% of the real property investment, excluding the land, the site was located within a high poverty census block group and thereby designated as an enterprise zone and a reinvestment zone by the State of Texas, and as such was eligible to receive a maximum tax abatement of up to 90%, that based upon a 90% rate the City tax to be abated was approximately \$250,000 to \$400,000 annually over the 10 year period for the term of the complete 10 years, that Aspen Heights presented, in its request for an abatement, a required investment yield by investment partners of 8%, that requirement was due in part to the blighted nature of the site and surrounding area, the high poverty levels and need and enhancements to create a safe pedestrian realm, the grant of the abatement was to allow the project to meet its target yield, however, to ensure the abatement did not exceed beyond what was required, the proposed agreement included a recapture provision that would allow the City to recapture taxes abated to Aspen Heights if the project exceeded its performance yield target, in conclusion the Office of Economic Development respectfully requested their support for a 10 year, 90% abatement, of incremental taxes and property taxes generated by Breckenridge Group, also known as Aspen Heights Houston. Council Members Davis and Cohen absent.

Mayor Parker stated that this would be marketed to students, but it was not restricted to students, and Ms. Tillotson stated, yes, that under the Fair Housing Act, although the target was the University of Houston and Texas Southern University student population, they had to make available the apartments to anyone who wanted to rent. Council Member Cohen absent.

After discussion by Council Members Gallegos, Robinson, Stardig, and Boykins, Mayor Parker stated that no one had signed up to speak at the public hearing and asked if there was anyone present specifically to address this issue, and hearing none requested a motion to close the public hearing.

Council Member Boykins moved to close the public hearing, seconded by Council Member Green. All voting aye. Nays none. MOTION 2014-0440 ADOPTED.

Mayor Parker stated that Council Members should have received the speakers list for the public session, and now as a reminder to everyone who was present for the public session, there were very strict rules of decorum in the City Council Chamber and they certainly expected the same kind of respect for speakers that they had the last two public sessions, they had a remarkable civil exchange of very divergent views and knew that she and all of the City Council appreciated that, they would try, as they worked through the speakers list, to give enough names in advance so those who were not able to be present in Chamber would have an opportunity to be present as their names were called, if they were not present exactly when they called their names, but came to the Chamber, they would have an opportunity to speak, those who had previously spoken the rules of the Chamber required that they be moved to the end of the list, and they did not catch everyone last week, but had tried to do a better job of moving those who had previously spoken to the end of the list, that she apologized if someone was not caught, but there was a significant volume of folks who had asked to speak today, that it did not matter how much time they signed up for, because of the rules of Council they would be limited to one minute because of the volume of speakers, and Council Members would have a cumulative one minute for each of the public speakers. Council Member Pennington absent.

Council Member Bradford stated that before they got into the public speaking list he wanted to clarify the fact that there was no proviso in the rules which permitted a Council Member to unilaterally extend a speakers time, and Mayor Parker stated no, that technically the Council Member was supposed to ask a question, a Council Member did not actually have time to give a speaker, they tended to be fairly loose on that but considering the volume of speakers if called on it the Chair would enforce that. Council Member Pennington absent.

Mr. Wayne Webb, 3910 W. which seemed a little odd to him, that right now the extensions to the actual roads it would service, the communities, there was nothing being done, that it was traffic, flooding and a multitude of things. Council Members Boykins, Pennington, Gallegos and Green absent.

Ms. Melanie Blake, 4107 Pine Blossom Trl., Houston, Texas 77059 (832-724-3308) appeared and stated that she was one of many outraged citizens opposed to the development by Trendmaker Homes and Fidelis, that many of them bought their homes with the expressed understanding that the land would remain undeveloped in perpetuity, they had learned that Fidelis paid \$11,000 per acre for the property, they knew that City Council was considering granting Trendmaker a subsidy, that according to an article in the Houston Chronicle, for \$9.8 million to \$30 million, that as taxpayers they object to incurring the developers profit at their expense, that it seemed counterintuitive that the City would be contributing more than twice the value of the original land purchase to build 700 homes on 412 acres of land, while bulldozing over 138 acres of natural prairie potholes, these potholes with diverse soil soaked up rainwater like a sponge full of water and support a variety of parks and wildlife, once these were eliminated they could not be restored. Council Members Boykins, Pennington and Green absent.

Council Member Stardig asked Ms. Blake who made the guarantee that the property would remain undeveloped, and Ms. Blake stated that when a lot of residents in Pine Brook bought their land they were told by Friendswood Development that the land would remain undeveloped in perpetuity, Exxon had signed a deed restriction, that she had it in writing and would be happy to bring it to them.

Mr. Willie Holder, 1322 Heathwick Ln., Houston, Texas 77043 (713-822-1283) appeared and stated that he was President of Trendmaker Homes, a Houston company of 43 years and appreciated the opportunity to do this development in the City of Houston, and for the instrument created by the Legislature, which put the City of Houston on a partial equal footing with land developments in the County, they were not asking for a subsidy, they were going to create tax revenue after they build the roads, pay for the roads, build the houses, pay for the houses, only then would they be reimbursed for any cost of construction of roads, it was a great opportunity for the City of Houston to expand its base, it would be a beautiful community consistent with the surrounding neighborhoods in every way.

After questions and discussion by Council Members Pennington and Boykins, Mr. Holder stated that they had given consideration to the traffic and there would be some improvements made and at the same time the traffic studies showed that it was completely within limits of what was considered normal or acceptable.

Mayor Parker asked Mr. Holder to address the issue of whether the property was deed restricted in any way, she knew there were Council Members concerned about that, and Mr. Holder stated that at one point in time there was a deed restriction on the property for it to be commercial, that Fidelis went through the process of changing those deed restrictions to include residential in lieu of warehouse district or other purposes for the land that would have been inconsistent with the surrounding properties, that it was very much accepted, and Mayor Parker asked if it was not in any way restricted as a natural reserve, and Mr. Holder stated no, that it was reserved for other purposes.

After further questions and discussion by Council Members Martin, Costello and Gonzalez, Mr. Holder stated that he was aware of a letter from the Pine Brook Community Association drafted in May 29, 2008, urging Exxon Mobile to do the right thing and left the deed restriction to allow single family residential development of the 412 acres, with numerous signatures, that the development had addressed infrastructure related issues through numerous reviews by both the water district engineers, as well as their engineers, that he

believed that within that district he thought it was engineered with twice the requirements for drainage that was required in other areas; that they would fund 100% of everything and only being reimbursed once the ad valorem tax base was created.

Mr. Collin Pier, 5507 Gracefield Manor Ct., Katy, Texas 77450 (281-675-3727) appeared and stated that he was with Trendmaker Homes as well, that improvements were being done, the widening of Clear Lake City Boulevard, intersection improvements offsite at Space Center and Clear Lake City Boulevard, a traffic signal at El Dorado, all of those had been submitted to the City and an approved traffic study had been received back from Public Works Department, that to respect to the drainage they were under that most stringent criteria, the Clear Lake City Water Authority, who was about double the detention rate of Harris County Flood Control or the City of Houston, that they had a letter from the Pine Brook Community Association from 2009 that said that the 412 acres had been foul, expect for grazing for many years, when Pine Brook was developed in the early 1990s, John Hammond and Friendswood Development Company told the residents that the lands adjacent to Pine Brook and North Folk would be developed for residential purposes. Council Member Boykins absent.

After discussion by Council Members Costello and Martin, Mr. Pier stated that this was in WCI MUD District. Council Members Davis and Boykins absent.

Mayor Parker stated that she thought they had exhausted the speakers on the Trendmaker and Clear Lake issue, if they had signed up they had spoken over them to speak now, that the motion was that they now take up the item. Council Members Davis and Boykins absent.

69. ORDINANCE approving and authorizing Economic Development Agreement between the City of Houston, Texas, TRENDMAKER CLEAR LAKE LLC, and CLEAR DORADO LAND ASSOCIATES, L.P. for the Construction of certain public works and improvements - <u>DISTRICT E - MARTIN</u> – (<u>This was Item 26 on Agenda of May 14, 2014, TAGGED BY COUNCIL MEMBER MARTIN</u>) - was presented. All voting aye. Nays none. ORDINANCE 2014-0528 ADOPTED.

Council Member Davis stated that he would release his tag on Item No. 27 and to allow the City Council to vote on the item, that he wanted to remind the Houston Sports Park and the Management Company that this was a sports park, and not just soccer park.

27. ORDINANCE appropriating \$1,964,149.22 out of Parks Consolidated Construction Fund to fulfill the obligations of the City in the Purchase and Sale Agreement to acquire approximately 32.187 acres of property to be added to the Houston Sports Park located on South Kirby Drive Approved by Ordinance 2014-464 - <u>DISTRICT D – BOYKINS</u> – was again before Council.

Council Member Boykins stated that he was in support of Council Member Davis and agreed with him in terms of the use of the facility. Council Member Martin absent.

A vote was called on Item No. 27. All voting aye. Nays none. Council Member Martin absent. ORDINANCE 2014-0529 ADOPTED.

Mr. Victor Martinez, 2008 Crockett, Houston, Texas 77007 (713-899-5956) had reserved time to speak, but was not present when his name was called. Council Member Martin absent.

Mr. Pete Porcarello, 1719 Crockett, Houston, Texas 77007 (713-412-2580) appeared and stated that the presentation of the First Ward Historic District had caused much confusion with the homeowners, the historic home preservation team led by Dominic Yap and Evan and Laura

Michaelides had been at the root of the problem, when they first approached him to promote the historic district an appointment was made to see his home, the team called it an investment opportunity, they had been so bold and persistent that they even approached him at the City Hall Annex during the last public hearing, they told him they would make a deal with him if he had \$80,000 to restore his home. Council Member Martin absent.

Council Member Kubosh asked Mr. Porcarello if he felt he understood the process, and Mr. Porcarello stated yes, he understood, and Council Member Kubosh asked if there was any confusion in his mind of whether or not he had a ballot or a survey to fill out and did he turn in the survey the City sent him, and Mr. Porcarello stated yes, that he did what he was told to do, and Council Member Kubosh asked Mr. Porcarello if he voted for or against the historic district, and Mr. Porcarello stated against. Council Member Martin absent.

Council Member Gonzalez stated that there was different contact information that said who they could call if they had any questions and told them where they could get information on the ordinance, plus the public hearings and asked if he had read any of that information when he signed it, because it did say different ways to contact the Planning Department, and Mr. Porcarello stated that there were other flyers that he had gotten in his mail box from the team and that really confused him, and Council Member Gonzalez stated that he was referring to what the City of Houston had sent. Council Member Martin absent.

Ms. Dorothy Andries, 632 Pizer, Houston, Texas 77009 (713-869-5670) appeared and stated that she was present to consider a "no" vote for the High First Ward proposal to make the First Ward a historical district, that she was told by Mr. Dominick Yap that he would cast her vote, also through purchase of houses in the First Ward that he could arrange votes in his favor, that initially she voted yes, later on May 10, 2014, after learning the people in this area were not given a complete and truthful statement concerning their vote and houses, she asked her "yes" vote to be changed to "no", that it was very important to all in the First Ward to be told and represented truthfully. Council Members Boykins, Martin and Green absent.

After discussion by Council Members Stardig and Gonzalez, Council Member Stardig stated that she had a lot of questions and asked if they could answer them before they voted. Council Members Boykins, Martin and Green absent.

Ms. Paula Andries, 4827 Caris, Houston, Texas 77091 (713-459-8297) appeared and stated that they had just heard from her mother, that this was whether this area should or should not become a historic district, but whether there was deception and misrepresentation by its supporters, that an application for what was being call High First Ward Historic District was submitted to the City in early December 2013, owners of property in that neighborhood had until February 24, 2014 to return their ballots to the City, that her mother received and returned the survey, but never received a voting ballot, however according to the redistricting map her property showed as a yes vote, if she never received the voting ballot then who voted for her, that she was now being threatened by a renovations developer, Mr. Dominic Yap, who had been stalling to purchase her property since November 15, 2013, that she was wondering how many elderly couples had been bullied or pressured into selling their home so that their plat of land could also be added to the list of supporters for the historical designation. Council Members Davis, Boykins, Martin, Laster and Green absent.

Upon questions and discussion by Council Members Gonzalez, Stardig, Kubosh and Pennington, Council Member Gonzalez stated that he knew there was some confusion because some community people were calling it a ballot or a survey, but the form that was singed had the information on the ordinance and who to contact for information, and asked Ms. Andries if they had contacted anyone and say that they were confused if it was a ballot or vote, because it was pretty descriptive, and Ms. Andries stated that they were told that it was a survey only and

that 30 days after that date a voting ballot would be sent so that it could either be a "yes" or "no" vote and they did not receive that voting ballot, that there was a block party by supporters called First City District, they even walked door to door in support of this, and they said that there would be a voting ballot within 30 days after the survey was completed and that was what they did not receive. Council Members Davis, Boykins, Cohen, Martin and Green absent.

Mr. Robert Griffith, 1610 Alamo St., Houston, Texas 77007 (713-446-5416) had reserved time to speak, but was not present when his name was called. Council Members Davis, Boykins, Cohen, Martin and Green absent.

Ms. Gloria Vera, 109 Richelieu Ln., Houston, Texas 77018 (713-681-3136) appeared and stated that she was present in support of establishing the First Ward as a historical district, they owned two houses, her brother inherited the first one, he sold it and they put three four story high rises in one lot, that her next door neighbor was a garage, two floors and a balcony, her neighbor sold hers to Dominic Yap and it was the most beautiful house that they had ever seen, there were original floors, windows, paneling, everything, as pretty as those you find in the Heights, that she had one that she was going to sell to Dominic and hoped to see the same thing. Council Members Davis, Boykins and Martin absent.

Mr. Tim Ruiz, 1407 Holly St., Houston, Texas (832-876-0701) appeared and stated that he was member of Houston's own, four time Grammy Award winning band, La Mafia, that Houston, Texas was their proud home base and he recently moved to the First Ward in October, he was present to voice his support in designating a historic district in the First Ward, he was not present to voice any rage for the developers, though after hearing the opposition he heard that there had probably been some pressure to lead them to feel how they did, that he would say if they did not preserve a piece of Houston's past in the First Ward it would turn into a generic place lacking character and triumph and some of that would quickly lose its value within 10 to 15 years, but more than that if they did not preserve their past they would simply lose a big part of Houston's history in this particular area of Houston, that he could see a lot of positive things that had happened. Council Members Davis, Boykins and Martin absent.

Upon questions by Council Member Gonzalez, Mr. Ruiz stated that there was data to support both sides, he believed that much good stuff had happened with what the developers had brought to the place and thought they had added value to what hopefully would be designated as a historical district, but also there was data to support the opposite side, basically if they designate a historic district it would add value to what they were bringing, and Council Member Gonzalez stated that they understood about property rights, but also about his rights to protect the investment that Mr. Ruiz had made and to protect the quality of life of what was immediately around him. Council Member Davis absent.

Mr. Lee Decker, 2006 Crockett, Houston, Texas 77007 (832-419-0849) appeared and stated that those who he had spoken with knew that he was not against historic districts, but he was in opposition of this one, after its initial defeat a bizarre configuration had been drawn that did not resemble a district, and actually singled out properties like his, allowing them to be surrounded by multi storied townhouses, this would reduce values by discouraging buyers and affecting the marketable ability of the structures they surround, that no other historic district looked like this one or allowed such a scenario, he did not believe any one present, including those in support, ever thought they would be debating a proposed historic district that looked like that, the ordinance was broken and in need of repair, the ordinance did include one final step and that was for the vote of the Houston City Council, that the boundary design of this proposed district was flawed, please vote against the district. Mayor Parker and Council Member Davis absent. Mayor Pro Tem Gonzalez presiding.

had heard other opponents who he did not think their concerns were as valid, that he did attempt to talk to the Director and advocate his position very strongly to see what could be done, that he wanted to thank him because he thought he had done a great job of stating his position of opposition to this. Mayor Parker and Council Member Davis absent. Mayor Pro Tem Gonzalez presiding.

Ms. Valorie Decker, 2006 Crockett, Houston, Texas 77007 (832-419-0857) appeared and stated that historic district designations encouraged the protection of neighborhoods within distinct historic character, the proposed High First Ward designation would not accomplish this, it was too late, new development had already redefined the character of the neighborhood and would continue to do so, there would be no continuity of buildings, no unification, no rhythm of street scape and no neighborhood historical character preserved, the purpose of the historic district was not to impede any one's property rights, its purpose was to preserve their history, however, she was not allowed to exercise her property rights, she was impacted financially and the neighborhoods historic character was not being preserved, the neighborhood community voted against the designation, please do not approve the High First Ward Historic District. Council Member Davis absent.

Upon questions and discussion by Council Members Stardig and Costello, Ms. Decker stated that she and her husband bought the property on Crockett in September, they were going to demolish the home and build two townhomes, they were going to sell one and move in to the other, they went to tear down the home and were not able to, this was three months after they purchased the home, that was when the petition was filed, they were not in the business of historic rehab, they found a real estate broker, she had been a real estate appraiser for seven years, they now had the property on the market, she had not had an offer to purchase the home, she had a whole lot of calls, when she tells people that the property was in a pending historic district, they did not want anything to do with it because there were townhomes going on right next door and then two doors down, that she knew an argument for historic districts was that property values would increase, that was true, but in this particular case they did not have a true defined district, they were going to drive down the street and there was going to be a townhouse, a townhouse, a really neat historic home and a townhouse, and two homes, they were not going to know they were in the historic district, so for their house the property value was not going to increase because it was not surrounded by like properties, that the lot she was on is on the north side of Crockett. Council Members Davis and Kubosh absent.

Ms. Tania Rivas, 1701 Crockett, Houston, Texas 77007 (939-828-8840) appeared and stated that she was present to represent her parents, Carolos and Flora Mina Rivas, who came to Houston in the 1960s and did not know very much English and did not have a dollar to their name, but they built a community mom and pop grocery store in the heart of First Ward, where she grew up, that was her neighborhood, that she had seen some changes, her parents worked very hard, the developers were pushing to tear down their community, they saw dollar signs where she saw her home, she wanted progress but not at the expense of the senior citizens that had worked their long and hard lives building a legacy for her, for their children, just so they could line their pockets with outrageous profits, where would those seniors go when they did not have a home, when they were displaced. Council Members Davis and Kubosh absent.

Upon questions and discussion by Council Members Christi, Gonzalez and Stardig, Ms. Rivas stated that she was in favor of preserving the history that was very important to Houston, it was an undiscovered gem, there was so much yet to be learned about that part of the neighborhood, that she owned the property now, this was her homestead. Council Member Davis absent.

Mr. Dominic Yap, 1847 Dart, Houston, Texas 77007 (832-531-3911) appeared and stated that he had heard his name mentioned numerous times, but there were bigger issues here,

one, Houston was his City and the Historic First Ward was his home, that it would be ironic that when they visited the Historic First Ward that they only see the richer broke part, two railway lines and an ocean of three to four story townhomes, yet nothing of the 100 plus year neighborhood and its Victorian cottages and bungalows, he wished their grandchildren would be able to see and appreciate the truly historic First Ward and not just read about it in the Houston Chronicle; two, their future, in the Historic First Wards most homes were around 1,200 square feet with a 2,000 to 3,000 square foot yard and many beautiful mature trees, since last year townhome builders had been demolishing homes indiscriminately, as well as cutting down many of the 70 year to 100 year old trees within the properties, at an average of one home every two weeks, that he wished they could all contribute responsibly leaving behind a greener environment for a much more pleasing neighborhood for their future generations, especially this close to downtown. Council Members Davis, Cohen and Bradford absent.

Council Member Gonzalez stated that Mr. Yaps name came up earlier and thought there was something to the effect that he was trying to deceive people or trying to take advantage of people and wanted to give him an opportunity to speak to that. Council Members Davis, Cohen, Green and Bradford absent.

Mr. Yap stated that in response to the Andries family, mother and daughter, he would like to state that he offered to buy her property in August 2013 when no one wanted her property because she was selling it to high a value, he offered and it was graciously accepted and was supposed to be going to closing, that was before any of the historic district came about, so the story was vastly distorted, that they were supposed to be going to closing this afternoon and they were most probably not going, that he had his legal attorney on this case, the story was vastly different, and Council Member Gonzalez stated that Mr. Yap was indicating that there was no attempt to deceive any one on his part, and Mr. Yap stated correct, that he had his three minute speech to be distributed. Council Members Davis, Cohen, Green and Bradford absent.

Mr. David Hille, 1710 Ansbury, Houston, Texas 77018 (713-551-1350) appeared and stated that he owned properties in the First Ward and had lived in the Sixth Ward for 15 years, that he was a real estate agent and had seen the changes to many of the areas that had become historic districts and these were becoming destination neighborhoods, which allowed a character and a diversity of housing that was in jeopardy of being lost, and that would be sad, that the homes in this district were part of their history, they were rail workers, the City seal had a railcar on it and these were homes of the people who worked on the rail, typically, in that neighborhood, that the character was in desperate jeopardy of being lost, think of Montrose, if Montrose was nothing but townhomes it would be so sad that they would lose that community, that now there were historic districts in place, Montrose and throughout the Heights, and this neighborhood was deserving of that as well. Council Members Davis, Cohen, Green and Bradford absent.

Mr. Evan Michaelides, 1810 Summer St., Houston, Texas 77007 (713-802-1699) appeared and stated that he was the applicant, he and his wife owned two historic properties within the proposed district, they stood on the threshold of an exciting moment in the First Ward, though many residents had long lamented the bulldozing of so many of their neighborhoods historic buildings, few believed that anything could be done about it, today they had new hope as the proposed High First Ward Historic District, the product of nine months of tireless effort by a team of determined volunteers, had reached the final step in hits formation, requiring a 60% super majority, while counting non votes as "no", created a high bar for a district application to surmount, it was not easy and the resulting map was not what any of them would have chosen, but it was what emerged from the process they had, and it would have the intended effect, the irreplaceable historic homes of the district would be saved and would preserve much of the historic character and charm of their neighborhood, that having met all of

the requirements, they the 67% respectfully ask Council to keep faith with the by approving this application. Council Members Davis, Cohen and Green absent.

Mayor Parker asked Mr. Michaelides if he followed the property as presented and followed all of the rules as they currently existed, and Mr. Michaelides stated that was right, it was kind of a heavy process and they had to do a lot of learning, knocking on doors, public meetings and outreach, but yes they went through everything, and Mayor Parker stated that a promulgated district that had been created was actually an outgrowth of compromises that were made at the Council table where when they actually passed the original ordinance Council wanted the ability to shrink the district to accommodate the wishes of as many of the residents as possible, but she understood that he worked under the rules that he was given, and Mr. Michaelides stated that they worked within the rules they were given and actually the process that they had, he thought, the difference between the district as proposed and as it came out, came out because when they were the applicant in that situation, they were basically in the position of guessing where their support was going to be, and they really did not know until further down the process when people's attention was grabbed by the vote. Council Members Davis, Cohen and Green absent.

After further discussion and questions by Council Members Kubosh, Gallegos, Gonzalez and Pennington, Mr. Michaelides stated that part of the process was that in response to the initial process where they found where their support was. Council Members Stardig, Davis, Boykins, Cohen, Pennington, Gonzalez and Green absent.

Ms. Laura Michaelides, 1810 Summer St., Houston, Texas 77007 (713-802-1699) appeared and stated that she and her husband owned two property's within the proposed district, five years ago when she was looking for a space for her business she was charmed by the First Wards turn of the century cottages and it had really broken her heart to see the wholesale decimation of parts of the neighborhood, that their district effort was a small step towards stemming this tide, that just as they recognized the role that their community's diversity played in making Houston great, so should they celebrate the diversity of the architecture in their neighborhoods, the blending of old and new contributed to a rich and varied urban landscape, any time they demolished a structure, that could be reused or repurposed, they erase a visible and valuable part of Houston's history and they lose another tangible reminder of their past. Council Members Davis, Boykins, Cohen, Pennington and Gonzalez absent.

Ms. Velma Martinez, 2998 Crockett, Houston, Texas 77007 (713-899-5956) appeared and asked if they used the survey why did they have to make a website, obviously the applicants and their group felt that the survey, and what the City was providing, was not good enough, they had to change it into their own terms, in addition in the ordinance, where did it say to advice the applicants and their group that they could form a company, purchase property, so they could control the support, and threaten home owners with a lawsuit if they did not sell, a copy had been provided to each of the Council Members from an email correspondence from Mr. Dominic Yap to Ms. Dorothy Andries, and their sister, Ms. Margaret Potroski, that by allowing this group to get away with this would cause an open invitation for other citizens to follow this behavior, she was not only asking that they vote "no" to High First Ward, it would be unfair. Council Members Davis, Pennington and Gonzalez absent.

Upon questions by Council Members Kubosh, Bradford and Gonzales, Ms. Martinez stated that Council Member Gonzalez kept referring back to the survey, he said everything was recorded there, to call the City Planning Department, so if the City Planning Department and the Historic Department was there to answer their questions why did they step in and make a whole new website called "Massive Confusion", and changed verbiage, who else was out there who was a victim like Ms. Andries, who had a sale pending. Council Member Pennington absent.

Mayor Parker stated that it was clear that what Ms. Martinez was referring to was a citizen generated website, not the City of Houston, or the City's correspondence, that the survey said, and she would be happy to share this with the Council Members, "I have read the preservation ordinance, or a summary of it, and understand how it would affect my property, yes, I support designation of my/our property, no, I do not support designation of my/our property", that it was very clear, that respectfully, she knew there had been confusion out there, but lots of citizens did things that they could not control and they did their best to provide very clear information from the City. Council Member Gallegos absent.

After further discussion by Council Members Gonzalez and Kubosh, Mayor Parker stated that when they drafted the ordinance, the reason that the form did not say ballot, it said survey, was that it was not a vote of the citizens that determined whether there was a historic district, it was a vote of Council, and the word ballot was deemed confusing because they would believe that they cast a ballot and their vote stood, and it was intended to be very clear that it was the vote of the City Council that made the final determination. Council Member Cohen absent.

68. RESOLUTION designating the High First Ward Area of the City of Houston as a Historic District DISTRICT H - GONZALEZ - (This was Item 12 on Agenda of May 14, 2014, TAGGED BY COUNCIL MEMBERS GONZALEZ and STARDIG) - was presented. Council Member Cohen absent.

After discussion by Council Members Gonzalez, Costello, Robinson, Bradford, Stardig, Pennington, Boykins, Council Member Costello moved to amend the resolution by substituting a new map, seconded by Council Member Pennington. Council Member Cohen absent.

After further discussion by Council Members Bradford, Costello and Gonzalez, Council Member Costello moved to postpone Item No. 68 until later in the meeting. Council Member Cohen absent. MOTION 2014-0463 ADOPTED.

At 11:15 a.m. Mayor Parker stated that they were back to the public session, those were the only two other agenda items, that as a reminder to the audience, they did not normally have a public session on the same day that they did the business meeting of City Council so they were jumping around a little bit. Council Members Cohen and Gonzalez absent.

Mayor Parker stated that as a refresher of the rules of City Council, there were strict rules of conduct in the Council Chamber, if they approved of the speaker they were welcomed to stand or raise their hands, they were not allowed to make noise, speak, cheer or clap, and certainly not in an attempt to drown out the other speakers, they would try to call speakers in advance so if they were not in the Chamber they had an opportunity to get to the Chamber, if they had spoken in the last two weeks they were at the very end of the list, it was not generally the Council's intention to move people up, they really wanted to hear from folks who had not had an opportunity to address the City Council previously. Council Members Cohen and Gonzalez absent.

Council Member Laster moved that the rules be suspended for the purpose of hearing Mr. Avie Kupfer and Mr. Larry Dodgen out of order, seconded by Council Member Costello. Council Members Cohen and Gonzalez absent.

Council Member Bradford stated that he would re-urge his colleagues, one it was a hardship for Ms. Russell, City Secretary, for them to start juggling these names, and under plain fundamental fairness to the people who called and got on the list in this order, that he thought they should try to leave the people in the order that they were on the list to the extent that was possible, that he supported his colleague moving two speakers, he was not opposed to that, but was encouraging the rest of them to try to leave the list in order.
