

City Council Chamber, City Hall, Tuesday, April 7, 2015

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, April 7, 2015 with Mayor Annise Parker presiding with Council Members Brenda Stardig, Jerry Davis, Ellen R. Cohen, Dwight Boykins, Dave Martin, Richard Nguyen, Edward Gonzalez, Robert Gallegos, Mike Laster, Larry V. Green, Stephen C. Costello, David W. Robinson, Michael Kubosh, and C. O. "Brad" Bradford, Jack Christie D. C., Harlan Heilman, Division Chief, Claims & Subrogation Division; and Marta Crinejo, Agenda Director and Stella Ortega, Agenda Office, present. Council Member Oliver Pennington absent on personal business.

At 1:41 p.m. Mayor Parker called the meeting to order and stated they would start with the presentation portion of the City Council meeting and recognized Council Member Costello with the first presentation. Council Member Davis, Boykins, Laster, Green, Robinson, Bradford and Christie absent.

Council Member Costello stated he was honor to have a proclamation to honor Houston Police Officers who served in the United States Armed Forces and normally they would do this during Veteran's Day but something came up that he thought was unique with some of the young men that work in the Houston Police Department that he wanted to highlight and approximately 1900 Veterans currently serve the Houston Police Department and want to recognize this group of individuals after hearing about four officers and invited Officers Jimmy Connelly, Kenneth Elliot, Eric May and Jack Simmerson to the podium and wanted to tell a little bit of their story; three of these Officers were in high school and graduated together, they all joined forces together, all Mariner, all signed up to police officers right around the same time and two of them are actually partners; so what they did, he thought was profound and they were helping a Houston Citizen, Mr. Calmer which was present today and was invited to the podium and who was a World War II Veteran which was visiting with the officers about his time in the service and his metals he had won during his service and the medals were in a show box and these officers got together and raised money to have something that was formal to present the metals in and Council Member wanted to formally thank the individuals for what they did and recognize the World War II Veteran Mr. Calmer and to thank them for their services and therefore Mayor Parker proclaimed April 7, 2015 as HPD Armed Force Veteran's Day in Houston Texas. Mr. Calmer and the four Officers were given a standing ovation. Council Members Davis, Boykins, Laster, Green and Christie absent.

Council Member Kubosh stated nurses were present today to honor and recognize Nursing Quality and Patient Safety Council at Memorial Hermann Hospital and the National Day was going to be May 5, 2015, The National Nursing Quality and Professional Practice Council was being recognized today even though it was a month in advance and invited the nurses to the podium; you don't appreciate something until you have to have it and when you are sick, in the hospital and depending on someone to give you proper medicine, proper therapy or proper things that needed to be done and thank God for nurses who follow the orders but sometimes have to get a little tough to get you out of bed to walk and to get you taken care of, nurses are highly trained, licensed professionals who combine knowledge, compassion, empathy and service to others and are committed to deliver quality care to patients and to ensure that quality health was invaluable, accessible, affordable and accountable and Mayor Parker stated even though a month early she proclaimed May 5, 2015 as Nursing Quality and Professional Practice Council Day in Houston Texas. Council Members Davis, Boykins, Laster, Green and Robinson absent.

Council Member Cohen invited Rebecca White the CEO of Houston Area Women's Center to the podium and stated it was always a privilege to present this to her; the work of the Houston Area Women's Center always goes on and had come a long way since 1977 in those days in terms of particularly for women and convinced people that if a woman was raped, it wasn't because of what she was wearing or what part of town she was in and clearly wasn't her fault and now everyone gets it and those that don't end up in jail, so today she was wearing teal because this was wearing Teal Day and the proclamation states since being founded by a group of dedicated volunteers in 1977, the Houston Area Women's Center has helped survivors of domestic and sexual violence restore hope and find healing every year, the center serves more than 60,000 adults and children through its programs and additional 30,000 adults and children through its education programs and on any given day more than 120 people would call the Houston Area Women Center 24 hour hotline and on April 7, 2015 the Houston Area Women's Center would encourage the entire community to join forces to end domestic violence by wearing teal and the City of Houston commends the Houston Area Women's Center for their leadership and extends best wishes for the successful observance awareness month and therefore she Mayor Parker proclaims April 7, 2015 as Wear Teal Day in honor of Sexual Assault Awareness Month in Houston Texas. Council Member Davis absent.

Mayor Parker stated there were three presentation this week but there are additional people on the chamber and advised Members of Council that they were not present to say anything ugly but present because on a nationwide basis they are acknowledging the many service volunteers across the community and invited the members to the podium; that there are number of service group that operate in the U.S. and has a Federal Agency that coordinates the service organization; National Service Members include AmeriCor, NNC, Senior Corp and some others but the people behind her get up every day and find things to do to make Houston a better place and volunteer time and energy to serve the greater good for communities and Mayors around the country have been asked to pause and recognize Mayor's Day of National Service and on April 7, 2015 Mayors across the nation would participate in the National Mayor's Day of recognition for the Nation Service spotlighting the value and impact of National Service to cities and in hope to inspire more residents to serve their communities and the City of Houston commends National Service Members for their contributions and therefore she Mayor Parker proclaimed April 7, 2015 as Mayor's Day of Recognition for National Service in Houston Texas.

At 2:30 p.m. Mayor Parker recognized Council Member Christie for the invocation and the pledge of allegiance.

At 2:31 p.m. the City Secretary called the roll. Council Member Pennington absent on personal business.

Council Member Kubosh moved that the previous minutes for March 24-25, 2015 and March 31- April 1, 2015 be delayed for one week and seconded by Council Member Stardig, all voting aye, nays none. Council Member Davis absent. **MOTION ADOPTED**

Council Member Green moved that the rules be suspended for the purpose of adding Ms. Casey Morgan to the Agenda list of speaker and seconded by Council Member Boykins, all voting aye, nays none. Council Member Davis absent. **MOTION 2015-0225 ADOPTED**

The City Secretary began calling the list of speakers.

Dr. Mitch Young, 1302 Hyde Park, 77006, (713)825-9669 appeared and stated he was present discussing concerns of Item 68 Hyde Park Parking and the owner of the automobile

shop causing congestion was on the radio this morning talking about not having enough parking for his employees that were 21 employees for two or three bays was interesting, and the public space used for private business with off the street parking and the cars were in various states of disrepair and some of them even had service hangers on them and the entire block were used to store the cars and the residents can not full access spaces to their homes because of the space being used for private business. Council Members Davis, Gonzalez, Green and Christie absent.

Dr. Sharon Young, 1302 Hyde Park, 77006, (713)825-9669 had reserved time to speak but, was not present when her name was called. Council Members Davis, Gonzalez, Green and Christie absent.

Mr. Shawn Grimm, 1316 Hyde Park Blvd, 77006, (281)236-6694 appeared and stated he was present to discuss the issue with parking in his street and parking in his neighborhood parking was difficult and they need residential parking permits on his street; the vehicles from the business does have more than enough parking for his employees including their customers, however the business chooses to park unregistered vehicles and other junk cars that are bumper to bumper around the block and prohibiting the freedom of residents any use of the street parking and requested Members of Council to approve Item 68 . Council Members Stardig, Davis and Christie absent.

Ms. Marlene Gafrick, 945 Bunker Hill, 77024, (713)586-6229 appeared and stated she was present in support of Item 21 and 22 and representing Houston Real Estate Council that is composed of people from the retail office multifamily residential sector and joint referral involves a lot of work in terms of when people are redeveloping their property and they need to abandon streets or need to move easement which was a length processes and the item significantly improves the process and in fact would shorten the time frame. Council Member Davis, Cohen, Nguyen and Chrisite absent.

Ms. Casey Morgan, no address, no phone number appeared and stated she was the Vice-President for Government Affairs for the Greater Houston Builder Association and was present in opposition to an ordinance and the proposed change to chapter 33 of the Code of Ordinance that would require a Planning Commission Member position to be filled by a Super Neighborhood Alliance Member from being involved in the Planning Commission which they already do but what they opposed was giving special treatment to one organization over the many others across the City of Houston and making their selection a requirement for years moving forward and Planning Commission Members should serve as Houston residents by bring their professional expertise and credential to the table not by their association and her request was not to oppose any involvement from the neighborhood alliance that's not what she was asking but request was the Council consider the present that sets moving forward and consider opposing giving one organization over the many others. Council Members Boykins, Martin, Nguyen and Christie absent.

Ms. Yvette Diaz, 6674 Rockbridge Ln., 77023, (713)923-1814 appeared and stated in the spirit of Easter she brought Members of Council some candy and she was present for something fun and presented information to Council Members about their First Annual Texas Taco Festival and the information on where the festival was located, the time and some of the bands that would be playing and invited Members of Council and their staff to the festival which included arts, music, jewelry, games for the kids and great food. Council Members Boykins , Nguyen, Green and Christie absent.

Ms. Necauje Turner, 900 Bagby, 77002, (832)393-0988 appeared earlier for a special presentation from the Mayor. Council Member Boykins, Nguyen, Green and Christie absent.

Ms. Kimberly Tutcher, 1 Shadder Way, 77019, (713)521-7474 appeared and stated that she and her husband brought a lot in 2002 and the house was completed in 2007 and in November of 2011 the City of Houston Public Works Department constructed a new drainage in the area and during the construction, a curb in front of their home was crushed and has been crushed since 2011 and there has been standing water everyday whether it has rained or not; they have been contacting the City of Houston and the contractor since late 2011 and found that no service request was issued and she was requesting Members of Council to have Public Works to prioritize this to a high level of repair. Council Members Nguyen and Christie absent.

Ms. Pauline Cheatham, 2307 Eden, 77026, (832)731-3438 appeared and stated her concern was the Area Agency and they did repairs on her home and had not completed, they first came out in November 2014 on which they came back five times for the same issue and that issue has not been resolved and some of the repairs were simple things like caulking and she was present requesting the Mayor and the Area Agency to change contractors but the agency already told her she had to keep the contractors that were given to her and she also has concerns of over grown lots around her property which she has reported but afraid of snakes and mice to come on her property and she had concerns that the owner of property wanted to put "hay" on his property which was a residential area, concerns of sewage smell in her area, concerns for her water meter that was higher than her yard and she can't mow in that particular area and would Lorraine and Hardy streets be reopen. Council Members Stardig, Nguyen and Christie absent.

Mayor Parker stated if she would take her list of concerns to Ms. Rhonda Saunter she would get Ms. Cheatham in touch with the right department. Council Members Stardig, Nguyen and Christie absent.

Mr. Steven Williams, no address, no phone had reserved time to speak but was not present when his name was called. Council Members Stardig, Nguyen and Christie absent.

Mr. Chris Shephard, 7630 Fawnridge, 77028,(713)633-0473 appeared and presented information to Council to show what he was about to speak on and stated he was presented because of Homestead, the neighborhood street was right next to this neighborhood and they were building an overpass or almost completed it and part was closing the railroad crossing, so a lot of people in this area of the neighborhood were having problems on the decision to do that and requesting that the City take back the right and leave that part open and the prints that he already provided, shows there was already a railroad on one side of the neighborhood and on the other side there was another overpass so one every side of this neighborhood there was either an overpass or railroad. Council Members Stardig, Cohen, Martin, Nguyen, Costello and Christie absent.

Mayor Parker stated their building an overpass over the railroad so that the neighborhood would not get land locked, so that the residents would never going to get stuck by a train again. Council Members Stardig, Cohen, Martin, Nguyen, Costello and Christie absent.

Mr. Darrien Johnson, 306 North No.39, 77009, (281)717-3718 appeared and presented a proposal to Members of Council and stated he was with the Houston Pathfinder and was present to make a proposal concerning Houston's 45 landfills and started this project because he wanted to make a difference and prove to people that Houston's pollution would no longer be a burden and his proposal saves the oil and preserves the oil for future generations. Council Members Stardig, Cohen, Martin, Nguyen, Costello and Christie absent.

Ms. Patsy Pate, 3676 Tarrington, Cabot, AK, 72023 appeared and stated she was speaking on behalf of the Greater Houston Coalition for Justice on the wrongful deaths of unarm citizen and police officers brutality; her son was killed on Christmas night by Officer Hamilton and before that he wrecked his car and had to borrow her grandson car which Officer Hamilton though it was a stolen which it was not and Mr. Hamilton approached him and had him walk from one side of the car and back around and he literally pulled his gun and shot her son four times but the main thing was that Mr. Hamilton should not be on that force with a gun or a badge because he did commit two other crimes but he still has his job; she had filed a lawsuit and was denied Justice. Council Members Stardig, Davis, Cohen, Martin, Nguyen, Costello and Christie absent.

Mayor Parker stated that Ms. Pate has an active case pending on the City of Houston and Members of Council were are prohibited from communicating to her without her lawyer. Council Members Stardig, Davis, Cohen, Martin, Nguyen, Costello and Christie absent.

Mr. Eric Jones, 211 Gerke, Snook, 77878, (713)614-5031 appeared and stated he was speaking on behalf of the Greater Houston Coalition for Justice for the Victim Rights Division and had articles present describing a lot of events that took place that night and past instances where Officer Hamilton was involved and a lot of what happened regarding Judge Hughe's ruling and wanted like to state on record that his family and him support the Houston Police Department but like to point out problems with officers in the department and Officer Hamilton isn't an officer, his was a criminal. Council Members Stardig, Davis, Cohen, Martin, Nguyen, Costello and Christie absent.

Mr. John Woods, no address, (281)835-3336 appeared and stated the following racially derogatory statements would and should shock the Council Members as they made him feel; a Caucasian HPD supervisor made this statement to another African American HPD supervisor and in present of yet other African American HPD employee who were standing there statement, "did your wife pick the sofa for your house? Why would you assume my wife did, because he known how black women over aggressive like that" and the same supervisor made the other remarks at an accident scene involving an Asian Driver and the supervisor and a complaint was filed because he stuck a suspect with a car and internal investigation started and he believes that HPD covered up some of these issue to protect the Supervisor and he requested to the Mayor and Council Members to re-open this investigation. Council Members Stardig, Boykins, Martin, Nguyen, Costello, Kubosh and Christie absent.

Ms. Sheri Johnson, 22510 Red Wing Trail, Tomball, 77375, (281)351-5704 had reserved time to speak but, was not present when her name was called. Council Members Stardig, Boykins, Martin, Nguyen, Costello, Kubosh and Christie absent.

Mr. Johnny Mata, 2121 Fountainview, 77057, (832)723-3110 appeared and stated thanked Council for allowing them to address the death of Blake who was killed by Sergeant Hamilton which already heard from his mother and justice has been denied at all level of government to the Pate family beginning with the City of Houston, Harris County grand jury and even Judge Hughes and question each of the Council Members why does Sergeant Hamilton still on the force. Council Members Stardig, Boykins, Martin, Nguyen, Green, Costello, Kubosh and Christie absent.

Ms. Adjua Umoja- Justice, 611 Walker, Ste.1900, 77002, (832)395-3168 appeared and stated she was a member of the Public Works Department and had been there for four years and worked on several real estate projects and her concern was over Parker Road and Fulton Road and parcels on Parker were going to require relocation and a decision was made after real estate promised one property owner relocation but didn't because of a cost benefit analysis and she believes that something needs to be done about the Real Estate Branch. Council Members Stardig, Boykins, Martin, Nguyen, Laster, Green, Costello, Kubosh and Christie absent. **NO QUORUM**

Ms. Kathy Swilley, no address, no phone appeared and stated that the Greater Houston Coalition for Justice appeared in behalf of her wrongful termination to Council last year and was retaliated against and terminated after filing an EEOC complaint and revoking her willing ness in the last chance to compromise a waiver agreement that required her to drop any and all discrimination complaints with the EEOC but there are officers like Officer Hamilton only get suspended and she lost her job after 22 years with a clean record. Mr. Lakimble Pitre, 4618 Pardee, 77026, (713)677-9969 appeared and stated he was a City of Houston Employee from 2001-2007 had to resign in 2007 and came back this year through a temp agency and was told that he won't make his three months and that he was continuously getting picked on and March 5 was told that he could not be rehired at the city which he reviewed his own record and there was nothing saying that he could not be rehired again.
