

City Council Chamber, City Hall, Tuesday, July 28, 2015

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, July 21, 2015 with Mayor Annise Parker presiding with Council Members Brenda Stardig, Jerry Davis, Ellen R. Cohen, Dwight Boykins, Dave Martin, Richard Nguyen, Edward Gonzalez, Robert Gallegos, Mike Laster, Larry V. Green, Stephen C. Costello, David W. Robinson, Michael Kubosh, and C. O. "Brad" Bradford, Jack Christie D. C., Assistant City Attorney Mr. Harlan Heilman, Division Chief, Claims & Subrogation Division; and Ms. Marta Crinejo, Agenda Director and Ms. Stella Ortega, Agenda Office, present. Council Member Oliver Pennington absent on personal business.

At 1:43 p.m. Mayor Parker called the meeting to order and stated they would start with the presentation portion of the City Council meeting. Council Members Stardig, Davis, Boykins, Laster, Costello and Robinson absent.

Council Member Green stated he was so excited to acknowledge and recognize the Civic Arts Pilot Project that had been sponsored by the District K Office in conjunction with the Mayor's Office of Cultural Affairs, Public Works and Engineering Department and the Houston Art Alliance; through this partnership they had transformed traffic control boxes located at various intersection throughout District K into Civic Art Mini Murals, On June 6, 2015 they unveiled the first Mini Mural Traffic Control Box at West Bellfort and Willowbend and since then 31 Mini Murals were spotted throughout his district; the funding for this project was made possible through his Council Service Fund and more importantly, this arts project fell under the umbrella of the District K beautification initiative "Clean it up, Green it up", he was very excited to bring Civic Art into the district and the purpose if the Civic Arts Project was to convert these bland traffic control boxes into some type of canvas, painted by local street artists, the traffic control boxes were intended to help install civic pride beautifying neighborhoods and streetscapes across the district and overall the project was a legacy initiative toward Civic Art not only in District K but through the whole city, Council Member Green invited the internal people that helped make this possible to the podium to receive the proclamation, recognized the local artist that painted the Mini Murals and stated that the City of Houston extends best wishes for continued growth and success and therefore, Mayor Parker proclaimed July 28, 2015 as Mini Murals Day in Houston Texas. Council Members Stardig, Davis, Boykins, Laster, Costello, Robinson and Bradford absent.

Council Member Nguyen stated he remember back in middle school science class where they learned that the Earth orbits the Sun but he was present to debate this, here in Houston especially in District F, the Sun, the center of the universe actually travels around the globe and the reason why he said this was Sun; Sun was a hip-hop artist, actor and a philanthropist who embodies the virtue of unity and giving to all mankind, a native of Alief, Texas, Sun found his calling in music when he was nine and credits his pursuit of hip-hop through continuous encouragement and support from his brother, after he discovered his authentic lyrical flow, he realized his gift of music was the ability to give back and help his Houston community and soon found himself holding his charitable causes across District F and in the City of Houston by providing for underserved youth in District F, also sponsors and hosted numerous back to school events, drives, health and wellness, fairs, sports and fitness camps benefiting the Youth and the families in District F and the City of Houston commends Sun for his accomplishment and commitment by continuing to give back to his community and therefore Mayor Parker proclaimed July 28, 2015 as Sun Day in Houston Texas. Council Members Stardig, Davis, Boykins, Martin, Green and Bradford absent.

Council Member Cohen invited the representatives from Lakewood Church to the podium and thanked her colleagues for the opportunity to recognize Lakewood Church in their efforts particularly during the flooding, since so much of her District was affected and Lakewood Church was also in her District and as faith based organization serves a vital role in disaster relief and recovery by organizing and focusing volunteer efforts toward the area greatest needs and the May 2015 launched of SAVE which stands for Support and Assistance for Volunteers in Emergencies allows for a level of coordination between the City of Houston and area volunteer agencies in expediting help to the elderly, the disabled and low income Houstonians impacted by natural disasters and faith based organization had been instrumental on responding to Houston's Memorial Day flood recovery by providing hundreds of volunteers who have served countless of hours in the cleanup, repair and stabilization of flooded Houston neighborhoods and Lakewood Church has a dedicated volunteer team that organized over 105 volunteers who had served more than 800 hours to help Houstonians and the City of Houston commends Lakewood Church for its volunteer efforts as part of the save Houston initiative, their selfless dedication towards ensuring Houston's resilience in the face of natural disaster truly encompasses the compassionate spirit of Houston and therefore, Mayor Parker proclaimed July 28, 2015 as Lakewood Church Day in Houston Texas. Council Members Stardig, Davis, Boykins, Martin and Bradford absent.

At 2:10 p.m. Mayor Parker recognized Council Member Gallegos for the invocation and the pledge of allegiance. Council Member Davis absent.

At 2:12 p.m. City Secretary called the roll. Council Member Davis absent. Council Member Oliver Pennington absent on personal business.

Council Member Gonzalez moved to adopt the minutes from the previous meeting and seconded by Council Member Green and then Council Member Kubosh moved that the minutes be delayed for one week as he had not had time to read them and seconded by Council Member Green, all voting aye, nays none.

Council Member Nguyen stated he had some special guest that was present today and this past Sunday he attended an event called A.Q.Z. Cherry Star Heart Foundation and he introduced three super stars from China and stated that the foundation collected almost over three-quarters of a million dollars for underprivileged children with Congenital Heart Defect which was going to help 110 children.

Council Member Gallegos moved that the rules be suspended for the purpose of hearing Mr. Tom Casland and Honorable Lane Lewis and Mr. Marty McVey out of order and seconded by Council Member Kubosh, all voting aye, nays none. **MOTION 2015-0500 ADOPTED**

Council Member Gonzalez moved that the rules be suspended for the purpose of hearing Ms. Kirsten Passmore out of order and seconded by Council Member Kubosh, all voting aye, nays none. **MOTION 2015-0501 ADOPTED**

Council Member Kubosh moved that the rules be suspended for the purpose of hearing Mr. Randall Kallinen and Mr. Paul Kubosh at the top of the speakers list and seconded by Council Member Gonzalez, all voting aye, nays none. The City Secretary began calling the list of speakers. **MOTION 2015-0502 ADOPTED**

Mr. Randall Kallinen, 511 Broadway, 77012, (713)320-3785 appeared and stated he was present to speak about the anti-feeding ordinance that makes it a crime to feed more than five people in the City of Houston without gaining permission; that he created a petition and within 2 months had received 70,000 signatures to abolish this law and would like to see this as a campaign issue since it was election year and the Mayor and Council Members may change. Council Members Stardig, Nguyen and Laster absent.

Mr. Kallinen was questioned at length by Members of Council.

Mr. Paul Kubosh, 1619 Lubbock, 77007, (281)850-0171 appeared and stated he was present to express his concerns and issues relative to the feeding the homeless ordinance and wanted to address the political aspect of this; that they conducted a poll here in the City of Houston which he wanted to make clear that 87% of the voters across the board, in every district were against this ordinance and they were currently engaging Mayoral Candidates that would make it their first agenda of the week they were elected to put this up for a vote and he was requesting that either the Council votes on it themselves or let the citizen vote. Council Members Davis, Martin and Green absent.

Mr. Kubosh was questioned by Members of Council.

Ms. Betty Gregory, 6207 Hirsch Road, 77020, (713)816-8665 appeared and stated she was a top community leader from the Kashmere Garden working primarily in Fifth Ward and she works with the Texas Organizing Project best known as TOP and they had been working tireless for years to stabilize their neighborhoods, even negotiated a deal with Mayor Parker several years ago to focus resources to true neighborhoods for opportunities and she was saddened by her concern about transferring money from home owner assistance to multi-family. Mayor Parker, Council Members Cohen, Gallegos and Green absent. Mayor Pro Tem Gonzalez presiding.

Ms. Tiffaney Hogue, 7906 Braesview Lane, 77071, no phone appeared and stated she was the Policy Director of the Texas Organizing Project and to piggy back on what Ms. Gregory said, there were three items of transferring CDBG money one was homeowners assistance and the other was re-allocating funds for facilities and it goes to them not understanding the details of what the rationale was behind this, not understanding the plan behind this and in general, not always but in general they would like to see CDBG money spent on uplifting their neighborhoods versus spending on public facilities. Mayor Parker, Council Members Cohen, Gallegos and Laster absent. Mayor Pro Tem Gonzalez presiding.

Ms. Kristen Passmore, 14231 Rock Dove Lane, 77044, (281)704-7065 appeared and stated she was 14 years old and she was representing the Houston Fireballs; the Houston Fireballs was the only power soccer team, power soccer was when they use their power chairs and put guards on when they play soccer like everyone else and they were hosting a game on August 5, 2015 and were playing against Dynamo Dash and the tickets were \$5 and invited Members of Council to come watch them play and also wanted to thank Council Member Stardig for accepting their invitation. Mayor Parker, Council Members Davis, Cohen, Gallegos and Laster absent. Mayor Pro Tem Gonzalez presiding.

Mr. Matt Murphy, 3209 Prospect Street, 77004, (713)791-4403 appeared and stated he was present a citizens, a registered voter and was present to voice concern of the dereliction of the ministerial duties as elected representatives; according to the ruling of the Texas Supreme Court on the opinion delivered on July 24, 2015, which the City Council had decided of its own

record not to act, disregarding the City Secretary certification that the petition had enough signatures and the charter requires immediate action by the City Council following the certification which the petition was withheld but yet it was not on this agenda and he was requesting why was Council continually delaying this item? Council Members Davis and Laster absent.

Mayor Parker stated that the item would be on the agenda next week and in order to put something on the ballot, you have to have ballot language upon which to vote and since the Supreme Court decided to drop this on a Friday which was the day they published their agenda and it would not be until next Friday that they could actually publish an appropriate agenda item for the following Wednesday which would allow Council Members to have a tag week as well, so it would be on the ballot next week and every Council Member was informed of that in writing. Council Members Davis and Laster absent.

Mr. Dave Wilson, 5600 West 34th Street, 77092, (713)202-7893 appeared and stated on May 14, 2014 the City Council passed Ordinance 2014-530 which some refer to as the H.E.R.O Ordinance and he just refers to the Ordinance as 530 which he believes it was an unjust law and requested that the Mayor and Council Members that voted for this Ordinance to search their hearts and do what was right to either repeal this Ordinance or put this Ordinance on the November ballot. Council Member Davis absent.

Ms. Ling Ngu, 10207 Crescent Bluff Lane, 77070, (281)702-4936 appeared and stated she was a resident of District A, she was 28 years old, unmarried, a woman, a Lesbian and a Buddhist which all these describe her but do not define her and she was present to express support like most Houstonians for the Equal Rights Ordinance. Mr. Marty McVey, 6363 Richmond, 77056, (713)334-0800 appeared and stated he was running for Mayor for the City of Houston and he particular emphasis was on economic development and growing the economy in a smart way and he believes that discrimination was bad for business and H.E.R.O represents Houston as an open and welcoming city.

Council Member Nguyen moved that the rules be suspended for the purpose of adding Jennifer Rene Poole to the list of speakers for 3 minutes and seconded by Council Member Cohen, all voting aye, nays none. **MOTION 2015-0503 ADOPTED**

Ms. Virginia Gregory, 9806 Westview Dr., 77055, (713)465-5814 appeared and presented information and stated she was present to speak about an issue that she believes it was important, there was a new agenda that was out called Plan Houston which was gorgeous that includes completing the streets and more but then she looked at the Policy Directives Plan Houston Draft recommendation and it says on No.3 "in your due safe and healthy neighborhoods" and No.6 says "sustain quality in factures" which all she can say was that her neighborhood was flooded during IKE and just recently during the Memorial Day flood which Ms. Gregory presented a map to Members of Council which showed where it flooded in her neighborhood and the damages that were done and the question she had "what were they supposed to do" because their quality of life was gone and their requesting were to be dry.

 4. Creative fun
- The Houston Youth Recreation Programs Standards of Care is codified at Article XII of Chapter 32 of the City of Houston Code of Ordinances
- Texas Human Resources Code 42.041 (b) (14) provides an exemption from child-care licensing for recreation programs serving elementary age children (ages 5 – 13) with the following criteria:
 - ✓ A municipality operates the program;
 - ✓ The governing body of the municipality annually adopts standards of care by ordinance after a public hearing for such programs;
 - ✓ The program provides these standards of care to the parents of each program participant;
 - ✓ The ordinance includes child/caregiver ratios, minimum employee qualifications, minimum building, health and safety standards, and mechanisms for monitoring and enforcing the adopted local standards;
 - ✓ The program informs the parents that the state does not license the program; and
 - ✓ The program does not advertise itself as a child-care operation.
- The Parks and Recreation Department offers the After-School Enrichment Program at 54 of our Community Centers
- We would be happy to answer any questions from Council or the Public. Council Member Martin absent.

Mayor Parker stated that the short version was that they provide activities for kids in park facilities across the city, that they were exempt from State oversight because they adopted local rules and regulation to oversee the care of those children and in order to maintain their exemption from State oversight, they had to annually reaffirm the rules under which they oversee the kids in their after school and summer youth programs and there was no proposal to change current standards of care that had been place for years.`
