City Council Chamber, City Hall, Tuesday, October 20, 2015

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, October 20, 2015 with Mayor Annise Parker presiding with Council Members Brenda Stardig, Jerry Davis, Ellen R. Cohen, Dwight Boykins, Dave Martin, Richard Nguyen, Edward Gonzalez, Robert Gallegos, Mike Laster, Larry V. Green, Stephen C. Costello, David W. Robinson, Michael Kubosh, and Jack Christie D. C., Ms. Tracy Calabrese, Division Chief, General Counsel; and Ms. Marta Crinejo, Agenda Director and Ms. Stella Ortega, Agenda Office, present. Council Member C. O. "Brad" Bradford absent on city business and Council Member Oliver Pennington absent on personal business.

At 1:45 p.m. Mayor Parker called the meeting to order and stated they would start with the presentation portion of the City Council meeting. Council Members Stardig, Davis, Martin, Pennington, Gallegos, Laster, Green, Costello and Robinson absent. **NO QUORUM**

Council Member Martin that stated joining him were Members of the Boeing Company and one of the exciting things that they had on the south end of the District and the south end of the city was the opportunity to work with a fine company like Boeing and at the Members of Council desk they had a Lapel Pin honoring their 100th Anniversary of Boeing Corporation and a lot things happen in and around space travel, they were at Southwest last week for the new International Terminal; Boeing supplied all the airplanes to Southwest; that spaceport out of Ellington was one of the hot topics today, Human Space Exploration and Public/ Private Partnerships and a lot exciting things were happening in the City of Houston: Boeing Company was a valued partner of the community since the early days of the Johnson Space Center and Boeing Company products played a major role in the daily life providing transportation across the globe, moving cargo, supporting our troops and making major investment in the technology of tomorrow, which the company helps improve the economy by employing 436 Houstonians, 1500 in the region and 4300 across Texas; that currently Boeing Company was building the CST100 capsule that would return American Astronaut to space and to stop our dependence on Russia and the company was also a prime contractor for the international space station and was manufacturing the space launch system soon to be the largest rocket in U.S. history and the City of Houston commands Boeing Company Corporation for its continued local and across the globe efforts for over the past 100 years and therefore Mayor Parker proclaimed October 20. 2015 as Boeing Company Day in Houston Texas. Council Members Stardig, Laster, Green, Costello and Robinson absent.

Council Member Gonzalez invited Judge Hartle and her team to the podium and stated that everyone knows how critical of the jobs in the Municipal Courts are and they take this week, every year to recognize the work that they do and appreciate their efforts; Municipal Courts provides citizens with a local forum where questions of law in fact can resolved in regards to alleged violations in State Law and Municipal Ordinance because citizens come in contact with Municipal Courts more than any other courts and the public impression of the Texas Judicial System was largely depended on their experience; Judges of the Municipal Courts function and also continuously try to improve the Administration of Justice through participation in education programs, seminars, workshops and meeting of their State and local professional organizations and the 84th Texas Legislature designated November 2nd through the 6th of this years as Municipal Courts Week to recognize the accomplishments of Municipal Courts and salute their critical role preserving public safety, protecting the quality of life in Texas and deterring future criminal behavior and therefore Mayor Parker proclaimed the week of November 2nd through 6th of 2015 proclaimed Municipal Courts Week in Houston Texas. Council Members Stardig and Robinson absent.

Council Member Boykins invited Members of Centerpoint Energy to the podium and stated that he wanted to present a proclamation to one the Infrastructure Utility Companies that bears no mentioning, really and they do not have to brag on what they do, the record speaks for itself not just in Houston but in the State of Texas and when hurricanes take place in this country Centerpoint Energy had always stepped set up to the plate and volunteers and gives time and effort and expertise to help bring communities back together and today they had the Senior Vice-President of Centerpoint Energy, Vice President for Centerpoint along with a host of Members of Centerpoint but another special reason, not just to take in all the infrastructure type work they do, he wanted to talk about the charity work that they do; Centerpoint Energy had partnered with the Houston Fire Department to something big in the City of Houston, Centerpoint Energy was a leader in the Nation in delivering energy services and value, this means more than just doing business but serving in the meeting which it conducts its business, Centerpoint Energy was committed to the core values of safety, integrity, accountability, and respect, this demonstration with partnership with the Houston Fire Department getting the Houston smoke detectors, carbon monoxide detectors program by distributing to citizens and since 2007 Centerpoint Energy had donated over \$100,000 towards the purchase of smoke detectors and carbon monoxide detectors to be distributed to the citizens of Houston for free and also Centerpoint Energy made accommodations towards the purchase of smoke alarms for the hearing and impaired citizens of the greater Houston area and City of Houston commends and appreciates Centerpoint Energy for its contribution to the citizens of the greater Houston Area and therefore Mayor Parker proclaimed October 20, 2015 as Centerpoint Energy Day in Houston Texas. Council Member Stardig absent.

At 2:10 p.m. Mayor Parker recognized Council Member Gonzalez for the invocation led the pledge of allegiance. Council Member Stardig absent.

At 2:12 p.m. City Secretary called the roll. Council Member Stardig absent. Council Member C. O. "Brad" Bradford absent on city business and Council Member Oliver Pennington absent on personal business.

Council Member Kubosh moved that the minutes be delayed and seconded by Council Member Green, all voting aye, nays none. Council Member Stardig absent. **MOTION ADOPTED**

The City Secretary began calling the list of speakers.

Mr. Martin Chavez, 13107 James Ln. Fort Bend, 77477, (281)914-1407 appeared and stated he works for the Greater East End Management District and first he would like to thank Solid Waste Management and this Council for considering making Amendments Chapter 39 relating to the tire disposal which they been dealing with this issue of illegal dumping of tires in their community and seen firsthand and understand the damages to health and safety as well as the negative image illegally dumped tires can had on their community and the District spent approximately 700 man hours in labor a year picking up tires from public right of ways within the districts 16 square miles and they hope that this Ordinance would help the fight against those companies and individuals that take the easy way out to dispose tires illegally and in the process hurt the community. Council Members Stardig, Davis and Kubosh absent.

Mr. Roger Church, 4521 Benning Dr., 77035, (281)628-4651 appeared and stated he was with Liberty Tire Recycling and was present to say that they support the proposed City Ordinance, he believes if the city passes it and enforces it, it would help the city become a lot

cleaner, reduce Solid Waste cost and level the playing fields for all the haulers. Council Members Stardig, Davis, Martin and Kubosh absent.

Ms. Cora Johnson, 10126 Alfred Ln., 77041, (713)462-4478 appeared and stated she was from the Carverdale Area and they been having cleanups since 1968, the tires had been their biggest problem and they were in support of the ordinance and if they pass it and it goes into effect and they start using it right away, it would solve their problem in Caverdale which was the only problem they had because they have people that go there every night and place some of the tires on vacant lots and she had pictures that she brought to Council but she would give them to Mr. Hayes so, that he can give them to Members of Council and with their cleanups, they have two people that have trailers and they load them up and take to their recycle place that they were supposed to and the City of Houston Waste Department does help them do this cleanup which they do this once a year in March and she requested Council to pass this and not sit on it.

Ms. Ruby Mosley, 862 North Victory Dr., 77088, (281)447-6095 appeared and stated she was present representing Ruby Bennett and herself and what they were requesting for was, it time to stop playing around, the illegal dumping from these business hiring people to discard the tires and bring the tires into their community, everyone knows that it was a health issue and there was nobody in the community that can afford that many tires, that was going to stroll up and down the street; what they were requesting was number one, some more money put in the Neighborhood Protection, so they can have more inspector out there, writing more fines and tickets and it was going on all over Houston and they need Council help. Council Member Martin absent.

Mr. Mark McMillen, 755 Marleen, 77034, (713)459-5242 appeared and stated he was the President of the Minitex Civic Club and back in 1983 they had their first major cleanup in that area and they netted around 1800 tires and every year since then they try to do two cleanups a year, one in the fall and the other spring with no less than 700 to 800 tires which there may be more out there because what they try to do was that they have a 40 yard dumpster that they get from the city and fill them up to the max; they have many trucking companies, concrete companies, that have the big tires and those major tires get thrown up into the dumpster but this Ordinance would be a great thing for Members of Council to undertake, they need some kind of stop gap to keep this from happening and a lot of the people in his area were getting older and tires were a nuisance but he approached Council in hopes that Council can come up with something to stop this. Council Members Davis, Martin and Gonzalez absent.

Mr. Brain Butler, 3914 Leeland, 77003, (713)528-3779 appeared and stated he just wanted to come and comment on the Idling Ordinance and he knew it was on the Agenda; first he would like to say was that Brain Butler, Community Outreach Director for Air Alliance Houston, worked in pretty much every single one of the Districts and he was always overwhelmingly encouraged to hear the comments that folks were making about City Council and for him, he can not say enough good things about everyone that was present, they work on a variety of issues with air pollution and water pollution to soil contamination and Council Members Kubosh, Gallegos and Boykins were very active when they were looking at the CES site and every time the Council Members were there front and center advocating for their communities and he can not thank them enough for doing that and he really wanted to support Council on passing this Idling Ordinance, it was well needed. Council Members Davis, Martin and Gonzalez absent.

Mr. Adrian Shelley, 3914 Leeland, 77003, (713)528-3779 appeared and stated representing Air Alliance Houston and speaking on behalf of the Idling Ordinance which everyone present had heard from him about this Ordinance and wanted to say thank you to Members of Council, he appreciated their attention to this and all the work that was been done on this, it was an important idea which the time had come and for all the work their partners in the city on this and thank you. Council Members Stardig, Davis, Martin and Gonzalez absent.

Ms. Barbara-Ann LaCourse, 4510 Balkin, 77021, (832)728-4377 appeared and stated she was present about the sidewalks in the Sunnyside in Houston, she got dropped off by a bus on Friday night where there was nothing but grass on the side where she was dropped off and which she had a picture on her phone but she does not know how to use her phone that good and she does have a picture where the grass was and an incline to get to the 29 bus stop and she fell off the thing, her chair spun around and fell off on the road, the girl at the bus stop tried to catch her but could not and six students from the University came to help her get into her chair and then the policeman came and she started giving him information, the 29 bus driver tried stopping in the street, she could not get her on the street, which she had to go to University Street to get her on a bus and she does have the officers name, the time, and the incident number with six witnesses that she fell off the sidewalk where there was no sidewalk and she believes she should get a claim because she got worse after that, on Saturday night she fell into the ditches on Falcom and she believes that the sidewalks need to be looked at. Council Members Stardig, Davis, Martin, Gonzalez, Laster and Costello absent.

Ms. Rosemary Stuart, 2101 Fountainview Dr. B61, 77057, (713)851-0170 appeared and stated she was actually a former assistant to the City Attorney but after Mr. Fieldmen came in and became the City Attorney her Department was dissolved and she was laid off which she then moved to Corpus Christie and the reason she was present today which had nothing to do with that but Corpus Christie had passed an Ordinance last year where people could not speak on cell phones in the car unless they had a hand free cell phone, now she knows that some cars were equipped with Bluetooth but anyone could go to AT&T store, Sprint store and buy something that would go on peoples visor which only cost around \$60 and she finds it incredibly dangerous driving around in Houston talking on their cell phone all the time and just Tuesday she was driving back from an appointment and this lady was driving in the left hand lane which she was not paying attention and swerving all over the road. Council Members Stardig, Martin and Gonzalez absent.

Mayor Parker stated that they were going to take to Council Committee a proposal to present before Council to ban texting while driving school zones or citywide and certainly part of the discussion would be banning cell phone use that was not hands free in general, but their focus was going to be on texting while driving but they would be taking that up to Council she thinks in the next week. Council Members Stardig, Martin and Gonzalez absent.

Ms. Cheryl Armitige, 2706 Barbee St., 77004, (713)775-3366 appeared and stated she was the President of Washington Terrance Civic Association and their members were opposed to building low income senior housing community at 2222 Cleburne, it was a fair request to know how this development would have an impact on them and their biggest concern was flooding and in May and having this much concrete was going to flood their neighborhood, they currently do not have flooding issues and was told in their meeting that all citizen over of the age of 62 qualify to reside in these apartments and when they reached out to the City of Houston and were told that they were being built for the LBGT Community and the Montrose Community had to raise \$14 million for this development, they trusted information that was being conveyed to them, they have no choice but question everything since the facts had be altered and given them; they need to know that their voices matter and all that were involved were being truthful and straight forward, their members were working tireless to create a family oriented environment in their neighborhood and they believe that a low income senior housing project rental units was not the highest and best use for this property and they believe that the highest and best use would be residential housing with down payment assistance. Council Members Stardig, Cohen, Martin, Gonzalez and Laster absent.

Mayor Parker stated it was still planned to be a four story project and because it was on the site of the potential University line, a rail stop, there was a necessity to get a variance and the Planning Commission was going to get this Thursday or next Thursday and she rightly pointed out they desperately need senior housing across the city and this was a former industrial site on a freeway which was an appropriate site for senior housing and she wanted to relieve her of the misconception that there would be any ability to discriminate against anybody that wanted to live on the property but it would be a place where the gay community was welcomed would be receiving Federal Housing Dollars and so it was available to anyone that qualifies. Council Members Stardig, Martin, Gonzalez absent.

Council Member Davis moved that the rules be suspended for the purpose of adding Ms. Carol Alexander to the list of speakers and to hear Ms. Deborah Dickerson out of order and seconded by Council Member Green, all voting aye, nays none. Council Members Stardig, Martin, Gonzalez absent. **MOTION 2015-0723 ADOPTED**

Mr. Joseph Omo Omuari, 3939 North Freeway, No. 210, 77022, (832)815-7006 had reserved time to speak but was not present when his name was called. Council Members Stardig, Cohen, Martin, Gonzalez and Laster absent.

Ms. Deborah Dickerson, 14511 Waterloo, 77045, (832)654-5356 appeared and stated she was the Founder and President of the Grandparents Support Group and she wanted to say that they had the best Councilman which was in District K, they wanted to announced their 2nd Annual Black Tie Gala that was a nonprofit organization that supports grandparents that had

received their grandchildren through CPS and other means that were having academics and emotional problems, they were navigators and they hire retired teachers and social workers to go into the schools and advocate for these children, this was a fund raiser which she needs all of the Council help because \$50 goes a long way for these grandparents and ask Members of Council for their support and their trying to sell 300 tickets and the grandparent would be cooking, she wanted the Mayor and the Councilman to have the first dance. Council Members Stardig, Martin and Gonzalez absent.

Ms. Florence Giles, 2847 Wuthering Heights, 77045, (713)884-6476 appeared and stated she was a client and had been a client with GPS since 2011 and at that time she became the caregiver to her grandchildren and this organization had been a great resource to her, especially when they were diagnosed with ADHD and when she was going through pain for her grandchildren and in 2011 she met Ms. Dickerson and so began GPS and advocacy was a very expensive service and she was present to request support for GPS because they were really standing behind the grandparents and please support the Gala on November 20, 2015 so they can hire more advocates to support the grandparent. Council Members Stardig, Boykins, Martina and Gonzalez absent.

Ms. Carol Alexander, no address, no phone appeared and stated she met Ms. Dickerson through Greg Grown which she has health problems and also raising a grandson on her own, she was going through so many changes, being threaten to have the child taken away from her and she met with Ms. Dickerson and they formed a plan and executed the plan which she got the final decree through CPS which her daughter was supposed to sign her right away with the final decree but it did not because she could not put her grandson on her insurance which that was another fight but she would tell that Ms. Dickerson had been there for a lot of grandparents and was requesting for everyone to attend the Gala to help more people to get the help they need and these kids had gone through so much, they have issues and this helps raise them up so they can some type adult to be able to forward in their life and when they come to them with a fixed income they were barely making it and please support the Grandparent Association.

Ms. Cindy Montgomery, Post Office Box 14312, 77221, (832)404-6943 appeared and stated she was the Executive Secretary and the Marketing Person for the Grandparent Support Group and as well she was a Juvenile Mentor and she was coming to Council at a different angle, the 2.5 million children that were raised by their grandparents and out of 2.5 million, 15 percent of those children were later incarcerated that leaves 2,125,000 children that were successed that were raised by their grandparents, everyday there were 20,000 youth that had been detained in America and every year the Juvenile Court in the United States had 1.7 million cases that had Juvenile Delinquents and 4,600 Delinquent cases per day and requesting that Council support the Grandparents Support Group and the Gala. Council Members Stardig, Boykins and Martin absent.

Mr. Muhammad Iqbal, 6110 Fairdale Ln., 77057, (929) 264-2936 appeared and presented information and stated he was a business man and moved from New York City to Houston and was in the Real Estate Investor, being a Real Estate Investor he knows the importance of location and property; his property was in the Galleria Area, where they welcome local housing and they were planning to build another block of residential apartments to meet up with the demand but when they prepared the plan that Centerpoint utilizes their land in the back yard of the property, the restriction was 20 feet high and 60 feet in distance which was taking two third of his plan, so this 80 year old transmission line was like 40 feet high that he can not cross and when he contacted Centerpoint and advised them of his construction plan, so these lines should be taken up on the streets or underground and they replied by saying they can't do

that and he was and he can not fully utilize his property and was requesting from the Mayor and Members of Council to reclaim his land.

Mayor Parker stated that they have a representative from the Administration and Regulatory Department who can talk also but this was a transmission line that had been there for 80 years and if they had an easement across that property that predates him owning the property, it was not his land and it was an easement and her understanding Centerpoint was willing to work with him but that he would have to pay the cost of moving the transmission line either up or down and because it was an easement that they would still need to access to the line, they were happy to work with him to the extent they can but it was a private property dispute between him and Centerpoint.

Mr. Bennie Freeman, 4530 Firnat, 77016, (713)254-1984 appeared and stated he was present to speak about the Houston Fire Department, back in 1996 he sued the City of Houston and 2001 he won a \$1.4 million lawsuit and he had a Federal Civil Rights case against the City of Houston \$28 million and any of the Council Members aware about the fire trucks, the ladder trucks and the City of Houston changed the ladder truck because of his case because they sent a faulty fire truck to one house fire where unfortunately someone died, the \$28 million dollars that the City of Houston spent redoing the Fire Department, that was the money that they sued the city for and the Federal Judge that presided over this case was Samuel Kent and he split the case in half and the Federal Civil Rights case and he was present today to inform the City of Houston that he was going to reopen his case on Federal Civil Rights the Judge that presided over this case and resue the City of Houston on his original case for the \$28 million. Mayor Parker, Council Member Stardig, Boykins, Martin, Laster, Green and Robinson. Mayor Pro Tem Gonzalez presiding.

Mayor Pro Tem Gonzalez stated that he does not know anything about his case and he believes it was a legal matter and he would have to take it up outside of Council. Mayor Parker, Council Member Stardig, Boykins, Martin, Laster, Green and Robinson. Mayor Pro Tem Gonzalez presiding.

Ms. Opal Clay, 8026 Sanders Glen Ln., Humble, 77338, (713)818-2693 appeared and stated as Council can see that she relies on mobile assists and she was a 21 year retiree from the City of Houston as a Public Servant of 2014, to celebrate this accomplishment and other in her life, she made the decision to take a trip to Europe which she completed Saturday October 10, 2015 and when she came back into Houston through Intercontinental Airport and that was when her nightmare began, she was assisted getting off the plane but was taken to this room and two hours later she was still waiting to get out of the airport and at that point she became very discouraged and began to question or felt so helpless and handicapped because the services was not available at the airport to get her out of there and when she asked the attendant that if she could use one of the wheel chairs and was told no because they would not get it back and she does not understand any reason why an International Airport and there was 20 plus people that were waiting and the employees that were assigned to work in this particular area where sitting around talking on their cell phone, not being able to get over time, taking breaks, and she just wanted to get out of there but one of the young ladies saw that she had gotten upset about it and actually helped her get out. At 3:53 p.m. The City Council was recessed until 9:00 a.m., Wednesday, October 21, 2015, Mayor Parker, Council Members Stardig, Davis, Boykins, Martin, Nguyen, Laster, Green, Costello and Robinson absent. Mayor Pro Tem Gonzalez presiding. **NO QUORUM**

At 8:29 a.m. Ms. Anna Russell, City Secretary, read the description or captions of the items on the Agenda.

The Houston City Council reconvened at 9:00 a.m., Wednesday October 21, 2015, Mayor Annise Parker presiding, with Council Members Brenda Stardig, Jerry Davis, Ellen Cohen, Dwight Boykins, Dave Martin, Richard Nguyen, Oliver Pennington, Edward Gonzalez, Robert Gallegos, Mike Laster, Larry V. Green, Stephen C. Costello, David Robinson, Michael Kubosh, Jack Christie D.C., Ms. Donna Edmundson, City Attorney; and Ms. Stella Ortega Agenda Office, present. Council Member C.O."Brad" Bradford absent on city business.

At 9:07 a.m. Mayor Parker called the meeting order and stated the first Items on the Agenda were Public Hearings.

HEARINGS - 9:00 A.M.

 PUBLIC HEARING relating to the proposal to use James W. Lee Park for Storm Water Detention <u>DISTRICT A - STARDIG</u>- was presented and the City Secretary advised that no one had reserved time to speak on it and that the Director Joe Turner of Parks and Recreation Department was present and made the following statement:

James Lee Park consists of approximately 5.89 acres located at 9025 Pinter in City Council District A.

The Public Works and Engineering Department has requested to use a portion of the Park for storm-water detention as part of the Binglewood Drainage and Paving Capital Improvement Project.

Benefits to the park as a result of the project include replacement of aging, existing park amenities with new ones.

Park amenities include a walking trail, a playground, park benches, picnic tables, bar-b-que pits and open green space for outdoor recreation.

Turf and trees will also be replaced and a shade structure will be added.

The park will also benefit from the new availability of parallel parking in the street right-of-way as part of the new curb and gutter pavement section around the park.

The Houston Parks and Recreation Department supports this request because it will provide a public benefit by reducing the risk of structural flooding for the Binglewood community while maintaining a park use.

The Parks and Recreation Department agrees there is not a feasible and prudent alternative to using the park for this purpose and supports the taking of a portion of the Park for the Project.

The Parks and Recreation Department agrees the Project includes all reasonable planning to minimize harm to the park resulting from the use requested by the Public Works and Engineering Department.

Statement by Daniel R. Menendez, P.E., Deputy Director Department of Public Works and Engineering as follows:

As part of the adopted CIP, the Department of Public Works and Engineering (Public Works) is to provide drainage improvements that addresses and reduces the risk of structural flooding in the Binglewood Community in City Council District A under the Binglewood Drainage and Paving project (WBS No. M-000293). As part of the Preliminary Engineering design, Public Works reviewed alternatives that would provide the needed drainage improvements for the area and be economically responsible. The selected alternative included the partial use of James Lee Park (Park) for storm water detention. James Lee Park is a low-lying area that has significant open space and is ideally located near the neighborhood's outfall into a Harris County Flood Control District channel.

The drainage improvements include both surface and underground detention. Surface detention would be provided by the Park, while underground detention would be provided in oversized storm sewer boxes along a number of streets in the subdivision. The majority of the detention is provided in these oversized storm sewer boxes. Using the Park to address some of the required detention reduces the amount of additional oversized storm sewer boxes that would be needed throughout the neighborhood, which would result in additional construction and maintenance costs.

The proposed detention facility will directly impact approximately 4.5± acres of the Park. While the depth of the detention facility will only be around 4-ft, the majority of the Park amenities will need to relocated with new amenities that meet the Houston Parks and Recreation Department (Parks Department) current standards for this type of park. Public Works plans to install a walking trail, a playground, park benches, picnic tables, bar-b-que pits, shade structure, turf and trees to mitigate any impacts to the Park. Additionally, because the detention facility is shallow and will be graded to drain, the open green space in the detention facility will still be used for outdoor recreation. At the end of the project, James Lee Park will be a multi-purpose facility and still be used as a park.

As part of the design improvements for the project, Public Works will also be replacing the existing asphalt pavement and ditch section streets with concrete curb and gutter pavement

sections throughout the neighborhood. These streets will be wider and will be able to accommodate street parking around the Park.

Over the past year, Public Works has met with Council Member Stardig's office, the Parks Department, and the Binglewood Civic Club to discuss the drainage project, including the use of the Park and the impacts to its amenities. At the conclusion of these meetings, all have indicated their initial approval to move forward with the project utilizing James Lee Park as partial detention.

The Department of Public Works and Engineering concludes that there is not a feasible and prudent alternative to using the Park for this drainage purpose and the project includes all reasonable planning to minimize harm to the park. The Binglewood Drainage and Paving project reduces the risk of structural flooding in the area and requires the use of James Lee Park to do so. Public Works respectfully requests City Council to make the same conclusion and approve the partial change to the use of the Park.

After a discussion, Mayor Parker asked if there was anyone present to speak on this specific issue and seeing none, requested a motion to close the hearing.

Council Member Gonzalez moved that the public hearing for James W. Lee Park for Storm Water Detention be closed and seconded by Council Member Robinson, all voting aye, nays none. Council Members Boykins, Pennington and Green absent. **MOTION 2015-0724 ADOPTED**

- On July 16,2014, the Boards of Directors of Reinvestment Zone Number Nineteen ("Upper Kirby Zone") and the Upper Kirby Redevelopment Authority approved a Fourth Amendment to the Upper Kirby Zone's Project Plan and Reinvestment Zone Financing Plan ("Plan") and forwarded the Plan to the City Council for consideration
- In accordance with Sections 311.003 and 311.011 of the Texas Tax Code, a municipality must hold a public hearing when proposed amendments to a Project Plan include changes that increase the total estimated project costs stated in a Project Plan, reduces or enlarges the boundaries of a Zone. The public hearing today is regarding the proposed Fourth Amendment to the Upper Kirby TIRZ Project Plan and Reinvestment Zone Financing Plan.
- In brief, the Fourth Amended Plan provides annexation of right-of-way area into the Zone. The proposed annexation will enhance the Zone's utility and street and streetscape improvements along certain commercial corridors to enhance pedestrian access, mobility and connectivity.

The amended plan provides for the design and construction of utility systems, roadways and streets, flood remediation infrastructure, parks and related recreational infrastructure, public art, lightning and landscaping.

- The Upper Kirby Zone's board chair and administration met with several property owners regarding the extension and expansion of the Zone. These property owners included: Greenway Plaza, Exxon Campus, Camden Living, the Morgan Group and Martin Fein Interests.
- In closing, City Staff has worked with the Upper Kirby Redevelopment Authority, the community and the council office on the proposed Fourth Amended Plan and will bring forth a recommendation for City Council to approve the plan amendment on November 4th. There is no council action required today.

Mayor Parker asked if there was anyone that was present to speak on the Upper Kirby Zone and a gentleman responded.

Harold Fletcher, no address, no phone appeared and stated he was present representing Highland Village and was the shopping center on Westhimer, the very west of this annexation and his opening remark was why the rush, and he says that because he had been working with the City Offices for five years on a 380 agreement and three weeks ago, they became aware of this annexation which they had several conversation but no real details had come forward and to them there was no a definitive plan and they requested information in writing which the only thing that they had received was a map and to Highland Village they feels its nuisance and they want to protect highland Village and their tenants.

- In accordance with Sections 311.003 and 311.011 of the Texas Tax Code, a municipality must hold a public hearing when proposed amendments to a Project Plan include changes that increase the total estimated project costs stated in a Project Plan, reduces or enlarges the

boundaries of a Zone. The public hearing today is regarding the proposed Third Amendment to the Southwest TIRZ Project Plan and Reinvestment Zone Financing Plan.

- In brief, the Third Amended Plan provides for the enhancement of and improvements to approximately 456.4 acres added into the Zone's boundaries and includes areas covered by the Plan, the First Amendment to the Plan, and the Second Amendment to the Plan, except for approximately 29 acres of residential area that will be removed from the Zone's boundaries as part of this Amended Plan. The primary goals of the Zone are expanded to continue to eliminate the blight and substandard conditions in the Zone, and encourage the sound growth of residential, retail, and commercial sectors in the Zone as well as design and construction of improved mobility systems, streetscape enhancements, pedestrian amenities, public utility system upgrades, adequate public facilities and parkland and public space improvements.
- The Southwest Redevelopment Authority conducted a public engagement meeting on October 1, 2015 to inform of the proposed annexation and improvements planned within the zone. Over 8000 postcards were mailed out to businesses and residents residing in the area and more than 160 people attended. Additionally, the Authority has received letters of support from both the owner of Ardenwood Group, a large retailer on Harwin and the India Cultural Center (ICC) who is largely comprised of business owners in the Harwin and Hillcroft corridors.
- In closing, City Staff has worked with the Southwest Redevelopment Authority, the community and the council office on the proposed Third Amended Plan and will bring forth a recommendation for City Council to approve the plan amendment on November 4th. There is no council action required today.

Ms. Peggy Thomas, 7715 Fondren Rd., 77074, (832)275-2513 had reserved time to speak on the hearing and appeared and stated she was present this morning to support the TIRZ and urge Council to vote yes to the amendment to annex and Deannex the 100 plus homes which she was not positive about that figure that were annexed in March of 2013 and she would also state as a resident, they collected 68 petitions by either going door to door or doing mail outs with the assist of the TIRZ and also Council Member Laster supported them and it exceed the 51 percent and maybe more petitions coming in and with that number it seems to show that they want to be deannex, so they can feel secure in their deed restricted community and she would also like to state that this had been a very difficult process, no support of their community nor the support of their Civic Association other than a paper resolution and again for Members of Council to vote yes.
