#### MAYOR'S REPORT

Mayor Turner stated that due to the severe weather for this morning, all of the COVID-19 testing sites have been delayed and they are trying to open at noon. They are doing this for the safety of the healthcare workers and members of the public. Many of the sites utilizes tents and cars drive through for the testing but of course there had been a lot of rain during the storm. Today,

free COVID-19 testing is opening in the Sunnyside Community for the first time. The Houston Health Department and the Texas Division of Emergency Management are working together to open the free mobile test collection site and it opens today at noon at Worthing High School, 9215 Scott Street, 77051 and will operate until May 3<sup>rd</sup>. the site will open daily from 9:00 a.m. to 5:00 p.m. or reaching its daily capacity of 150 test. This site requires an appointment by visiting TXCOVIDTEST.ORG or they can call (512)883-2400. They recognized the importance of testing which the testing will give a better indication of the impact of COVID-19 and the impact that it's having on Houstonians and also will help stop the spread. Yesterday the Houston numbers increased to 3,419 positive cases and now up to 50 people who have died as the result of COVID-19.

Yesterday, the Mayor had a conversation with Montgomery County Judge in reference of opening up even more so then what the Governor had required, and he wanted the Judge to know the impact it has on all of us as a whole in this region. Please be mindful as much as possible and we need to stay in sync. In respect to water disconnections, they know that they have suspended water disconnection to the end of April, and he is going to extend it through the end of May. Doesn't mean your bill has been excused. The City of Houston operation will continue as they are today through the end of May. So, any City sponsored permitted produced event will be on hold though the end of May. They are looking to start off and kicking back up on June 1<sup>st</sup> and the Houston Public Library will continue to be closed to the end of May.
