A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, August 18, 2020 with Mayor Sylvester Turner presiding with Council Members Amy Peck, Jerry Davis, Abbie Kamin, Dave Martin, Carolyn Evans-Shabazz, Tiffany Thomas, Greg Travis, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department, Marta Crinejo, Agenda Director present.

At 1:41 p.m. Mayor Turner called the meeting to order and stated they would start with Council Member Kamin presentation.

MAYOR'S REPORT

Mayor Turner stated that this morning at 8:00 a.m., the online applications open for the City of Houston Small Business Economic Relief program and as they know, the program is funded with \$50 million dollars from the City's allocated Cares Act 2020 funds. It will provide immediate and short fund grant assistance to small businesses that have been affected by COVID-19 pandemic and the most that a business can receive is \$50,000.00. This money can be used for payroll, accounts payable rent, mortgage, personal protective equipment, employees and marketing strategies. The application deadline is 11:59 p.m. on Friday, September 4, 2020 and this must be completed online at www.cityofhouston-sberp.org this is not a first come, first serve basis. The Rent Assistance Program is taking applications from landlords and will be open for the rest of this week, to participate the landlords must agree not to evict any tenant through September and next Monday tenants can begin applying for assistance, they can be eligible for up to \$2,112 for delinquent rent. Baker-Ripley will have a dashboard up soon to help breakout the numbers for the City. Most landlords are opting into this program. People can log on to www.houstonrentassistance.org or they can call (832) 390-2018.

Mayor Turner stated that there is a lot going on in Houston, but he doesn't want people to forget about getting tested for COVID-19 and requesting the Council Members to encourage their Districts and also for the At-Large Council Members as well. Yesterday, Houston Health Department reported 382 new cases bringing Houston's total to 58,554, 6 newly reported deaths brings the City of Houston total to 655. He is encouraging everyone to attend the virtual townhall meeting for mental health in minority communities. It's sponsored by the Mayor's Health Equity Response Task Force Force's Faith Community Leaders Subcommittee, the live and interactive forum will be from 6:00 pm - 7:30 pm on Friday, August 21, 2020, they register online on Facebook. This Saturday the H.E.R. Task Force will be giving out mask and food and packages with COVID-19 materials in the Alief community. The distribution will take place starting at

9:00 a.m. to 11:00 a.m. at the Notre Dame Catholic Church and the address is 7720 Boone Road, Houston, Texas 77072.

In regard to the Census the deadline is approaching to complete the 2020 Census, there are 6 weeks left before the September 30th deadline and Houston response rate is 54.6% which is 10 points behind the National average. We need everyone to be counted in Houston.

Mayor Turner wants to acknowledge two individuals, Master Sergeant Joe Ramirez, Jr. who received a proclamation from them a couple of weeks ago had passed away and they want to pay tribute to him. They also want to honor Rabbi Samuel Karff who passed away over the weekend, he was one of the Three Amigos. His funeral is taking place virtually at 10:00 a.m. this morning.
