A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, September 1, 2020 with Mayor Sylvester Turner presiding with Council Members Amy Peck, Jerry Davis, Abbie Kamin, Dave Martin, Carolyn Evans-Shabazz, Tiffany Thomas, Greg Travis, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. At 2:00 p.m. Mayor Turner called the meeting to order and recognized Council Member Peck for the Invocation and she led the Pledge of Allegiance.

At 9:01 a.m. Mayor Turner called the meeting to order and requested the Interim City Secretary to call the Roll.

REPORT FROM CITY CONTROLLER AND THE CITY ADMINISTRATION REGARDING THE CURRENT FINANCIAL STATUS OF THE CITY including but not limited to, a revenue, expenditure and encumbrance report for the General Fund, all special revenue funds and all enterprise funds, and a report on the status of bond funds - Was presented, City Controller Chris Brown and Director of Finance Department Tantri Emo, reviewed the Monthly Operation and Financial Report; copies of which are on file in the City Secretary's Office for review.

Council Member Martin moved to accept the Monthly Financial Report and seconded by Council Member Castex-Tatum, all voting aye, nays none. **MOTION 2020-0443 ADOPTED** 

 PUBLIC HEARING on the adoption of Article XII Chapter 32, Code of Ordinances, City of Houston, regarding Standards of Care for the Houston Parks & Recreation Department Youth Recreation Programs – Was presented,

Assistant Director Debra Lathan from the Parks and Recreation Department and Tyrone Lin With the Legal Department presented a power point presentation for the Standards of Care to Members of Council.

Members of Council commented and questioned Ms. Lathan and Mr. Lin about the power point presentation.

Mayor Turner requested a Motion to close the Public Hearing; Council Member Castex-Tatum moved to close the Public Hearing regarding Standards of Care and Seconded by Council Member Robinson, all voting aye, nays none.

#### **MOTION 2020-0444 ADOPTED**

At 9:40 a.m. Mayor Turner stated that they will move to the Mayor's Report.

#### MAYOR'S REPORT

Mayor Turner stated that he just has a few comments, in regards to COVID-19, at one point in time the positively rate in the City of Houston was as high as 23% and then it went down to like 15.6% and then it was at 9.2% and as of this week, the positivity rate for the City of Houston is 7.8% which is good news but the goal is to lower the positivity rate to 5% and to keep it below 5%. There still is work to do to bring it down but it is a positive step in the right direction. In order for this to happen we must be vigilant in putting the mask on in public, to social distance together, get tested and there are plenty of testing sites in the City of Houston. If people don't like the nasal swab, they can go to the Minute Maid parking lot for the oral mouth test. There are no waits, they don't have to register, they can just go to one of the sites. The test will give them a sense of prevalence in the community and he is encouraging people to get tested. Mayor Turner stated that Labor Day is next Monday, and they may recall the celebration around Memorial Day and July 4th weekend helped the virus spread in our communities and please don't let your guard down during this Labor Day weekend.

Mayor Turner stated with Rental Assistance, today is the last day to apply for Rental Assistance in both the City and the County. In response to the overwhelming need to help those who cannot pay their rent as a direct result of COVID-19. Both the Landlord enrollment and the Tenant application were extended today and the program will help about 30,000 plus tenants and for tenants to be able to apply, their Landlords must enroll into the program. They

currently have more than 10,000 different Landlords that have enrolled in the program. Mayor Turner want people to take full advantage of the program and for more information they can go to <a href="https://www.bakerripleyrenthelp.org">www.bakerripleyrenthelp.org</a>

Mayor Turner continued & stated that Houston dodged a major storm in Hurricane Laura but it devastated communities to the East of Texas and Louisiana and they started a donation drive to help our neighbors, Houston paying it forward is accepting new supplies, that you can drop off at the George R. Brown Convention Center, Hall D between 9:00 a.m. to 4:00 p.m. or Gallery Furniture or any Kroger store and they are asking cleaning supplies, water bottles, nonperishable items and they can find more information about the supplies online. He just wanted to thank Houstonians and people from Harris County and people around this region who have taken it upon themselves and they are having their own supply drive and driving to Beaumont, Port Arthur, Orange County and Lake Charles in Louisiana area. In regards to the Coastal spin because if that storm would have come 40 to 50 miles further to the West and it hit us in the Galveston Bay, we could have a serious problem with the storm surge and we were very fortunate but we still need to prepare, Laura was a Category 4 storm when it landed. The U.S. Army Corps of Engineers are working on plans for the coastal spines, a system of levies and gates to protect the Coast and Rice and Texas A&M have also put forth certain proposals. He asked Mayor Pro Tem Martin to lead the City of Houston advocacy efforts for storm surge protection and he represents District E and Mayor Pro Tem Martin will work with the Government Relations Team and with the Chief Recovery Officer Steve Costello on advocacy as it relates to looking out for the City's interests and the Region's interest in protecting us from the next major storm and they need partners on this, they need the Federal Government as well as the State to step in meaningful ways. He can't close the report about the talking about the Census and we have 30 days and requesting all people in all of the Districts across the City to fill out the Census.

Members of Council commented and questioned Mayor Turner about the Mayor's Report.
