A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, September 29, 2020 with Mayor Sylvester Turner presiding with Council Members Amy Peck, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Greg Travis, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department, Marta Crinejo, Agenda Director present. Council Member Jerry Davis absent on Personal Business.

At 1:35 p.m. Mayor Turner called the meeting to order and the first order of business, is to present Proclamations by Council Members.

Council Members Kamin, Evans-Shabazz, Robinson and Alcorn presented a Proclamation to Alan Clark, Director H-GAC'S Transportation Policy Council and was read by Council Member Robinson for Alan Clark Day in Houston, Texas.

Council Member Gallegos presented a Proclamation to Barrio Dogs that is celebrating 10 years of service and to accept the Proclamation was Gloria Zenteno, Founder.

At 1:56 p.m. Mayor Turner recognized Council Member Evans-Shabazz and she invited Reverend Dr. Murphy D. Simon, Jr. (Pastor of Bethel Institutional Missionary Baptist Church) for the Invocation after which she led the Pledge of Allegiance.

Mayor Turner called the meeting to order and requested the Interim City Secretary to call the Roll.

MAYOR'S REPORT

Mayor Turner wanted to give a quick reminder that voter's registration will end on October 5th, which is this coming Monday. He encourages people to register if they haven't and if there is any question to whether or not you are registered to check your status go online. The Houston Health Department is launching a new effort to support mental health in the COVID-19 pandemic. "Let's beat COVID-19 Health Education Support Services", which includes mental health help line and other resources to help people to help adjust mentally and emotionally and the Help Line opens tomorrow, Thursday, October 1st and will open daily from 1:00 p.m. to 11:00 p.m. through December 24th. The Help Line number is (713)999-9442 to be contact to a trained Mental Health Professional. Yesterday, the Health Department reported 175 cases of COVID-19 and 6 deaths which brings the City of Houston total to 1,107 and he thinks that yesterday in a long time that no Hispanics are being reported who have died from COVID-19 and he wants everyone to continue to work in keeping these mask up, on and engage in the Social Distancing and the proper hygiene. The positivity rate in the City of Houston is 5.6%, it is steadily decreasing and let's hope that it continues to go down.

Mayor Turner wanted to make a note about the Houston Police Task Force, the Police Task Reform will be making it's presentation today at 3:00 p.m. and the report will go live online at 3:00 p.m. and that presentation will be in the Legacy Room. The Task Force is recommending following the implementation of Cite and release for Class A and Class B and they are upgrading Class C. Yesterday, Mayor Turner participated in the Barbara Bush Literacy Plaza, it was a virtual groundbreaking. It was hosted by the Houston Library Foundation, the City of Houston announced in 2016 was renovating in the middle of the Central Library and the Julia Ideson building. Mrs. Bush dedicated her life and public services on the focus of the cause for literacy. He looks forward in opening this space in her honor. Today, his Office of Cultural Affairs is releasing its first Equity Review of the Artist, that is represented by the City of Houston Art Collection and this report includes several immediate action steps after taking consultation with the Houston Arts Alliance.

Mayor Turner stated that Census Bureau announced it will cease all 2020 Census on October 5th and they have been going back and forth with this because it has been really confusing. He is requesting everyone to please response to the Census. The City of Houston response rate is 58.1% and there are 40% pf people out there who have not responded. It's in the best interest for the entire City to respond to the Census.
