A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, September 12, 2023, with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Dave Martin, Tiffany D. Thomas, Mary Nan Huffman, Karla Cisneros, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department, and Marta Crinejo, Agenda Director, present. Council Members Carolyn Evans-Shabazz and Robert Gallegos absent on personal business.

At 1:43 p.m., Mayor Turner called the meeting to order and recognized Council Member Plummer for the first proclamation.

### MAYOR'S REPORT

Saturday was a great day in District I at the Hidalgo Park ribbon cutting for the 50/50 Parks. It was the ninth park of the 22 parks that will be significantly upgraded before the year is out. 13 more neighborhood parks will be significantly upgraded before December 31<sup>st</sup>. Kudos to Council Member Gallegos and his entire operation on Hidalgo Park.

We're continuing to battle the water leaks. They often times talk about how many water leaks there are and he wants to give a perspective on how many water leaks that have been fixed. From the beginning of June through the end of last week, Public Works and contractors have completed and closed out 3,956 work orders. Of that number, 3,140 were completely repaired, 816 were investigated and determined to either not to be a leak or was a leak on private property. They continue to work with about 12 contractors and on average, they're completing about 400 water leaks in a week's time. Texas Monthly stated that Houston is not the only city in Texas that is dealing with water leaks. Mayor Turner does want to give credit to Houston Public Works and the contractors that are working feverishly to address these water main leaks. He also wanted to say there are some old pipes that are underneath that have been there 100 years. When they have extreme hot weather and drought, it affects not only the old pipes that are breaking but they have the new pipes that are breaking because the ground is shifting. He stated that they are trying to get them as quickly as they can. If anyone sees a water leak, please report it.

Mayor Turner wanted to introduce Christina Nowak as the new Deputy Inspector General, who will help oversee implementation of One Safe Houston and work with the Independent Police Oversight Board. She is replacing Crystal Okorafor. She is a native Houstonian, raised in Alief. She obtained her Bachelor of Arts from the University of Texas in Austin and her Doctor of Jurisprudence from South Texas College of Law. She started her career as an Assistant District Attorney in New York City, prosecuting narcotic cases and specializing in the prosecution of gangs and homicides. After a decade long career as a prosecutor, she joined the New York City Department of Education's Office of Special Investigations as Deputy Director. Tasked with overseeing investigations of complaints for one of the largest school districts in the country. From there, she joined the New York City Fire Department as Deputy Inspector of the Equal Employment Opportunity Office acting in an oversight capacity pursuant to a federal monitor for that division. Upon moving back to Houston in 2021, she joined the City of Houston as a Senior Investigative Attorney in the Office of Inspector General where she focused on investigating complaints with the Houston Fire Department. He had an opportunity to sit down and talk with Ms. Nowak where he was very impressed. She is someone that doesn't wait to be instructed on what to do. She is very outgoing, recognizes what the role is and is very selfassertive. He has no doubt there will be a seamless transition between Crystal's work and the work that Christina Nowak will be doing moving forward.

Members of Council commented and questioned Mayor Turner about the Mayor's Report.

Mayor Turner requested Director Haddock and her Chief Operations Officer, Randy Macchi, to come out and give them some context in terms of how many water leaks that our own team, separate and apart from the contractors, is doing and then the number of contractors that they have out there that are working to fix these water leaks.

Members of Council commented and questioned Director Haddock and Randy Macchi on the water leaks.

Mayor Turner wanted Council to be mindful of the Moroccan earthquake and the donation drive. The City of Houston is partnering with the Moroccan Society of Houston to host a donation drive this Saturday and Sunday to help survivors of a massive earthquake. More than 2,000 people were killed and hundreds more were injured. They can drop off needed items on Saturday and Sunday from 10:00 a.m. to 3:00 p.m. at the Arab American Cultural and Community Center, 10555 Stancliff St. They are requesting tents, socks, shoes, flashlights, blankets and first-aid kits. If they need any information, reach out to Janice Weaver's, Community Service Director, who is working directly with them.

The Mayor's Adult Literacy Breakfast is tomorrow morning at 8:00 a.m. The theme is "Keeping the Torch Lit." The breakfast will honor Neil and Maria Bush for their lifelong commitment to literacy. The literacy community helps their little readers initiative and professional janitorial services for their innovative programs to help their employees learn English. The Houston Astros Manager, Dusty Baker, is the honorary chair for the adult literacy.

The State of the City will be on Wednesday, September 27th at the Hilton Americas and Houston First is a key producer of this event. Party on the Plaza will be on September 15th, celebrating National Heritage Month. The Party on the Plaza returns Saturday and will offer free live entertainment featuring Latin and Mexican regional music on Avenidas de Las Americas Street in front of the George R. Brown Convention Center. The street will be closed to traffic as Houston First Corporation partners with Discovery Green. This takes place on Saturday, September 16<sup>th</sup> from

6:00 p.m. to 9:00 p.m. presented by Houston First Corporation. Party on the Plaza is open and free to the public as part of the organization's recognition of the contribution of Hispanic Americans.
