

The Department also recommends that Motion 2008-656 be amended to remove residential permit parking designation from the west side of 1300 Crosby for reasons outlined below:

- The block has no residential front footage and was designated RPP in error as part of a global RPP petition for Crosby Square.
- The residents of Crosby Square have sufficient parking available on streets in the zone.
- The nature of the 1300 block of Crosby has changed due to the dedication of Bethel Park as a public City park on December 14, 2013.
- The east side of the 1300 block of Crosby is adjacent to Bethel Park and is currently a no parking zone due to the limited width of the street.
- To allow parking for visitors to Bethel Park, the west side of 1300 Crosby will be converted to a No Parking zone and the east side of 1300 Crosby will be designated as three hour time limit parking to prevent all day commuter parking while providing parking for park visitors.
- Residents of the Crosby Square Residential Permit Parking area were notifed by USPS mail of the configuration change to 1300 Crosby the week of December 16, 2013. No objections were raised.



Findings:

Testimony from the Parking Management Division, approval by the Public Works and Engineering – Traffic Operations Division, and comments received at the public hearing leads to the following findings:

- A parking problem exists between the hours of 11 pm and 5 am, Wednesday through Sunday.
- More than 60 percent of the available parking spaces were occupied. More than 25 percent of cars parked curbside was generated by commuters from local night club.
- Excessive commuter parking on the block creates traffic congestion and reduces safety and residential quality.
- Neighborhood support is demonstrated by 82 percent of residents (out of 17 households affected) signing the petition in favor of the permit area.
- Designating a parking permit area is the most cost-effective way to resolve the parking problem.



Proposed Residential Parking Permit Area




- 4. The applicants be required to: (a) remove and return the digital parking pay station on Chenevert Street between Capitol Street and Texas Avenue to the Administration and Regulatory Affairs Department, 2020 McKinney Street, Houston Texas; and (b) pay for the loss of projected parking revenue;
- 5. 

SPECIFIC EXPLANATION:

The City Attorney requests that Council adopt an ordinance relating to the retail gas utility rates of CenterPoint Energy Resources Corp. D/B/A CenterPoint Energy Entex, and CenterPoint Energy Texas Gas (CenterPoint or Company), terminating the formal gas utility rate inquiry. CenterPoint provides natural gas distribution services in the Houston metropolitan area. The City of Houston exercises original jurisdiction over the rates, operations and services of CenterPoint under the provisions of the Gas Utility Regulatory Act (GURA) for customers inside city limits. As municipal regulator, the City is obligated to balance the interests of the utility and the ratepayers — ensuring customers are charged just and reasonable rates and utilities receive a reasonable opportunity to earn a reasonable return on their invested capital necessary to maintain the financial integrity of the utility and health of their infrastructure.

On March 30, 2012, CenterPoint filed an annual earnings monitoring report (EMR) with the City. A review of the EMR indicated that the Company might be over-earning to the extent that the filing of a rate case would be appropriate. Therefore, on July 25, 2012 City Council approved Ordinance No. 2012-662 initiating a formal inquiry into CenterPoint's gas utility rates. City experts requested and reviewed information provided by the Company, and any additional information available and necessary to make a determination regarding the reasonableness of the Company's existing rates. The Company was also directed by Council to submit a full rate filing package (Ordinance No. 2012-49).

At the time Council approved the subject ordinance, it encouraged the Legal Department to seek a peaceful resolution with CenterPoint. Consistent with that, and believing that resolution of the rate inquiry by settlement agreement to be in the best interest of the ratepayers, the City entered into negotiations with CenterPoint. During the negotiations, both the City and the Company agreed to suspend submission of the rate filing package. Over a period spanning several weeks, ARA and the Legal Department participated in several discussions with the Company before reaching an agreement. Under the terms of the agreement, the existing gas utility rates will remain in effect within the city of Houston. The Company also agrees not to file a base rate case for its Houston Division, including the city of Houston, before November 2016 unless otherwise required to do so. At that time, the City will have the opportunity to thoroughly review the Company's proposed rates.

The Department of Public Works & Engineering and the Mayor's Office of Intergovernmental Relations recommend City Council approve an agreement with Clay Pope and Cliff Johnson to advocate for the City before both the State Legislature and several state and federal agencies with regard to water and wastewater related issues.					
The Texas Commission on Environmental Quality (TCEQ), the Texas Water Development Board (TWDB) and the Texas Parks and Wildlife Department (TPWD), along with the Environmental Protection Agency (EPA), regularly propose new regulations or revise existing regulations related to public water and wastewater utilities that can significantly affect the City's permitting and operational responsibilities.					
Mr. Pope and Mr. Johnson are currently representing the City under a professional services agreement. A Request for Proposals (RFP) for professional services was posted utilizing City procurement processes and guided by principles of state procurement for professional services. The RFP solicited proposals with intent to continue the services of Mr. Pope and Mr. Johnson unless a more highly qualified consultant and better offer was submitted. The City received one proposal and that was from the team of Pope and Johnson.

This team recently helped secure the initial State Participation Program funding for the Luce Bayou Interbasin Transfer project. They will continue to work with the City and the TWDB to secure additional sources of financing for the City's various water projects.

Recent accomplishments include assisting with the development of proposed legislation to address upstream erosion control from sand pit operations in the San Jacinto River Basin upstream of Lake Houston, and assisting in the negotiations for reuse permits of City treated wastewater effluent that provides for additional future water resource options for the City. The reuse permits were granted after their negotiations with local and statewide environmental interests to address concerns regarding Galveston Bay.

During the term of this contract, in addition to providing support during legislative sessions, Mr. Pope and Mr. Johnson will provide active support with legislative interim charges during non-session years. Additionally, they will communicate with elected and appointed officials at the state level including board and commission members of the TWDB, TCEQ and TPWD in support of the following projects: Northeast Water Purification Plant Expansion, Allens Creek Reservoir development, Brazos River Authority System Operations Permit, Trinity River Water Rights acquisition, Sabine River Water Rights research and long range planning for water reuse.

The proposed contract provides for a two-year term with a one-year renewal option with a maximum contract amount of \$522,000.
