### **Background:**

The Housing and Community Development (HCD) Department recommends Council approval of an Ordinance authorizing a new Subrecipient Agreement between the City of Houston (City) and the Coalition for the Homeless of Houston/Harris County (Coalition), providing up to \$130,000.00 in Community Development Block Grant (CDBG) funds for strategic homeless planning services and activities.

As the Lead Agency for The Way Home system, the Coalition is a sole-source provider that guides the development, advocacy, and coordination of community strategies to prevent and end homelessness. Their collaboration with homeless services providers, affordable housing providers, community stakeholders, those with lived experience, and other non-profits allows for greater alignment in every aspect of planning and decision-making activities necessary for providing critical homeless services and responding to emerging issues in the homeless response system.

The Coalition will address problems of homelessness and provide systemic solutions through landlord engagement, stakeholder recruitment, encampment response strategies, needs assessments, gap analyses, and system operations support. They will serve as liaison at the city, county, state, and federal levels, support homeless services providers, establish standards, coordinate affordable housing options and supportive services for the homeless, and advocate on behalf of the very vulnerable homeless and at-risk populations.

### Background:

The Housing and Community Development (HCD) Department recommends Council approval of an Ordinance authorizing a Subrecipient Agreement between the City of Houston (City) and Harris County Domestic Violence Coordinating Council (HCDVCC), providing up to \$324,520.00 in Community Development Block Grant-CARES Act (CDBG-CV) funds to support Mobile Trauma Support Partners, benefiting a minimum of 100 households (individuals and families) experiencing homelessness or are at risk of homelessness due to impacts of COVID-19 and may be survivors of domestic violence, sexual assault, and/or human trafficking.

The Way Home developed the Community COVID Housing Program (CCHP) – Phase 2 to continue supporting Houston's most vulnerable residents impacted by COVID-19 - people experiencing homelessness. As part of the CCHP Phase 2, the Mobile Trauma Support Partners will provide mobile and home-based supportive services to households referred by homeless service providers. Permanent supportive housing (PSH) sites will be identified for strategic interventions that will include group work, education and awareness activities, and individual advocacy and services. Additional services include assessment and monitoring of the Domestic Violence Coordinated Access waitlist to refer families to the homeless service providers for housing opportunities. The Mobile Trauma Support Team will work within encampments, the Housing Navigation Center, and with the outreach teams when there are identified needs.

Through The Way Home, a collaborative partnership between the City of Houston, Harris County, and the Coalition for the Homeless of Houston and Harris County (Coalition), the CCHP was developed specifically to respond to COVID-19's impacts on the homeless. For CCHP Phase 2, a joint Request for Expression of Interest from qualified agencies was released in March 2022 by the Coalition. HCDVCC was one of the qualified agencies selected to receive funding for essential supportive services to households experiencing homelessness or are at risk of homelessness and may be survivors of domestic violence, sexual assault, and/or human trafficking.

This Agreement provides funding from the Date of Countersignature – December 31, 2023, with an optional one-vear extension. This is HCDVCC's first Public Services agreement with the City of Houston. As this would be the agency's first Agreement, there has not been an annual compliance and monitoring review and no findings.

#### **Background:**

The Housing and Community Development (HCD) Department recommends Council approval of an Ordinance authorizing a Fourth Amendment to extend an Agreement between the City of Houston (City) and Healthcare for the Homeless-Houston (HHH), providing up to an additional \$150,000.00 in Community Development Block Grant (CDBG) funds to operate the Project Access homeless transportation program, benefiting a minimum of 1,800 additional riders who are homeless.

Project Access offers transportation services to homeless persons Monday through Friday, from 7 a.m. to 5 p.m., 52 weeks a year using a 40-passenger, wheelchair-accessible bus traveling a scheduled route. The service supports 23 agencies that provide essential services such as health care, meals, shelter, and social services. Funding also supports a community health worker that serves as a resource for riders, collects data, acts as a liaison with other homeless services providers, and serves as the face of the program to promote ridership and improve outreach.

HCD conducted a Notice of Funding Availability (NOFA) for CDBG contracts for the fiscal year 2019 with the option to renew in up to one-year increments. The initial contract began on February 1, 2019, and was extended through three subsequent amendments and administrative extensions to December 31, 2022. This Fourth Amendment provides funding through December 31, 2023. HHH has received CDBG funding through the City for various contracts since 2003.

As of November 1, 2022, HHH has expended approximately 94% of funding and served approximately 107.6% of its annual client goal. There were no findings in their annual compliance monitoring.

The Housing and Community Development (HCD) Department recommends Council approval of an Ordinance authorizing a Third Amendment to the Agreement between the City of Houston (City) and The Montrose Center, providing an additional \$1,200,000.00 in Housing Opportunities for Persons with AIDS (HOPWA) funds, for (1) Tenant-Based Rental Assistance (TBRA); (2) Short-Term Rent, Mortgage, and Utilities assistance (STRMU); and (3) supportive services; for 275 low-income households living with/or affected by HIV/AIDS.

The Montrose Center provides rental subsidies and supportive services to participants at risk of becoming homeless. Supportive services include Permanent Housing Placement Services (PHPS), case management, professional counseling, and other services. Housing assistance will be provided as follows: (1) TBRA for 60 households, (2) STRMU for 190 households, and (3) PHP for 25 households of persons living with/or affected by HIV/AIDS. The City provides approximately 41% of the costs for this HOPWA project.

### Background:

The Housing and Community Development (HCD) Department recommends Council approval of an Ordinance authorizing a First Amendment to the Agreement between the City of Houston (City) and the Coalition for the Homeless of Houston/Harris County (Coalition), providing up to \$270,991.00 of Homeless Housing and Services Program (HHSP) funds for the operation of the Housing Navigation Center located at 2903 Jensen Drive, Houston, Texas 77026.

Due to pervasive, underlying health conditions and a lack of access to adequate facilities, the homeless are especially susceptible to COVID-19 and are at higher risk of experiencing severe symptoms. Per guidance from the Center of Disease Control, it is imperative during the current pandemic to move individuals experiencing homelessness off the streets. In response, the City partnered with the Coalition to launch and operate a Housing Navigation Center, which will temporarily house individuals living on the streets and assist to moving them to long-term housing.

The Coalition, through a selected subrecipient, manages the operations, administration and reporting for the Housing Navigation Center. The facility provides bridge beds for 350 clients annually to stay during the housing process. "Bridging" is the time from housing assessment to placement into permanent housing. The additional HHSP funding will support eligible essential services, such as but not limited to, food and security services. Regulations pertaining to the use of previously approved Community Development Block Grant – CARES Act (CDBG-CV) funds for operations do not allow for the purchase of food. HHSP funding will assist in providing three meals a day to clients residing at the facility. Potential clients must be referred and transported by homeless agencies and/or first responders to enter and utilize the center's services.

#### Background:

The Housing and Community Development Department (HCD) recommends Council approval of an Ordinance authorizing the City of Houston (City) to accept two grant awards from the Texas Department of Housing and Community Affairs (TDHCA) for a total of \$1,679,747.00 in Homeless Housing Services Program (HHSP) funds. This Ordinance further authorizes the Director of Housing and Community Development to represent the City on behalf of the HHSP award and have signature authority to execute the contract and amendments between the City and TDHCA for HHSP funds.

Per the TDHCA, the proposed 2023 HHSP award amount for general allocation is \$1,277,839.00, with an additional set-aside funding amount of \$401,908.00 to address youth homelessness. Each award will be presented as a separate contract.

The general allocation must be used by the City on activities eliminating and/or preventing homelessness. Specifically, allowable activities include construction, development, or procurement of housing for homeless persons; rehabilitation of structures targeted to serving homeless persons or persons at-risk of homelessness; provision of direct services and case management to homeless persons or persons at-risk of homelessness; or other homelessness-related activities as approved by the TDHCA.

HHSP was established by the 81st Texas Legislature through an appropriations rider and codified during the 82nd Texas legislative session. Through HHSP, the state provides funding to the nine largest cities in Texas in support of services to homeless individuals and families. Cities currently served through HHSP include Arlington, Austin, Corpus Christi, Dallas, El Paso, Fort Worth, Houston, Plano and San Antonio.

This item is a procedural, administrative matter required by the State of Texas for the City to receive the funds awarded. An Ordinance allocating the accepted HHSP funds for use by local nonprofit organizations will be presented to Council for consideration within the coming months.

### **Background:**

The Housing and Community Development (HCD) Department presents version 1.2 of the Affordable Home Development (AHD) Program Guidelines. Version 1.2 of the AHD Program Guidelines introduces and explains the proposal submission process outside the traditional procurement time period. The purpose of AHD Program is to increase the City's stock of affordable single-family homes and create homeownership opportunities for households earning from 60% to 120% of the Area Median Income (AMI).

For-profit and nonprofit developers are eligible to apply for gap financing for their affordable single family home projects. Developers must complete and submit the pre-application and supplemental documentation to be considered for funding. Each project will be evaluated based on its alignment with the City's affordable housing objectives and priorities, the readiness of the project, the project completion timeline, and overall community benefit.

The AHD Program is funded through the Uptown TIRZ Series 2021 Affordable Homes Fund allocation to large tract development. The AHD Program Guidelines provide specific processes and procedures for administering the AHD Program, including application, resiliency construction standards and project eligibility requirements, underwriting criteria, funding requirements, standards, closeout and monitoring, and complaint and appeals processes. The City will administer the AHD Program in accordance with the program guidelines.

The City's Deed of Trust is to be fully released upon closing the sales of 44 affordable homes and closing the respective City loans to homebuyers. Partial releases of the City's Deed of Trust securing the construction loan will be given for lots as the lots are sold.

This project is aligned with the City's efforts to invest in creating affordable housing opportunities for homebuyers in desirable neighborhoods throughout the city.
