DNA CLEARANCE PROJECT

- On February 27, 2013, City Council approved a plan to outsource all legacy backlog Sexual Assault Kits and active cases awaiting DNA testing to Bode and Sorensen Laboratories.
- Outsource testing will be accomplished via 3 main funding sources totaling \$4.4 million
 - 2011 & 2012 NIJ DNA backlog grants totaling \$2.2 million
 - \$2.2 million of General Fund monies allocated for this purpose when the Houston Forensic Science LGC, Inc. was created.

All completed forensic reports are forwarded for investigative follow-up.

Investigative Process

- An investigative team within the Special Crimes and Juvenile Divisions has been formed to conduct follow-up investigations pertaining to the DNA Clearance Project and new sexual assault cases.
- Sexual Assault Investigation team consists of:
 - 3 Lieutenants
 - 8 Sergeants
 - 33 Investigators
- All of these resources have been dedicated to this project until the completion of the DNA Clearance cases.

Investigative Process

- Initial Screening of CODIS Hits
 - Is someone incarcerated?
 - Does the CODIS hit match the suspect?
 - ✓ Yes?
 - Arrest confirmation –assigned for follow up and / or case closure.
 - ≠ No?
 - If there is indication of a false arrest- assign immediately for follow-up investigation.
 - Determine if suspect is charged (incarcerated) on other evidence- assign for follow up investigation.

Investigative Process

After Initial Investigative Screening, cases are prioritized for follow-up investigation based on the following criteria:

Adult Cases:

- Statute of Limitations on CODIS name hits
- Suspect incarcerated and possibly released soon

Juvenile Cases

- Stranger cases with no arrest
- Statute of Limitations (if the case was from 2007 or earlier)
- Juvenile Suspect

All cases are assessed individually on various factors.
