





HOW ARE DITCHES MAINTAINED?

BASIC MAINTENANCE

Prevents unexpected failure **Abutting property owners** maintain roadside ditches cleared of obstructions:

- $_{\odot}$ Overgrown vegetation: mowing
- Trash: litter / light debris pickup
- $\circ\,$ Avoid unpermitted installations
 - (e.g., walls, bridges, inadequate landscape)

DITCH RE-ESTABLISHMENT

Reinstates ditch functionality

Houston Public Works:

- \circ Regrading
- Clearing and grubbing
- $\,\circ\,$ Flow Line Establishment
- $\circ\,$ Culvert flushing and repair
- Removal heavy debris/obstructions




ROADSIDE DITCH MAINTENANCE HISTORY

ROADSIDE DITCH REESTABLISHMENT PROGRAM

Proactive Planned- 5-Year Inspection and Re-establishment Cycle (500 miles / year capacity) Priority to Northeast and Complete Communities during Transition Period

Additional One-Time Resources FY24 Approved for Equipment and Contract Procurement
 Fixed Annual In-House Staffing and Contract Resources Required after FY25




FY24 Updates: I. Inspections & Mapping
