## Texas Department of Information Resources (DIR) General Services Administration (GSA) National Association of State Procurement Officials (NASPO) Value Point National Intergovernmental Purchasing Alliance (NIPA)

Purpose:

To approve annual spending authority for routine technology related purchases up to \$300,000 per purchase order.

Spend Authority:

\$20,240,000.00

What is the benefit:

Cooperative purchasing leverages volume discounts obtained by state and federal purchasing organizations, and streamlines procurement time.

Department Utilization:

All City Departments

Term:

1 year

M/WBE Goal:

All purchases will comply with current City purchasing guidelines.

### REVIEW OF CONTROLS PRESENTED TO CITY COUNCIL IN 2018 PROPOSAL

- Spending Authority will be requested annually instead of multi-year
- A New Executive Order specifically for cooperative purchasing
  - Monthly reports will be posted via City of Houston intranet
  - Staff augmentation via cooperative purchasing will require additional documentation and CPO approval
- Expanding purchasing vehicle to leverage multiple federal and state cooperative contracts instead of just TX DIR
- All cooperative purchases route via SPD
- All material groups pertaining to technology require HITS approval in SAP
- All purchases over \$100,000 are to obtain MWBE participation or waiver
- Cooperative Purchasing Justification form required for each purchase

#### OUTCOME OF 2018 PROPOSAL

- Executive Order 1-59: Technology Related Purchases from Cooperatives
  - All technology purchases through a Cooperative must be processed by SPD.
  - All purchases from any Cooperative shall require the then current "Request to Purchase from Cooperative/Interlocal" justification form.
  - Any department in need of Staff Augmentation should first seek to utilize existing department or citywide contracts.
  - HITS shall prepare monthly reports on citywide technology related Cooperative purchases
    between \$50,000 and \$300,000 and post them on the City of Houston intranet no later than the
    last day of the month following the reporting period.

#### OUTCOME OF 2018 PROPOSAL (CONTINUED)

- All material groups pertaining to technology related items require HITS's approval in SAP.
- All purchases over \$100,000 are to obtain M/WBE participation or a goal modification.
