





## EXPLANATION OF CORRECTION

We are amending Schedule A to report the contributions of the contributors reflected on the attached schedule, all of which were accepted on December 31, 2003. All of these contributions were originally mistakenly reported on the July 15, 2004 report (covering the period January 1, 2004 through June 30, 2004) rather than the January 15, 2004 report (covering the period from December 30, 2003 through December 31, 2003), and the date of the contribution originally reflected on the July 15, 2004 report was the date of the contributor's check rather than the date the contribution was accepted.
