



The person who was hired to prepare the original report was indicted by a Grand Jury on charges of First Degree Felony Theft and is currently being held in the Harris County Jail awaiting trial. The ensuing examination by investigators of the District Attorney's Office, the bank's fraud examiners, and outside accountants hired by the Committee's political consultants have discovered errors which this report corrects. In this instance, no report was filed for the January 15, 2005 reporting period.

We request that the Commission consider waiving any fines that may be incurred by the filing of this correction.
