

ATTACHMENT "A"

The Quality of Life Political Action Committee (the "QOLPAC") is organized to distribute information on the 2001 City of Houston Mayoral and City Council candidates position on certain quality of life issues for the City of Houston, including improvement of parks and recreational areas, restrictions and reduction of billboards, reforestation, landscaping and beautification of the City of Houston and the elimination of litter and graffiti. A list of questions on these issues has been prepared and has been submitted to all of the identified Mayoral and City Council candidates. QOLPAC intends to distribute a pamphlet indicating the scores of the various candidates based on their answers. The QOLPAC does not support or oppose any particular candidate. QOLPAC does support three ballot measures on the November 6, 2001 ballot: the City Parks Bond Referendum (City Proposition C), the Harris County Parks Bond Referendum (County Proposition 2), and the state constitutional amendment allowing bond funding for construction and repair of projects, including projects for the Texas Parks and Wildlife Department (State Constitutional Proposition 8).
