

On the Cover Sheet Page 1 of the July 15, 2001 Report an inaccurate starting date for my campaign and the period this report covers was listed. The correct start date is 4-11-01 and this report covers 4-11-01 through 6-30-01.

Schedule A of the previously filed report lists Mr. and Mrs. Dan Sterling as the contributor on 5-21-2001 for \$6,000.00. This corrected report lists the contribution as \$5,000 from Dan Sterling and \$1,000 from Mrs. Dan Sterling.

The previous report listed a \$1,000 contribution on 6-8-2001 from Tilman Fertitta, Landry's Restaurant PAC. The correct contributor is listed in this amended report as Landry's Restaurant PAC.

On Schedule F of original filed report, an address for Whiterock Acquisition Company was inadvertently omitted. This corrected report lists its address as 3003 W. Alabama, Houston, TX 77098.

Also on Schedule F of the original filed report were two entries reimbursing me with the purpose as Auto Expense. In this corrected report, I have further defined that purpose as Mileage reimbursement for political/campaign activities.

Also on Schedule F of the original filed report were two entries reimbursing me for political expenses. Schedule G was inadvertently omitted which itemized those campaign expenses that I paid for personally and got reimbursed for. Attached is Schedule G itemizing those expenditures.

Attached is a revised Cover Sheet pg 2 with an updated amount for Total Expenditures. This amount reflects the total expenditures in Schedule F of the original filed report and includes the entries on Schedule G that are listed in this revised report.

All of these mistakes were clerical errors.




