^{**} A second or subsequent conviction of an offense under the Texas Motor Vehicle Safety Responsibility Act for no liability insurance will result in the suspension of your Driver's License and denial of automobile registration unless you file and maintain proof of financial responsibility with the Texas Department of Public Safety (DPS) for two years from the date of conviction. DPS may waive the requirement to file proof of financial responsibility if you submit satisfactory evidence with DPS reflecting that at the time the citation was issued, the vehicle was covered by a valid liability insurance policy, or that you were otherwise exempt from the requirement to provide evidence of financial responsibility.

POINTS ASSESSED:

A conviction of an offense under a traffic law of this State or a political subdivision of this State may result in the assessment of a surcharge on your driver's license under the Driver Responsibility Program.

VIOLATION	POINTS ASSESSED (per event)
Driver's License Restriction Violations	2 points
Moving Violation (Non-Accident): * State Law Violation * Ordinance Violation	2 points 0 points
Moving Violation (Accident)	3 points
Open Container (Driver)	2 points
Read/Write/Send Text While Driving	0 points
Safety Belt Violation (Non CDL)	0 points
Speeding- 10% or More Over the Speed Limit	2 points
Speeding in a School Zone	2 points

DPS SURCHARGES:

VIOLATION	SURCHARGES ASSESSED
Failure to Establish Financial Responsibility	\$250/year x 3 years
No Valid Driver's License	\$100/year x 3 years
Too Many Points (6 points or more in 36-month period)	\$100 + \$25 (for each point above 6)

NOTE: Failure to pay surcharge(s) or failure to timely enter into an installment payment agreement will result in SUSPENSION of your Driver's License until you pay the surcharge(s) and any related costs.
