

To assist in your claim that you did not receive the citation in question, please provide the Court and the Prosecutor with as much information and documentation as possible.

<u>Suggested documentation for **Defendant's True Identity Motion**:</u>

- 1. Valid driver's license or Identification card.
- 2. Address information on the date the citation was issued.
- 3. Current address, home phone number, and work phone number.
- 4. Make, model, license plate number and proof of insurance of the vehicle operated on the offense date and current date (today).
- 5. Identity of person you know or have reason to believe has received and/or signed this citation using your name.
 - a. Name
 - b. Date of birth
 - c. Driver's license number
 - d. Home address and phone number
 - e. Work address and phone number
 - f. Make, model, and license plate number
- 6. Proof of your location on the date and time the citation(s) was issued. (Example: copy of work schedule, time slip, etc.)
- 7. Any other information or documentation you deem relevant to establish that you did not receive the citation in question.

Note: A person commits a third-degree felony if he/she makes a false statement during or in connection with an official proceeding.

A person commits an offense if he/she makes, presents, or uses a record or document with knowledge that it is false.
