## **2020 Annual Racial Profiling Report**



#### **RACIAL PROFILING**

The Houston Police Department (HPD) prohibits the practice of racial profiling and has established policies, provided training to its officers, and instituted a process to monitor traffic stops.

#### STATISTICS SUMMARY

HPD conducted 217,288 traffic stops in 2020, 32.5% fewer stops than the previous year. Traffic stops were most often a result of moving traffic violations (161,387) and searches (18,229) were conducted in 8.4% of all stops. Contraband (536) was found 33.7% of the time. In all, HPD effected 11,197 arrests, issued 120,389 tickets, and 89,713 warnings as a result of traffic stops in 2020. Eight (8) racial profiling complaints were filed against HPD during the reporting period. Of the complaints, five (5) were unfounded, two (2) were exonerated and one (1) is still pending investigation.

## FILING COMPLAINTS

Discrimination in any form, including racial profiling, is strictly prohibited and the department will take immediate and appropriate action to investigate allegations of discrimination. Any person who believes he or she has been stopped, searched, or inappropriately ticketed or arrested based on racial, ethnic or national origin profiling should file a complaint.
